Robbery suspect nabbed after trying to evade

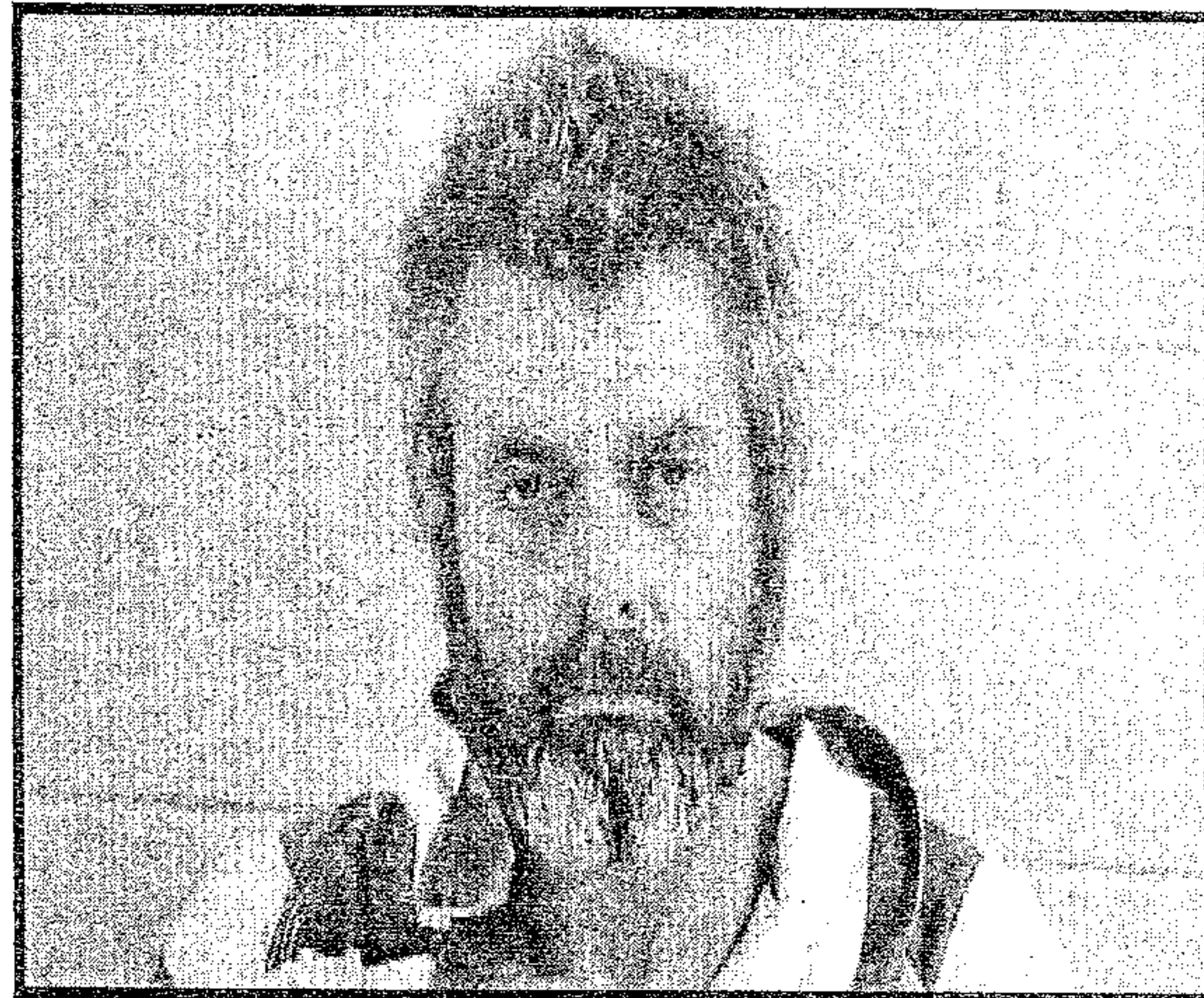
