Amanda Miller, 30, Sewell Road Philadelphia, was charged with Domestic Assault. On this date Deputy Chris Bowen LCSO, was dispatched to Davis ferry road to the report of a domestic disturbance. Upon arrival Deputy came in contact with the victim. She stated that she and her daughter identified as a Mrs. Amanda Miller had been in an argument and that her daughter had hit and busted her lip. Upon first coming in contact with the victim she had blood in the right corner of her mouth and after cleaning it off a small cut to the corner of her lower lip. The victim stated that all parties had been at a function at her child's school. Upon returning to her residence with the children. That child spit on the grandmother and

the grandmother popped the child on the mouth. She then became unruly and told the victim no. At which time the victim called their mother and told her to come and pick up the child that she could not handle her. When Amanda arrived there was an argument ensued over the disciplining of the children. The children were then taken to the car. The assailant then exited the residence and started to the car. dence of James Johnson.

During the execution of the search warrant James Johnson was encountered in the backyard of his residence by agents and was armed with a handgun, which was holstered on his side as well as another small gun in the pocket of a vest he was wearing. Mr. Johnson has a handgun carry permit with the state of Tennessee and is permitted to carry a weapon.

A search of Mr. Johnson's residence revealed a cache of weapons to include handguns, shotguns and assault rifles. Also found was approximately 3 ounces of a substance believed to be marijuana and numerous schedule II pills to include oxycodone and morphine.

Several of the weapons found are believed to be illegal class III weapons, specifically weapons that can fire more than one cartridge per trigger pull commonly referred to as machine guns or automatic weapons. These weapons must be registered with the Federal Government and approved before owning or possessing. Also located was a registered suppressor or silencer, which is legal as long as the person possessing it is the person it is registered to. In this case it was not registered to Mr. Johnson, it was found to be stolen from Townsend, TN

several years ago.

Mr. Johnson was arrested and charged with Sale and Delivery of Schedule II Drugs and Possession of Schedule II Drugs for Resale. Both of these charges were enhanced because the suspect was armed while committing these offenses. Mr. Johnson was also charged with Possession of Schedule VI for resale (Marijuana). Mr. Johnson resides, and these crimes are alleged to have occurred, within 1000 feet of a daycare center, which is a protected zone in the State of Tennessee. This also enhances the charges Mr. Johnson is facing.

Federal Authorities were notified and are assisting in the investigation for possible federal violations committed by Mr. Johnson due to the weapons found in his home. The 9th District Attorney General's Office is prosecuting this case and also looking into charges for other defendants as well as additional charges for Mr. Johnson.

The 9th Drug Task Force is working with other district law enforcement agencies in a

combined effort to combat the sustained and increasing battle with the abuse and sale of prescription drugs that his district faces. Many teens and young adults begin taking prescription medication that is not prescribed to them because they think it is safe due to the fact it was prescribed by a doctor. These drugs are extremely dangerous and can cause serious medical problems or even death. Cases involving prescription drugs that agencies within the 9th District investigate far surpass cases involving any other drug type, and the agents and officers in this district work tirelessly to try to combat this problem. John Doe, 43, Godby Road College Park Ga, was charged with DUI and Criminal Im-

personation. Lt. A.J. Yokley LCSO, was dispatched to a possible drunk driver on Sugarlimb Rd near I75. Upon making contact Deputy observed the vehicle driving westbound in the eastbound lane on Sugarlimb. Lt. Yokley initiated the traffic stop and vehicle

pulled over to the side of the on ramp of the interstate. Upon making contact with the driver LT. asked for his driver's license in which he could not produce one. The driver gave the name of Samba Timera and a DOB and a social security number. Lt. asked the driver to exit the vehicle and asked for consent to search the vehicle.

Upon searching the vehicle Lt. found a large quantity of cigarettes (684 packs) in the vehicle. We ran the name that was given by the driver through the law enforcement EPIC center. The EPIC center advised that the social security number was incorrect on the driver's license. At this time

we requested Loudon County Dispatch to send a photo from the driver's license to verify the driver's identity. The picture did not make the driver. In the vehicle there were also a few other names that matched. The passenger in the vehicle stated that he knew the driver only as Diallo. There were several attempts to identify the driver but we could not get a positive identification. The driver had given several dates of birth and names but could not be matched. The driver was placed under arrest and transported to the Loudon County Jail where he was charged with criminal impersonation and driving without a license. Lt. AJ Yokley LCSO, made the arrest.

FBI SAC Kenneth L. Moore to retire

After 27 years of service to the FBI, Special Agent in Charge of the Knoxville Division, Kenneth L. Moore, will retire on May 31, 2014. A native of Macon, Georgia, Moore earned his Bachelor

of Arts degree in criminal justice from Morris Brown College in Atlanta. Moore's FBI career began in 1987. After graduating from the FBI Academy, in Quantico, Virginia, Moore's first assignment was the Little Rock Division, where he gained broad based investigative experience working criminal and national security investigations.

In 1992, Moore was transferred to the Detroit Division to work counterintelligence matters. In 1994, he became the civil rights coordinator in Detroit, which led to his promotion in 1997 to a Supervisory Special Agent in the Hate Crimes Unit at FBI Headquarters. This assignment in the Hoover building included participation in several multi-agency task forces.

In 2000, Moore got his first taste of Tennessee as the Supervisory Senior Resident Agent in the Jackson, Tennessee FBI office, which is a satellite office out of

the Memphis Division. Moore supervised a squad investigating all federal violations within 19 counties in Western Tennessee.

In 2005, the Charlotte Division called his name, where he became an Assistant Special Agent in Charge, responsible for managing the counterintelligence and counterterrorism programs in North Carolina. It was during this time that he was called to serve as the on-scene commander for FBI operations in Afghanistan.

In 2009, Moore was promoted to an Inspector in the Office of Inspections, Inspection Division of the FBI, in Washington D.C. He was later promoted to Chief Inspector for the FBI.

Knoxville welcomed Moore in 2012, when he arrived to serve as the Special Agent in Charge of the Knoxville Division of the FBI.

Brighton Mayor Makes City Employees Do Private Work

The mayor of the tiny Tipton County town of Brighton directed two public works employees to help build a house for his son, an investigation by the Comptroller's office has revealed.

Brighton Mayor Jeff Scott sent the employees to property owned by his son, Hunter Scott. The employees initially thought that they were going to locate water meters on the property. However, when they arrived, they were ordered to do other tasks, including removing tree stumps, handling landscaping work and digging, preparing and pouring the house's foundation.

During the course of the three days the employees were working at the construction site, they used a backhoe, dump truck, trailer and two other vehicles owned by the town. Mayor Scott oversaw their work during most of those three days.

Mayor Scott told the employees not to fill out their public works department time sheets for the time they had spent at the construction site because they would be paid by a private

contractor who was supervising the project.

That contractor, a friend of Mayor Scott's, later told investigators from the Comptroller's office that he didn't have a contracting license and was merely acting as a helper. The contractor paid for the employees' time and reimbursed the town \$200 for the use of the backhoe.

According to three local companies interviewed by investigators, a backhoe would typically rent for \$240 to \$312 per day. Investigators were unable to calculate how much of the town's fuel was used at the job site due to a lack of adequate recordkeeping.

Investigators concluded that the use of town-owned equipment and town employees was an apparent abuse of the mayor's power and created potential liability issues for the town.

The investigators recommended that the town's board of mayor and aldermen calculate all costs funded by the town on the construction project and seek reimbursement from the mayor, his son and/or the contractor.

Also, investigators learned that one member of the board of aldermen had used the town's backhoe at his home on two occasions and public works department employees and equipment were used to spread asphalt on private property owned by another local resident. Investigators recommended that the town also calculate those costs and seek reimbursement from the property owners.

"It is unacceptable for officials to use public resources for the exclusive benefit of private individuals," Comptroller Justin P. Wilson said. "People pay taxes and fees with the expectation that money will be fairly distributed to provide services to all citizens, not just a select few who happen to know somebody at city hall. I commend our investigators for their fine work in bringing these issues to light."
