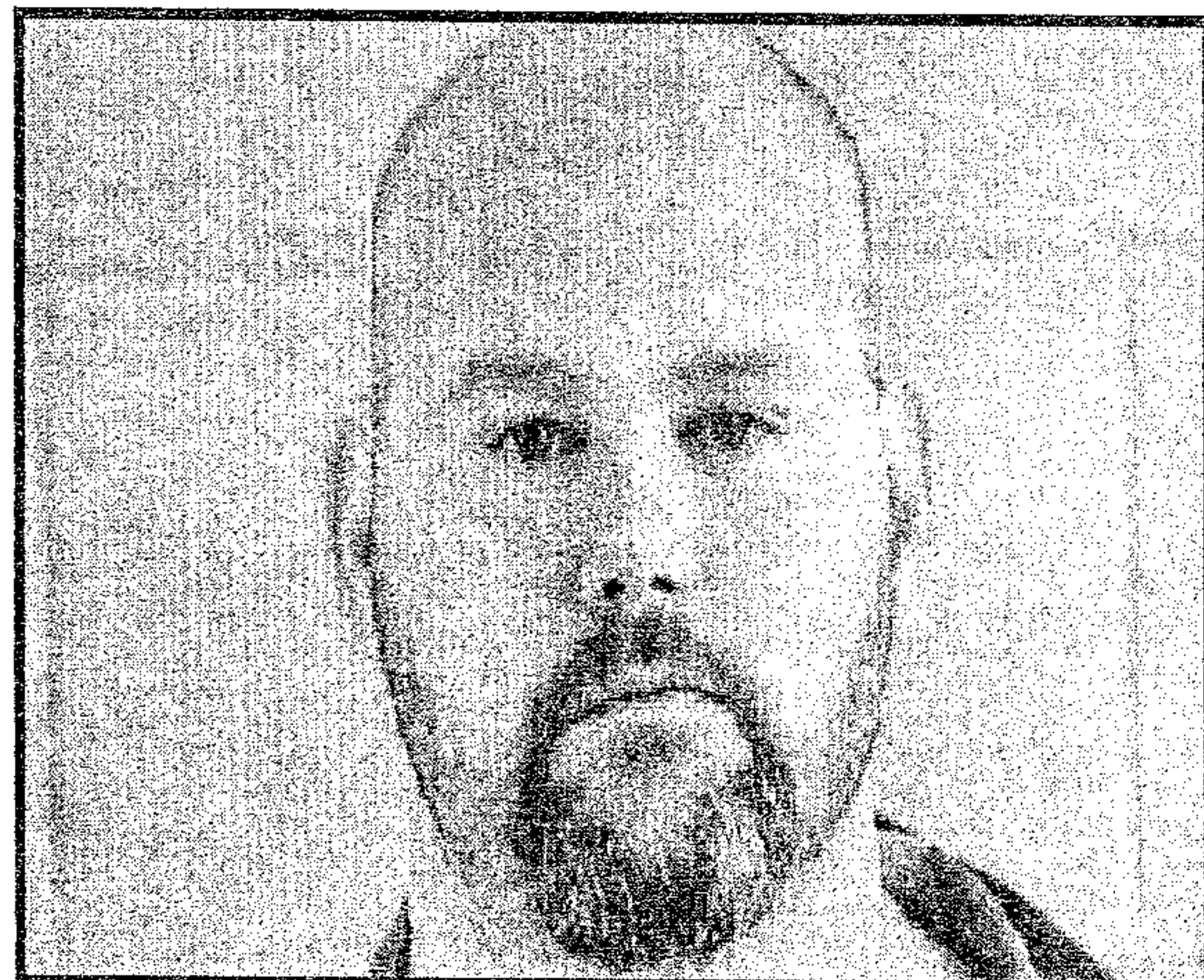

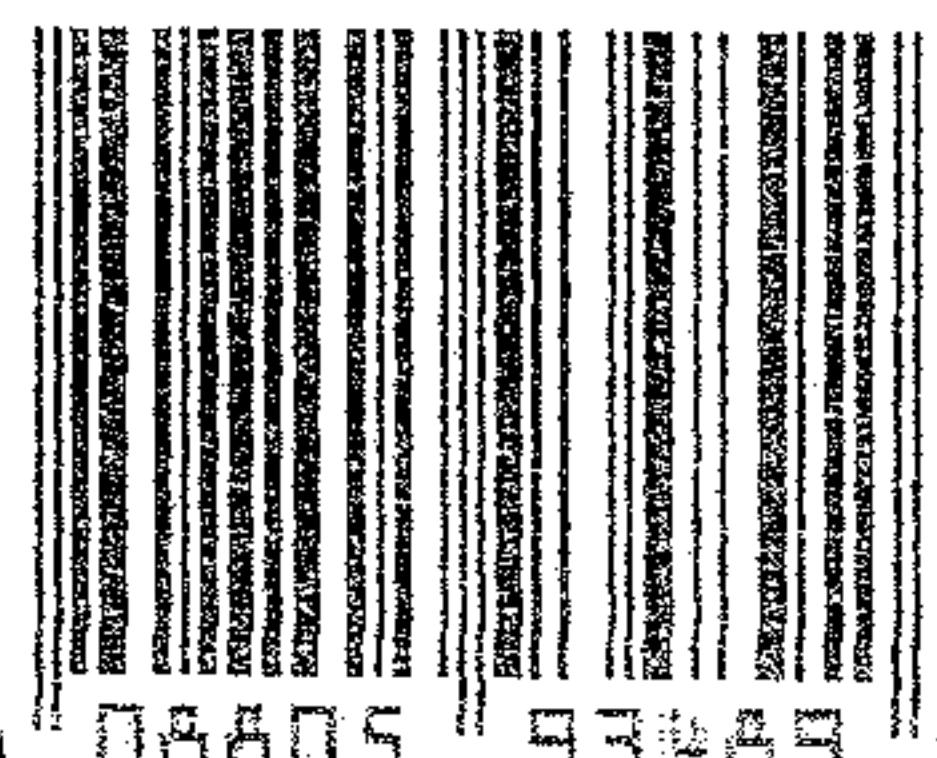

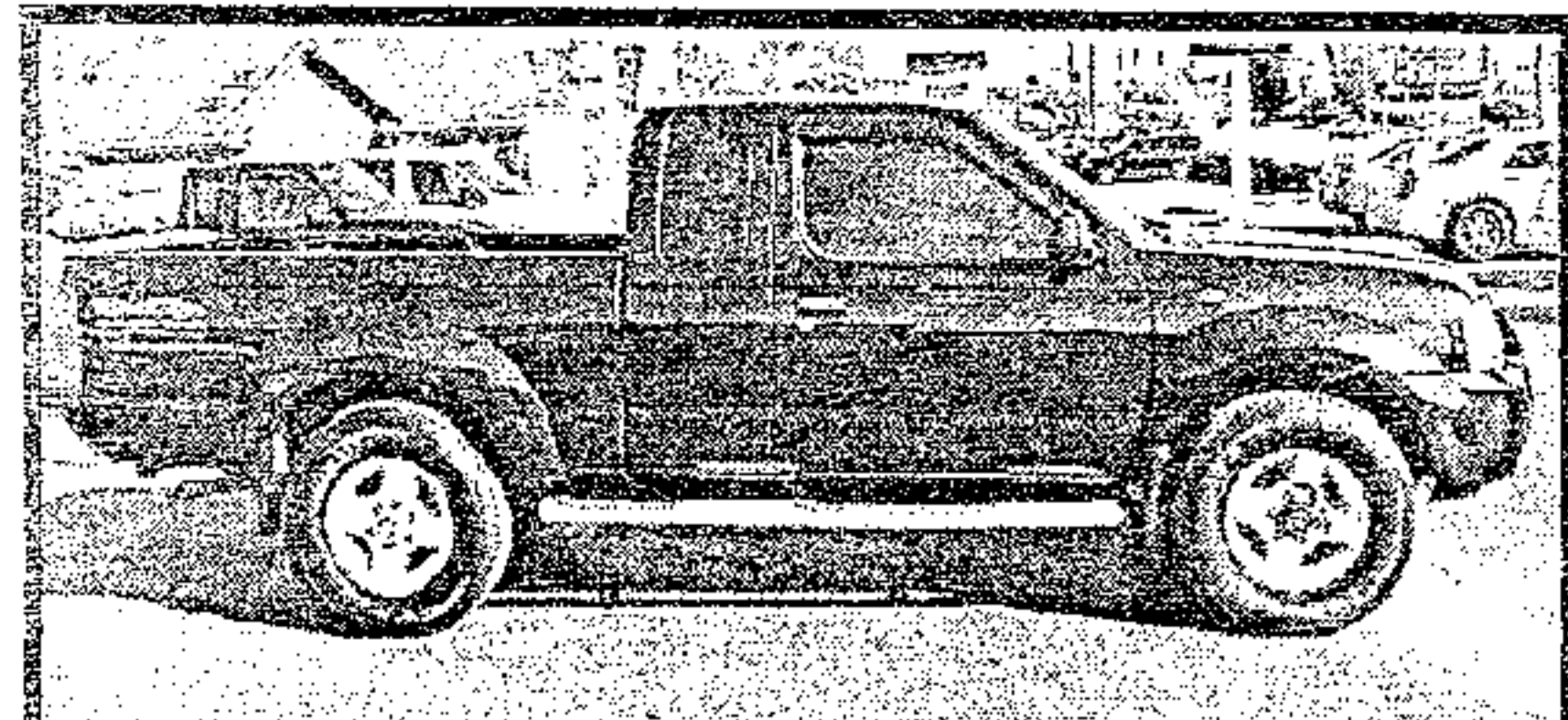

Attack

Carlton Garvin, 61, Moss Road Philadelphia, was charged with Aggravated Assault, and Domestic Assault. On this date 05-23-2014 Deputy Rondel Branam LCSO, responded to Moss Road on a possible Domestic Assault involving a knife.

Upon arrival Deputy did see Mr. Carlton Marion Garvin laying on the ground and victim 1 was holding him down. Victim advised this officer that Mr. Garvin had pulled a knife on him and he was intoxicated. Upon speaking to Mr. Garvin Deputy was unable to find out what had happened due to his intoxication. Upon speaking to victim

2, she stated that she and her husband, Carlton Garvin, had been arguing over getting a divorce and Carlton threw a punch at her. At that time Victim 1, victims 2 boyfriend, stepped in between the two. Carlton then punched victim 1 in the face and at that time victim 1 wrestled Carlton out of the residence and to the ground.
