Nessie Brotherton, 40, West Church St Greeneville, Tn. Was charged with DUI, Aggravated Assault, Evading Arrest, Reckless Endangerment, and Resisting arrest.

Ralph McNabb, 45, Cedar Crest Rd Mosheim, TN, was charged with Evading Arrest.

Trooper Eric Miller THP, stopped a vehicle at the 68 mm. Trooper Miller removed the defendant Nessie from the vehicle, and placed him in front of his vehicle and administered a series of field sobriety test. Following these test THP Miller went to speak with the front seat passenger Ralph McNabb who was also Nessie's brother. At that time Nessie took several steps to his vehicle before Trooper

could stop him. Nessie fled to his vehicle and attempted to flee.

Trooper Miller physically attempted to stop Nessie from leaving the scene but was unsuccessful, as Nessie was driving off Trooper Miller still had a hold of Nessie, and Trooper was almost knocked off his feet, Trooper Miller fired 3 shots at the operator however neither struck the operator or passengers. The vehicle entered the interstate swerved into both northbound lane and struck a vehicle which had traveled into the median to avoid.

Nessie continued on I-75 N traveling in excess of 100 mph before exiting the interstate at 72. Nessie continued on State

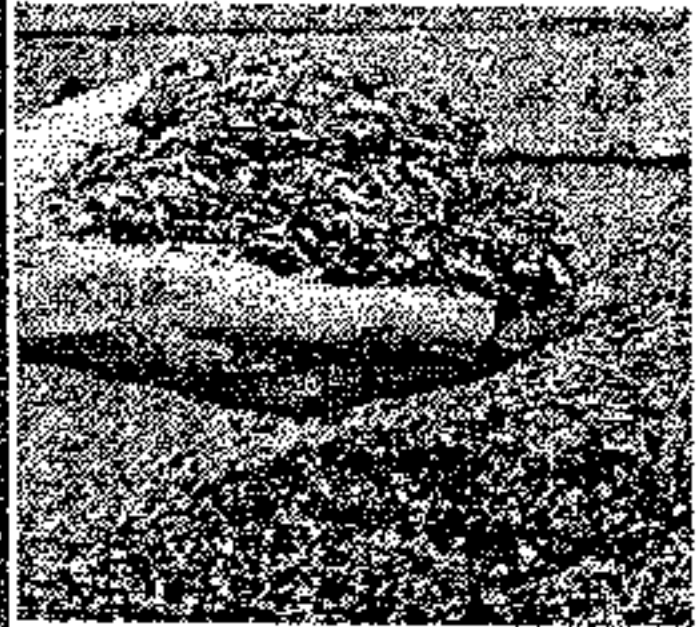
Rd. 72 to 11 where he turned towards Sweetwater, When Nessie reached the intersection of HWY 11 and Pond Creek they turned right somewhere near the Grizzly Pig the defendant slowed and the passenger in the back Daulton Brotherton also the defendant son jumped out of the vehicle, and went into the Grizzly Pig and called 911.

The vehicle continued on Pond Creek Rd. where they stopped and fled. Both Nessie and Ralph McNabb was apprehended. Daulton has not been charged as of presstime.

Pablo Cisneros, 25, Saddle Creek Circle Arlington, was DUI, and Violation of implied consent. 




