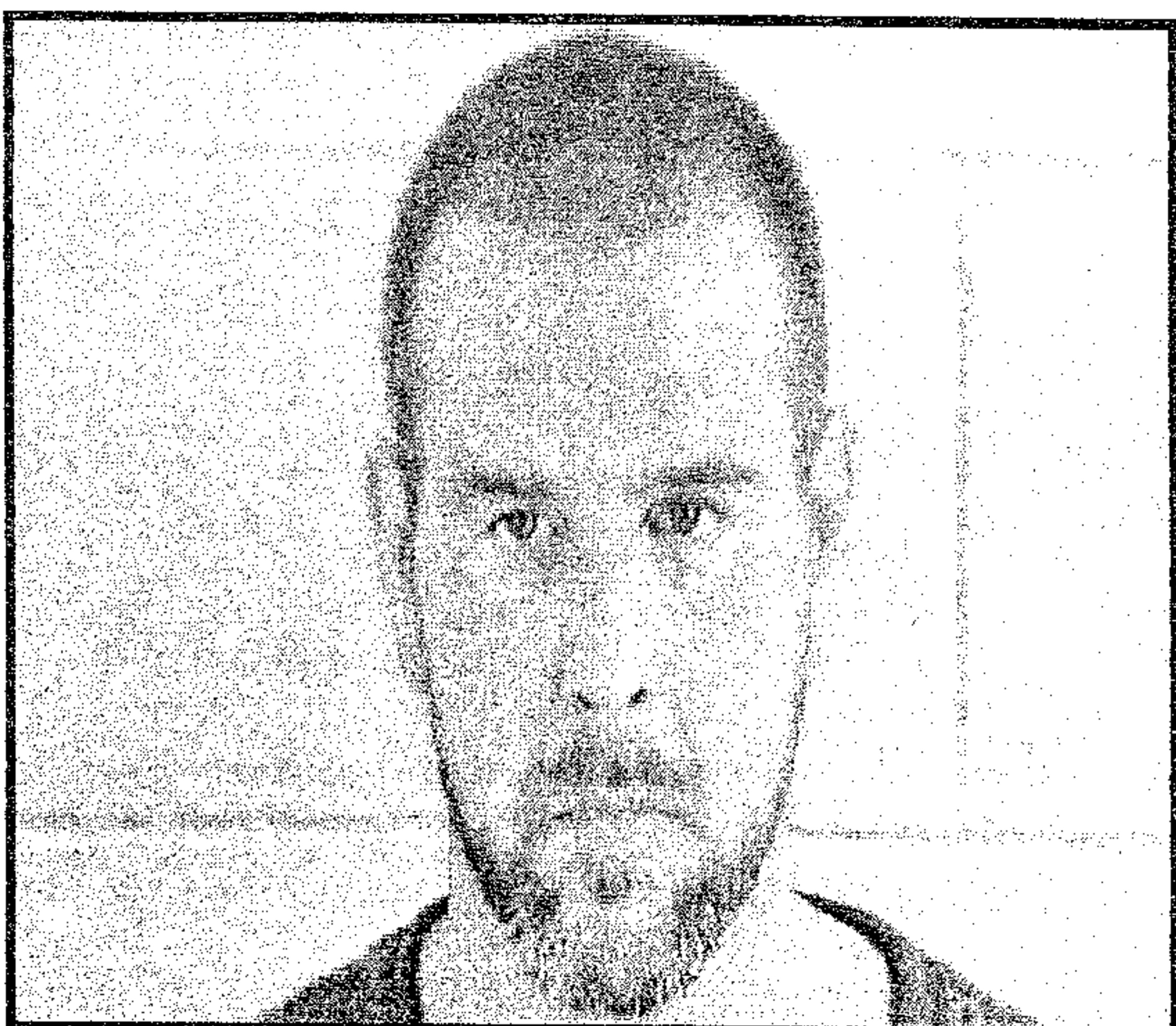

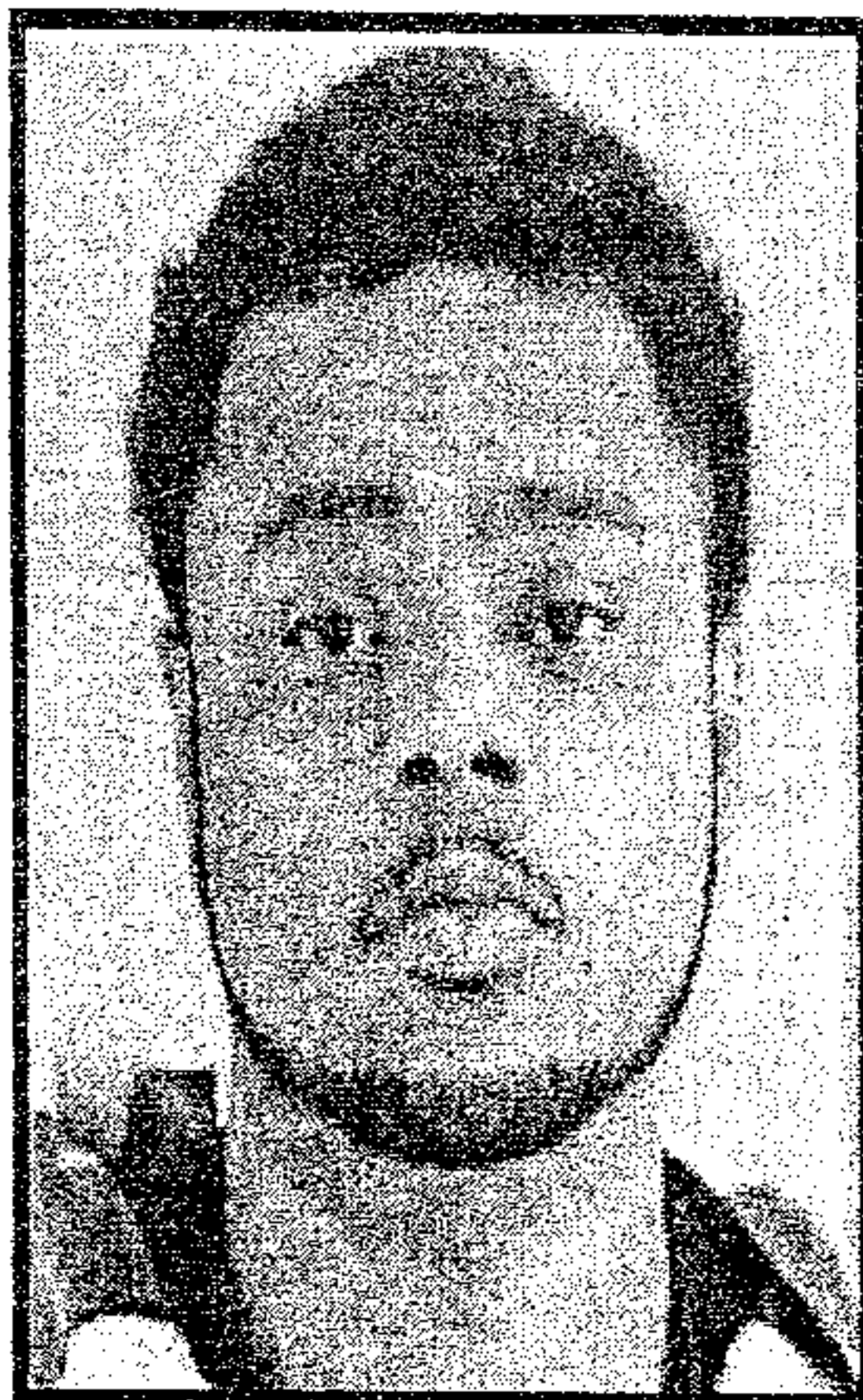

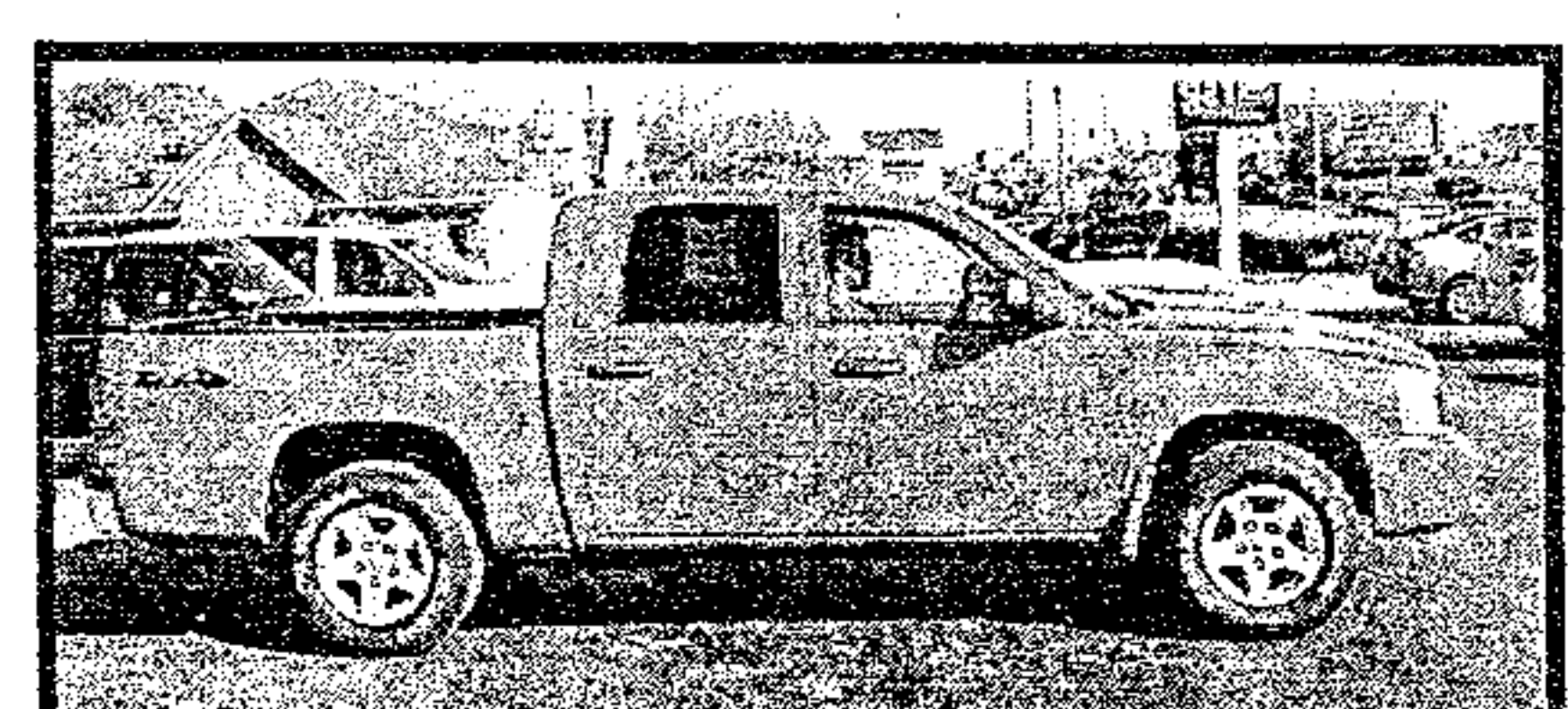

Deputy Craig Brewer LCSO, responded to Vonore Road Loudon, to a report of a

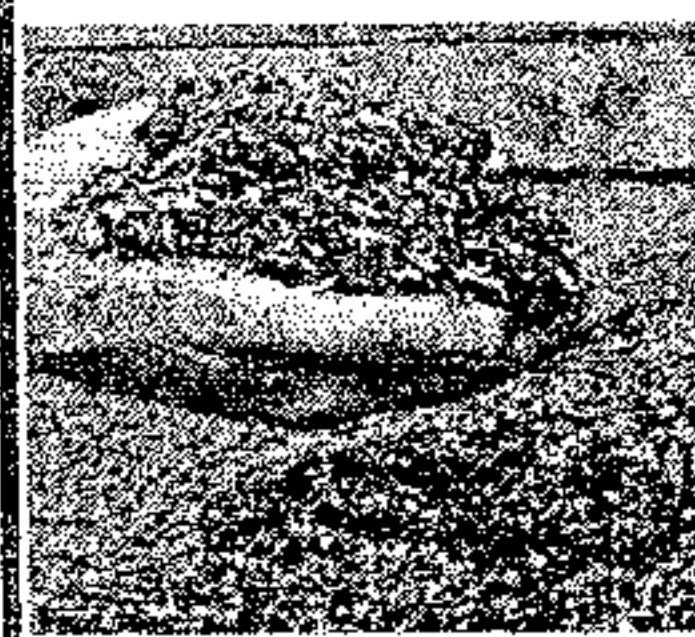
domestic dispute. On arrival found Tommy Overton and victim at the residence. They are in a relationship and reside together.
