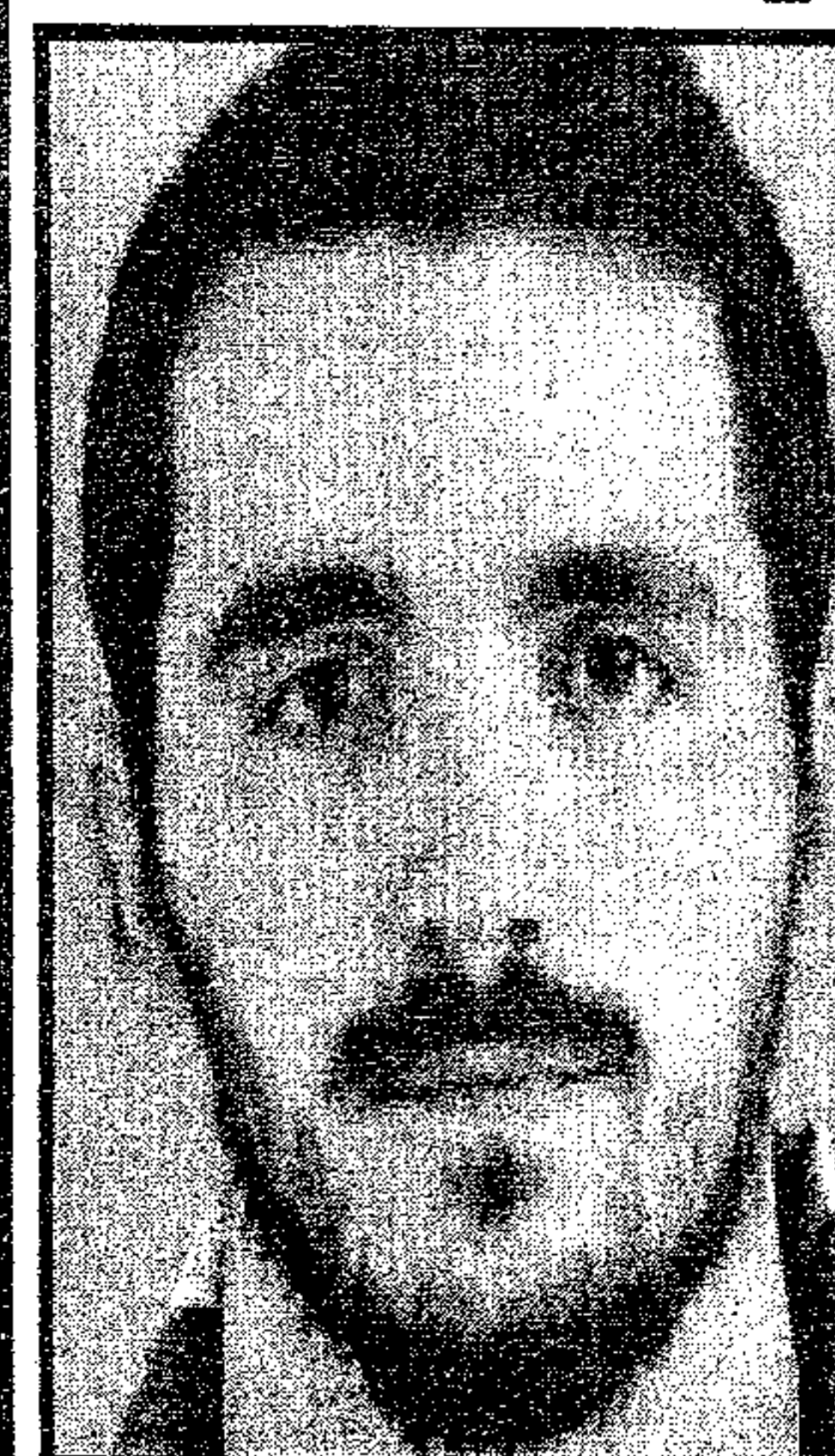

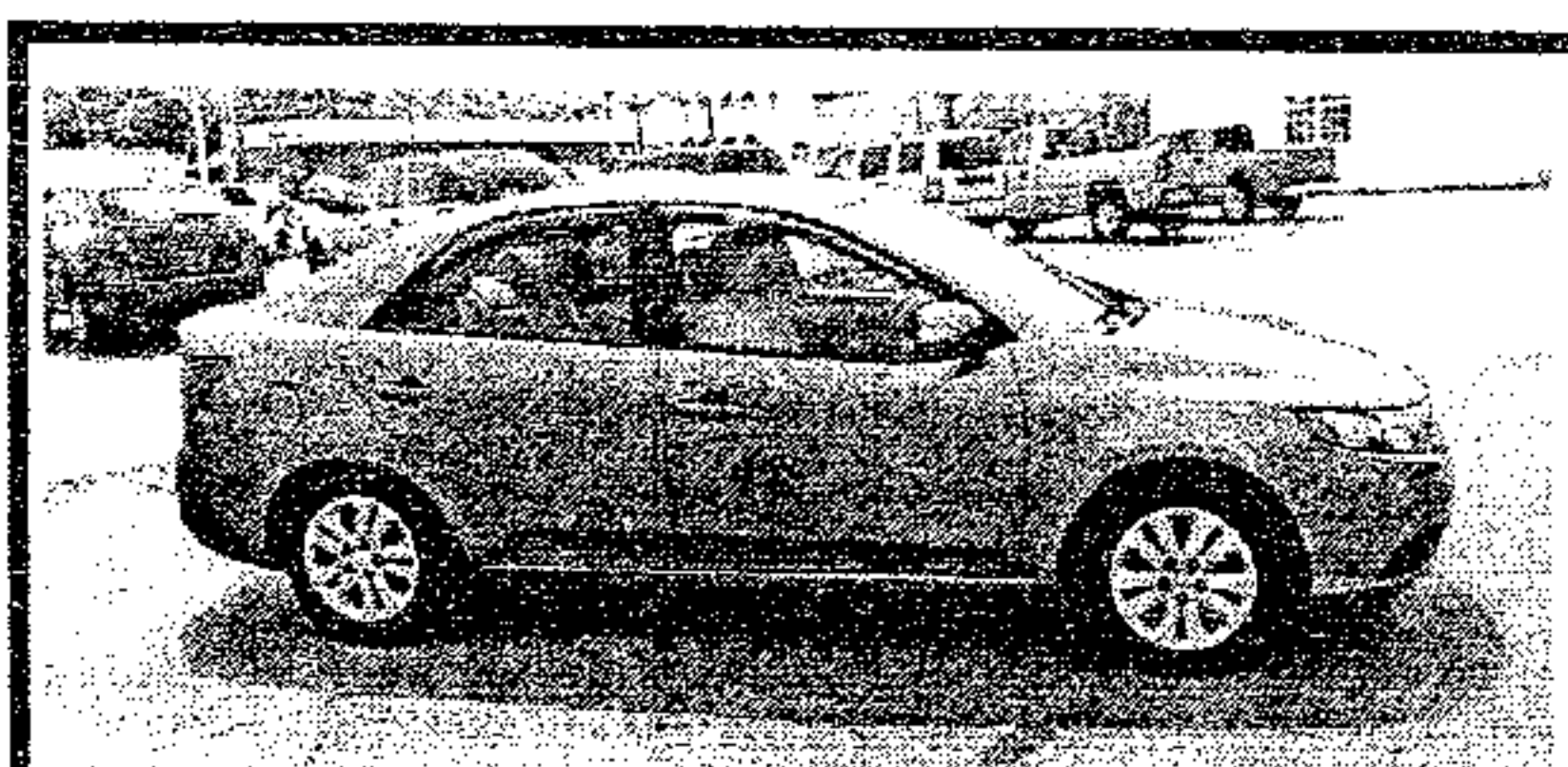

was sitting.
