Mark Freeman, 54, Belmont Circle Cleveland, was charged with DUI, Evading Arrest, and Resisting Arrest.

According to the report, Cpl. Brandon Dixon LCSO, responded to a reckless driver call on I-75 Southbound approaching the 81 mile marker. Contact was then made with the described vehicle, a 2014 recreational vehicle white in color. The said vehicle crossed the center line and the fog line several times. Cpl. Dixon then activated his emergency equipment around the 77 mile marker. The vehicle did not stop and was traveling approximately 55mph.

The RV continued on 75 South approximately 4 miles with speed varying from 55mph to

The following items were found inside the vehicle: 3 bags of marijuana (apprx 13 grams), 1 pipe, 1 pack of rolling papers, 1 set of digital scales, 1 needle (in a McDonalds cup of tea), 2 bottles of inhalants and approximately 1 gram of methamphetamine with two empty bags with a crystal substance on them.

Some of the Meth and marijuana was located in a compartment under the ashtray between the driver and passenger.

There was also one bag containing a crystal substance on the ground of the passenger side where Ms. Stevens exited.

All four subjects were arrested and transported to the Loudon County Jail. Ms. Stevens had in her bra one needle and Ms. Visage

had one spoon in the jail. Deputy Jamie Ketner LCSO, made the arrest when we arrived at the rest.
