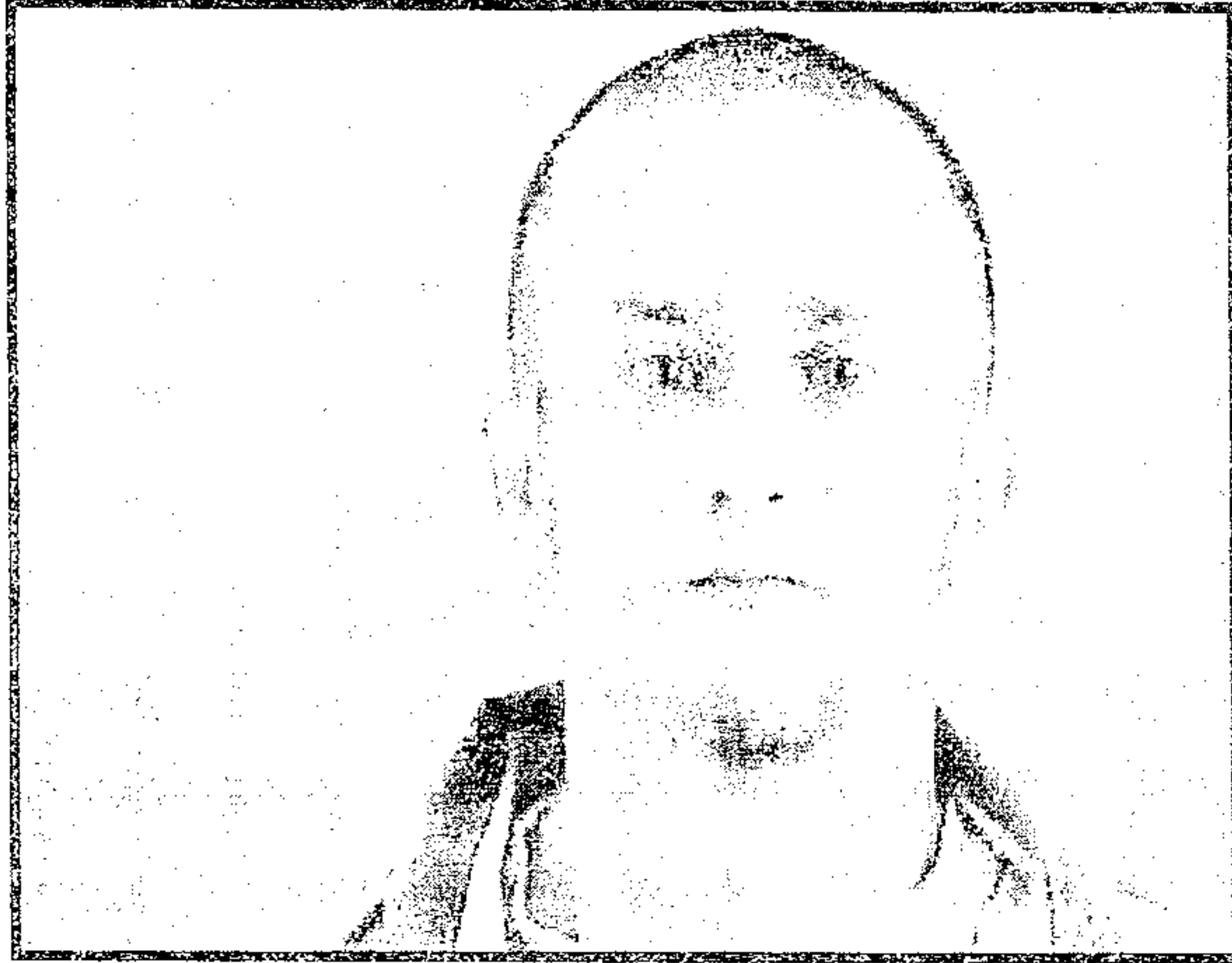

University Employee Payroll Scam

University employees are receiving fraudulent e-mails indicating a change in their human resource status. The e-mail contains a link directing the employee to login to their human resources website to identify this change. The website provided appears very similar to the legitimate site in an effort to steal the employee's credentials. Once the employee enters his/her login information, the scammer takes that information and signs into the employee's official human resources account to change the employee's direct

BRIAN MURPHY SENTENCED TO 45 MONTHS IN PRISON FOR CONSPIRACY TO COMMIT MAIL AND WIRE FRAUD THROUGH BENCHMARK CAPITAL PONZI SCHEME

Brian Murphy, 43, of Knoxville, Tenn., was sentenced on January 8, 2015, to serve 45 months in prison by the Honorable Thomas A. Varlan, Chief U.S. District Judge.

Murphy was also ordered to pay \$18 million in restitution to the victims in the case.

Murphy pleaded guilty in August 2014, to a federal indictment charging him with conspiracy to commit mail and wire fraud. The indictment arose out of Murphy's participation with Joyce Allen and

The indictment and subsequent conviction of Murphy was the result of a three-year investigation conducted by the Internal Revenue Service, U.S. Postal Inspection Service, and Federal Bureau of Investigation. Assistant U.S. Attorneys Frank Dale and Jennifer Kolman represented the United States.

deposit information. This re-directs the employee's paycheck to the bank account of another individual involved in the scam.

Consequences of this Scam:

The employee's paycheck can be stolen.

The money may not be returned in full to the employee.

The scammers can take the employee's log in credentials and attempt to log into other accounts that belong to the employee.

Tips on how to Protect Yourself from this Scam:

Look for poor use of the English language in e-mails such as incorrect grammar, capitalization, and tenses. Many of the scammers who send these messages are not native English speakers.

Roll your cursor over the links received via e-mail and look for inconsistencies. If it is not the website the e-mail claims to be directing you to then the link is to a fraudulent site.

Never provide credentials of any sort via e-mail. This includes after clicking on links sent via e-mail. Always go to an official website rather than from a link sent to you via e-mail.

Contact your personnel de-

partment if you receive suspicious e-mail.

If you have been a victim of this scam, you may file a complaint with the FBI's Internet Crime Complaint Center at www.IC3.gov. Please reference this PSA number in your complaint.

Kenneth Yates, 47, Britton Road Loudon, was charged with DUI, Driving on Revoked License, and Assisting other Agency.

Officer Padgett, did observe a white cavalier driving north

on highway 321. Officer observed the vehicle cross over the center line multiple times and the driver side brake light was not working. Officer then activated his emergency equipment and stopped the vehicle in the parking lot of Weigels gas station at highway 70 and highway 321. Upon making contact with the driver, he was identified as Mr. Kenneth Yates. Upon speaking with Mr. Yates, his speech was slurred, and his eyes were bloodshot. Officer asked Mr. Yates to exit the vehicle to perform standardized field sobriety tests. At which time he did perform poorly. Lt. Flynn asked for consent to search Mr. Yates vehicle, at which time Mr. Yates gave verbal consent. Upon Lt. Flynn searching the vehicle, a prescription bottle of clonazepam 2 mg and a prescription bottle of hydroxyzine 50 mg were found in the vehicle. The prescription bottle of clonazepam was filled on 1-8-

15, with a quantity of 90 pills, there were only 6 pills remaining in the bottle. Mr. Yates was then placed under arrest for driving under the influence and read Tennessee implied consent law. After reading Tennessee implied consent law, Mr. Yates refused to give blood. Upon having Mr. Yates ran through NCIC my dispatched advised me that Mr. Yates drivers license was suspended for failure to satisfy citation. Dispatched also advised me he had a warrant out of monroe county, for failure to appear. Mr. Yates was then transported to the loudon county jail. Officer Bruce Padgett LCPD, made the arrest.

open. The victim then went to the front door and notice the door had been forced open. The victim stated several firearms along with some jewelry were missing, see list. 


