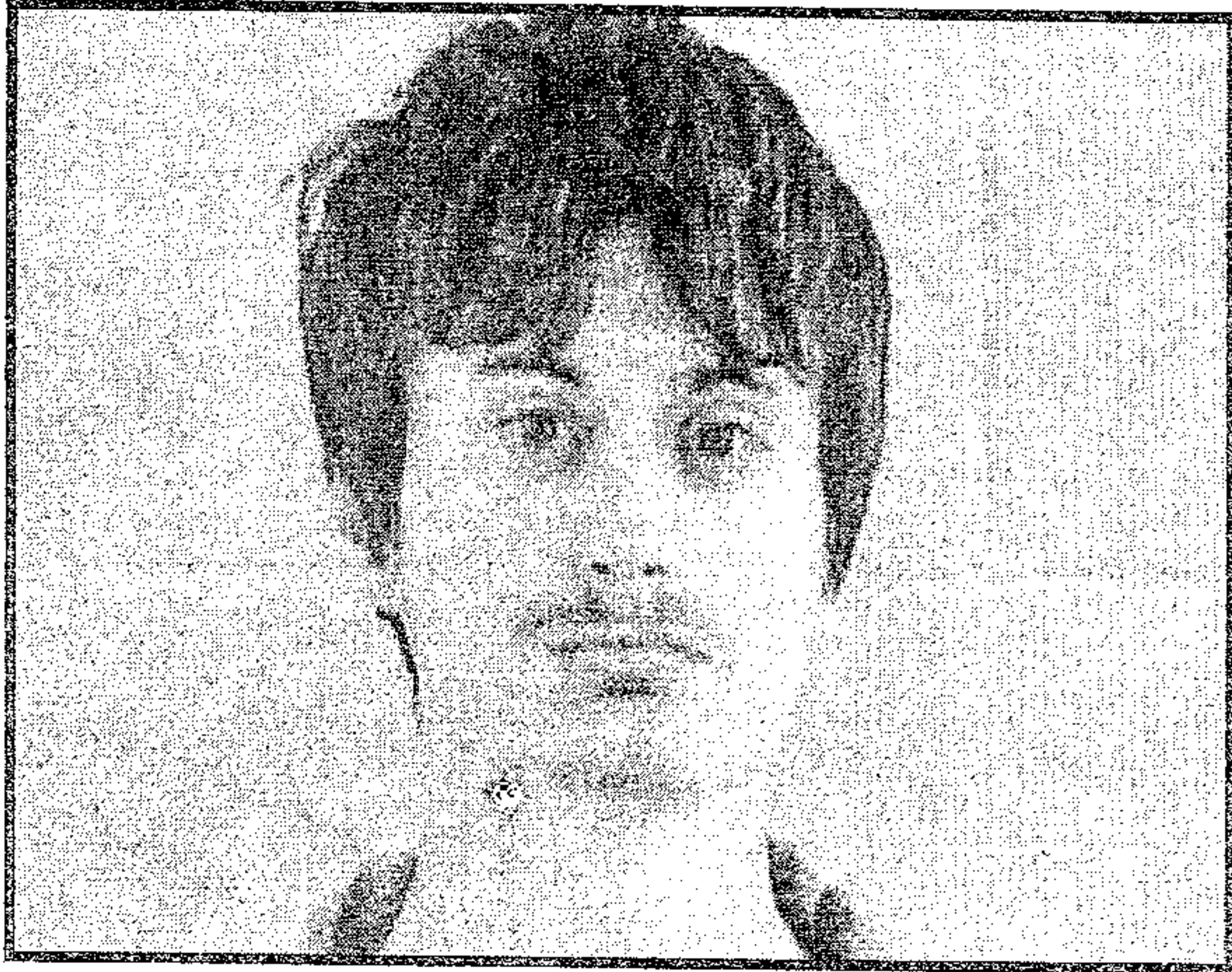

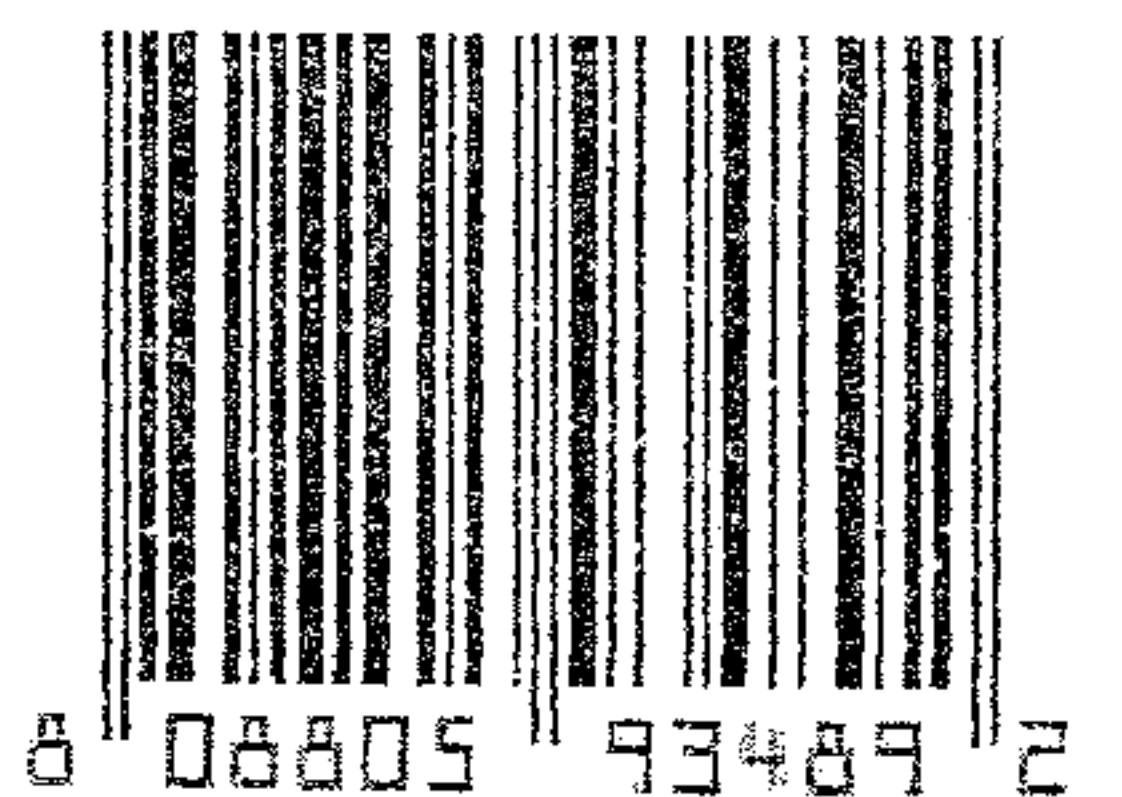

Matthew Jenkins, 23, Gleason Road Knoxville, was charged with DUI & violation of implied consent.

According to the report, Deputy C. Parker LCSO, responded to Northshore Drive near Nichols Road on a single vehicle accident with no injury. Upon arrival, Deputy

We were looking at the life and ministry of John the Baptist as described in the opening verses of John and in the first chapter of the Gospel of Luke. We talked about John the Baptist's ministry being foretold in Isa-

iah 40:3 and how he had been ordained from before birth to "Prepare the way of the Lord" and "Make straight in the desert a highway for our God".

John the Baptist was given a mission to proclaim the arrival of Jesus Christ as the awaited Savior. He preached repentance of sins and baptized with water as a way for people to symbolically purify and identify with the need for Jesus. John the Baptist made it clear that he was really a "Nobody" but Jesus was truly a "Somebody"!

John 1:26-27 (NKJV) John answered them saying, "I baptize with water, but there stands One among you whom you don't know. It is He who, coming after me, is preferred before me, whose sandal strap I am not worthy to loose". While John was preaching and baptizing people in the Jordan River some Jewish priests and

Levites, who were sent from Jerusalem, approached him to find out who he was and what he was doing. They asked John the Baptist if he was Elijah or one of the prophets. When he told them that he was neither, they said the following to him:

John 1:22 Then they said to him, "Who are you, that we may give an answer to those who sent us? What do you say about yourself?"

Last night I asked the guys in our discipleship meeting, and I pose the same question to you today..... Who are you and what do you say about yourself?

John the Baptist responded by pointing the Jewish leaders back to Isaiah chapter 40. I respond by pointing you to Luke 9:23-24, "If anyone desires to come after Me, let him take up his cross daily, and follow me. For whoever desires to save his life shall lose it, but whoever loses his life for My sake

will save it."

In many ways, our responsibility as a follower of Christ is very similar to the mission of John the Baptist. We are to acknowledge that each breath we consume is a gift from Jesus Christ who loves us and gave His life for us. We are to proclaim His eminent return and point those around us to Jesus for eternal salvation. If we live like the world around us we are clearly not "losing our life for Jesus' sake to save it".

In closing today, I again ask you to consider the question..... Who are you? What do you say about yourself?

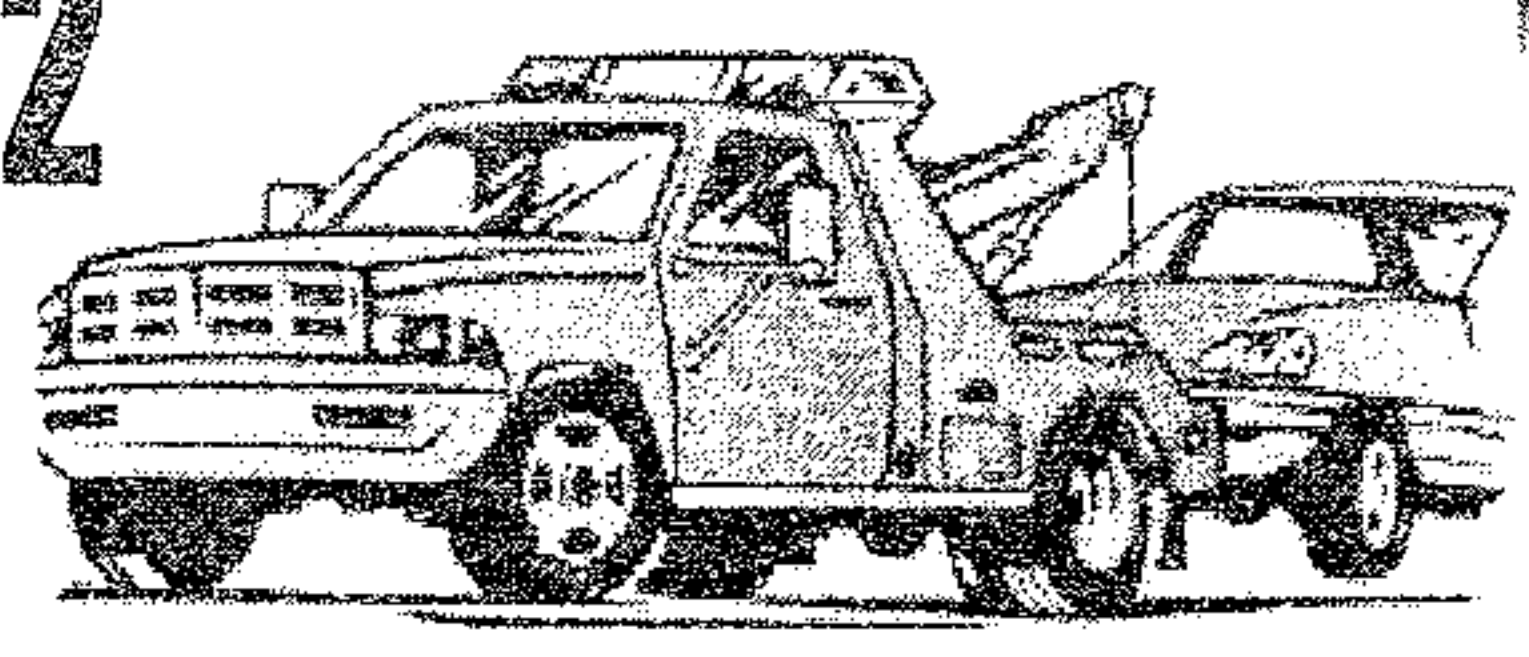
