Drugs

Corey Chambers, 24, Wasser Cove Bartlett, was charged with Manufacture/Sell/Delivery/Resale of SCH. I x2, SCH. VI, IV, III, and Poss. of Drug Para.

William Fite, 36, Dogwood Road Germantown, was charged with Manufacture/Sell/Delivery/Resale of SCH. I x2, VI, IV, Poss. of Drug Para. and DUI.

Sgt. Michael Watkins did received a call of a possible intoxicated driver in a black Lincoln traveling south on I75. Deputy made contact with the vehicle at the 68mm southbound, as it passed Deputy he observed the vehicle across the center line. Deputy then got in behind said vehicle and it crossed the line almost one half of the car width and jerked back to the right. Upon traffic stop the vehicle was very slow to stop and appeared the driver was reaching into the seat before coming to a stop. Upon contact with the driver a Mr. William Ryan Fite, Deputy could smell the odor of alcoholic beverage emitting from the vehicle. Trooper Whitt

and Trooper Best arrived on scene and administered field sobriety tasks on the driver. A passenger, Mr. Corey Chambers was asked to exit the vehicle and when he did so Deputy deployed K9 Derro to sniff the exterior of the vehicle. Before Deputy ever made it all the way to the vehicle Derro began pulling Deputy to the vehicle and jumped through the drivers window and alerted to a black back pack located in the passenger floorboard area. A search of the back pack and vehicle found, 1.5 grams of Molly(MDMA) (Sch1), 25 hits of LSD (Sch1), 23.8 grams of Marijuana (Sch 6), 4.5 grams Hash oil (Sch 6), 12.8 grams Hash (Sch 6), 3-1mg Clonazepam (Sch 4), 2-2mg Clonazepam (Sch 4), 5-1mg Clonazepam (Sch 4), 4 - .5mg Clonazepam (Sch 4), 2-10mg Diazepam (Sch 4), 20.5 Alprazolam 2mg (Sch 4), 17-1mg Alprazolam (Sch 4), A Marijuana grinder, 3 E cigarettes with some of the hash oil inside, and rolling papers. Upon a search

of Mr. Chambers person 1 of the E cigarettes was found on his person along with 4 8mg suboxone(3mg) and rolling papers. During interview neither subject would state the items were theirs. Mr. William Ryan Fite and Mr. Corey Scott Chambers was arrested for 2 counts of Poss of Sch 1, 1 count of possession of sch6, 7 counts of possession of Sch 4, and possession of drug paraphernalia. Chambers also was charged with poss. of Sch 3. Sgt. Michael Watkins LCSO, made the arrest. **DUI**

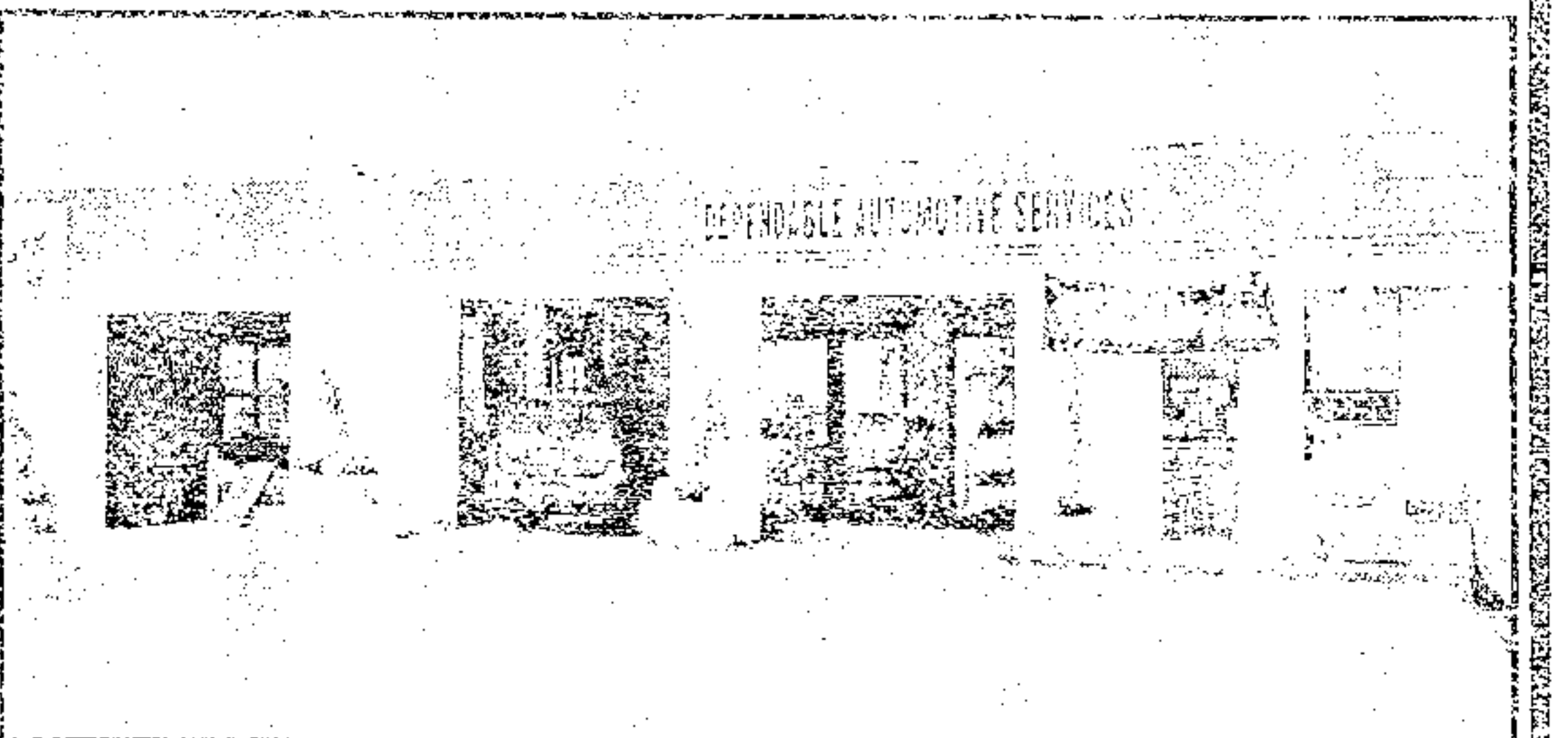
Franklin Spears, 47, Kelly Lane Lenoir City, was charged with DUI.
