Melody Spears, 56, Bussell Ferry Road Lenoir City, was charged with DUI, Simple Possession/Casual Exchange, and Violation of Implied Consent.

Officer Jason Arden LCPD, performed a traffic stop on a red Mazda pick-up truck, tag MOOSKA, for driving without headlights. Upon stopping the vehicle, Officer identified the driver as Melody Faith Spears, age 56, of Lenoir City. Mrs. Spears had a strong odor of an alcoholic beverage about her person and had slurred speech and blood shot eyes. Upon officer inquiry, Mrs. Spears admitted to consuming alcohol prior to being stopped.

Officer Brandon Gentry arrived on scene and performed Standard Field Sobriety Tests on Mrs. Spears. Mrs. Spears was unable to perform or complete any of the tests and was placed under arrest for Driving Under the Influence. A

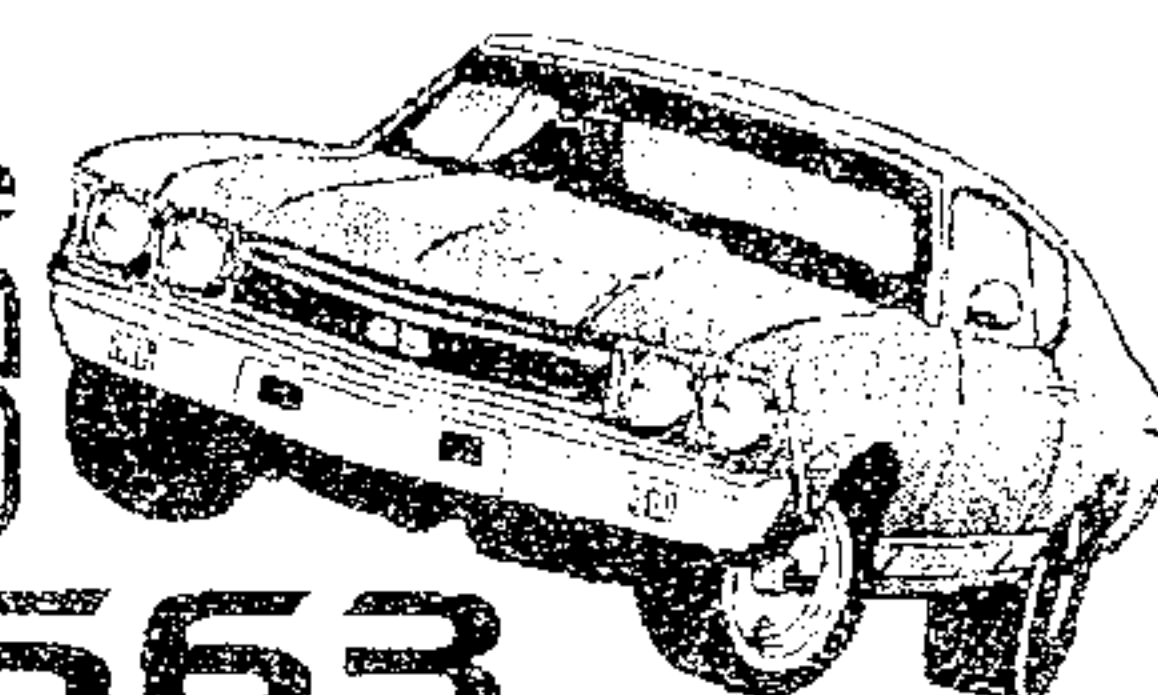

LCPD, spoke with the complainant who stated a white male came into the bank and attempted to cash a check made out to a male subject in the amount of \$8,765.00 drawn off of victim (Falmouth Rd. Chattanooga, TN 37405). No bank info was found on the check number. During Investigation Officers found that the check was counterfeit and the Florida DL was a fake counterfeit as well.

Investigation showed that the male trying to cash the check was Mark Anthony Darden, W/M, who lives at Jeff Webber Road Lyons, Ga. Mr. Darden stated an email on his phone was asking him if he wanted to work and that it was legal. Mr. Darden talked with a male he identified as Rico who after approximately one month picked Mr. Darden up at his house. They then stayed at a motel in Atlanta, GA and got up on this date and drove to Lenoir City, TN. to FSG Bank where Rico, Eddie, Chris (all black males) dropped him off to cash the check. The three

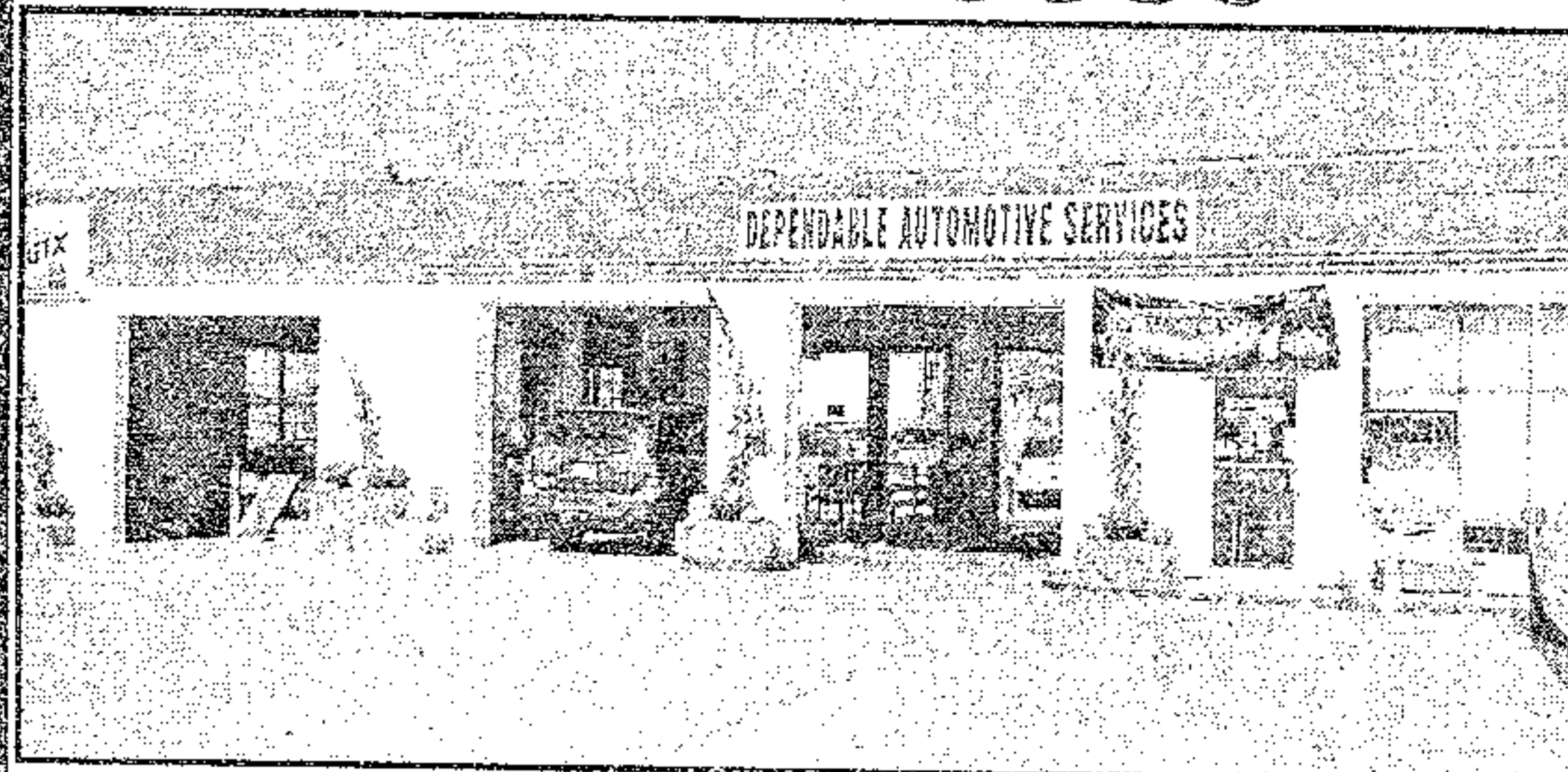

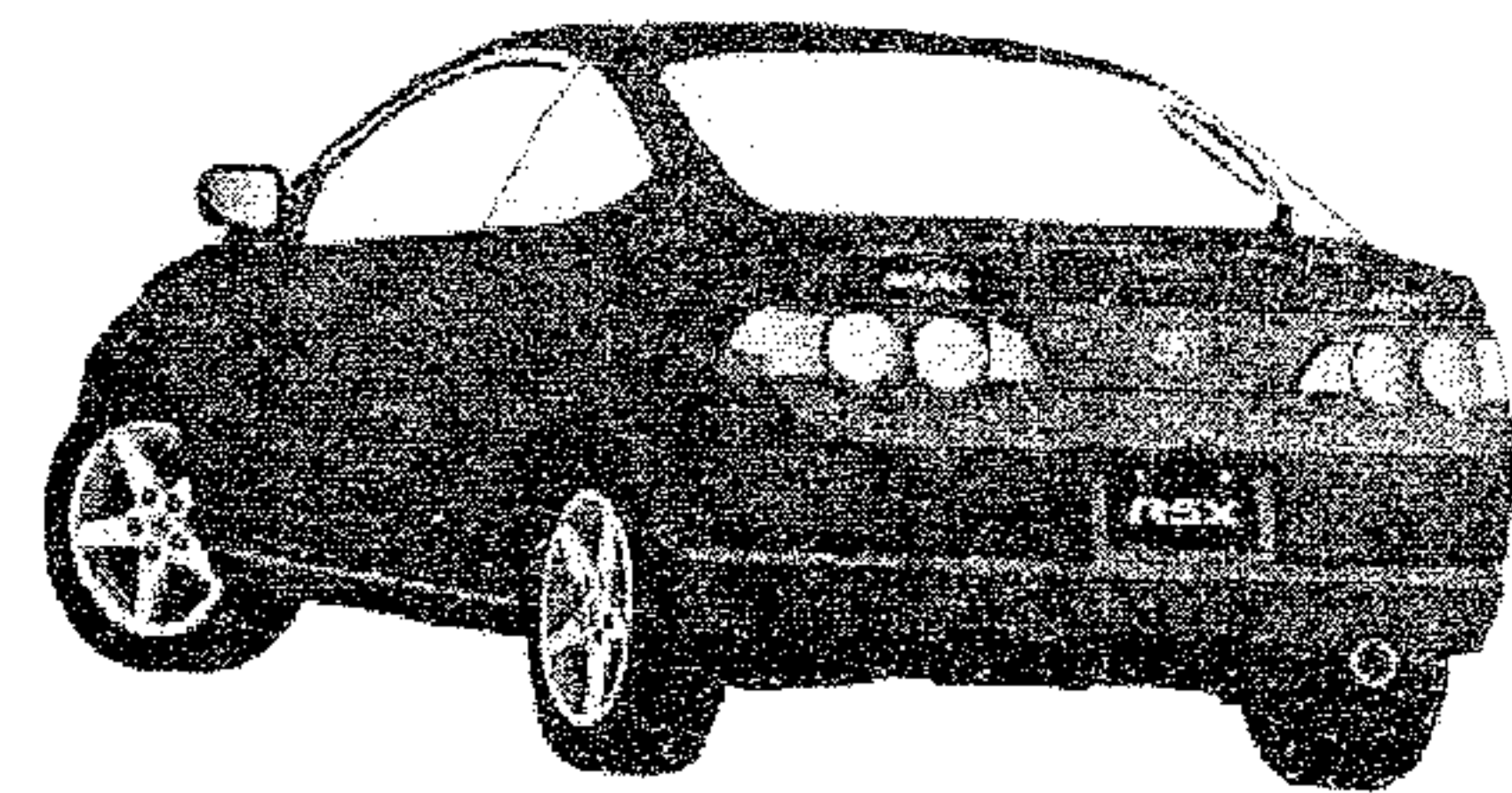

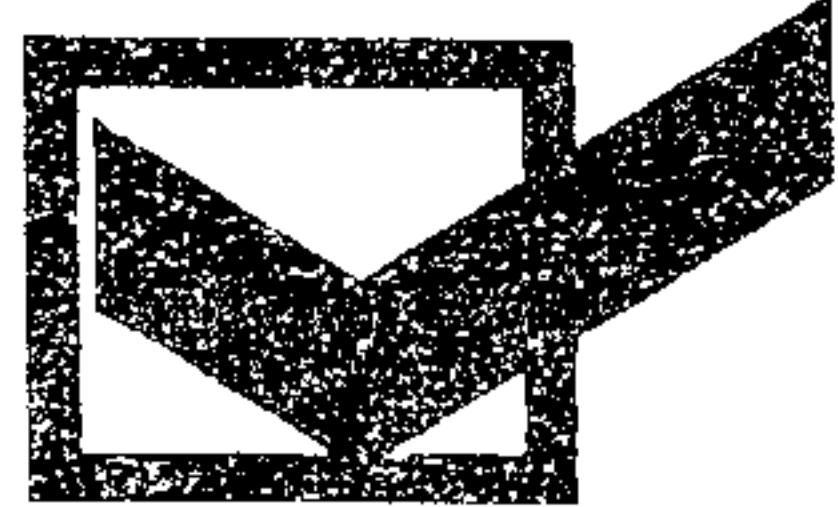
