LPD, LCSO and 9th DTF Team up to catch robber



Eyewitness Testimony





of the testimony is to share one's firsthand knowledge of an event in hopes of convincing others (the judge or a jury of one's peers) of a fact that we believe to be true and accurate.

Each time someone approaches the witness stand to testify they are asked a question similar to this: "Do you swear, or affirm, that the testimony you are about to give will be the truth, the whole and nothing but the truth, so help you God?"

The witness is asked to make a declaration, as God as their witness, that what they are going to say is not fabricated, not embellished, not exaggerated; but the absolute truth. If the witness is deemed "Credible" by those he or she is trying to persuade, then the weight of their testimony could have life changing consequences for

the person they are testifying about.

So why is courtroom testimony being discussed within a Christian article? What does this have to do with Jesus? I was hoping you would ask yourself that question. Acts 1:8-9 is the reason.

"But you shall receive power when the Holy Spirit has come upon you; and you shall be witnesses to Me in Jerusalem, and in all Judea and Samaria, and to the end of the earth. Now when He had spoken these things, while they watched, He was taken up, and a cloud received Him out of their sight." The last thing Jesus told His disciples, which now includes every believer, was to be a witness to those around them in the city they were currently in, to the surrounding country side, to other nations and ultimately to the entire world. Jesus' disciples were faithful

to that command and as a result, I had the gospel shared with me and made the decision to accept Jesus as my Savior. Their "eyewitness testimony" traveled from Jerusalem over two thousand years ago, and somehow eventually landed between my ears in East Tennessee on the night of November 17, 1987. Through the drawing and the power of the Holy Spirit, I deemed their testimony credible and made

a decision that has forever changed my life.

How credible and believable is your testimony for Christ today? If you claim to be a Christian, who have you "witnessed" to lately? Have you shared the truth, the whole truth, and nothing but the truth about the saving power of Jesus Christ with any lost person around you recently? If you were to do so, how would
