strongly of alcohol and stated that she lived at the residence. It was determined throughout the investigation that juvenile had lied, she does not live at the residence. Additionally the parental unit at the residence was Rachel Russell, who is the mother of juvenile, both reside at Ellen Lanc. Russell stated that she, Russell, had been consuming vodka throughout the evening. Russell stated that she knew her daughter, was having friends over for the evening but was unaware that three juvenile males had been at her residence and had brought beer and sex toys.

Inside the residence on the kitchen table beer pong was set up, as well as scattered throughout the downstairs as well as Vodka in plain view. Russell was supposed to be the parent and legal guardian of the children who were present and then allowed them to consume alcohol, have tobacco, as well as have sex toys. The juveniles who were present when Deputy arrived on scene did commit the offense of Contributing to or encouraging delinquency or unruly behavior of a child. Russell did in fact contribute to and encourage the delinquency or unruly behavior of multiple children by allowing them to consume alcohol while she was supposed to watching them as well as she lied in order to conceal

their crimes. Deputy Brandon Burley LCSO, made the arrest.

William Sloan, 38, Siltzer Road Philadelphia, was charged with Criminal Impersonation, and Assisting other Agency. Deputy Kenneth Palmer LCSO, stopped a silver Nissan Versa on Highway 11 at Matlock Property's for running a stop sign. Deputy made contact with a passenger of the vehicle who stated his name was Clifford Sloan.

Deputy ran the name and date of birth trough dispatch at which time they advised that it was not on file. The suspect later advised his real name was William Wade Sloan. Deputy ran Mr. Sloan's name through dispatch at which time they advised Mr. Sloan had a warrant out of Monroe County for violation of probation for possession of a weapon by a convicted felon. Mr. Sloan was placed under arrest for criminal impersonation and violation of probation out of Monroe County. Deputy Kenneth Palmer LCSO, made the arrest.

Angel Micheau, 28, W 3rd Ave Lenoir City, was charged with Contempt of Court, Theft of Property, and Illegal Poss./Fraudulent use of Credit Card. Deputy Brandon Dishner was advised by Cpl. Pam Snow that Deputy JC Schultz, LCSO, was enroute to the jail with 1 white female. Once Deputy Schultz arrived at the Loudon County Jail. Deputy took Angel Micheau into custody. At this time Deputy served three active warrants on Ms. Micheau.

Scotty Puckett, 42, Highland Ave Lenoir City, was charged with Criminal Impersonation. Officer Tyrel Lorenz LCPD, made contact with Scotty Puckett at the Rock Springs Park for a domestic disturbance call. Upon Officer contact with Scotty he gave Officer a different name. Upon further investigation a DL was found with Scotty's information. Scotty was placed under arrest.

Manuel Mejia, 25, E 2nd Ave Lenoir City, was charged with DUI.

Deputy Brandon Burley LCSO, did receive information from a Loudon County Rescue Squad member, that a black Nissan Sentra, was driving recklessly and was unable to maintain its lane. The vehicle was last seen on Highway 11 towards Lenoir City. Deputy did locate the vehicle on Highway Il were the vehicle left its lane of travel. Deputy conducted a traffic stop on Industrial Park at Highland. The vehicle continued traveling, passing several safe and legal places to stop, and eventually stopped at Industrial Park Drive,

partially blocking the access way. During the initial approach Deputy did make contact with the driver, Manuel Mejia, who had a strong odor of alcoholic beverage and red / watery bloodshot eyes.

Mejia was unable to explain why he was on Industrial Park Drive if not to avoid law enforcement contact. Mejia stated that he was on his way home, eventually changing the story to he was taking his friends home but the road they were on did not lead to any of their homes. Mejia was unsteady on his feet which he contributed to a knee injury, but when asked to perform modified field sobriety tasks Mejia did poorly. Mejia

stated he could perform the one leg stand. Mejia attempted the one leg stand providing multiple clues of impairment. Mejia also was asked to conduct the finger count and

Mejia provided multiple clues on this task as well. Mejia stated that he consumed (4) four alcoholic beverages prior to law enforcement contact. Given the preponderance of evidence Mejia was placed under arrest for driving under the influence 1st offense and read the Tennessee Implied Consent advisement to which in writing Mejia agreed to and was transported to the Ft. Loudon E.R. for a blood draw. Deputy Brandon Burley LCSO, made the arrest.



Shootout

Luis Rodgriguez, 33, Rogers Circle Lenoir City, was charged with Possession of Handgun While Under Influence, and Reckless Endagerment.

According to the report, Officer Don Lorenz LCPD, was dispatched to Rogers Circle for a domestic call with a male shooting out a window.

Upon arrival Officer was unable to make contact with anyone inside the residence. After a short while a female exited the residence who was identified as the victim. The victim stated to Officer that her husband Luis Rodriguez is suicidal and had locked himself in the bathroom. Victim stated that Luis was armed.

Luis exited the residence a short time later and had a strong odor of alcoholic beverage about his person. Luis was placed under arrest. Officer Don Lorenz LCPD, made the arrest.

both abroad and here in the United States," said Attorney General Loretta E. Lynch. "It spans at least two generations of soccer officials who, as

alleged, have abused their positions of trust."

Related guilty pleas of an additional four individuals and two corporate defendants were unsealed today as well. The investigation, which is ongoing, has also snared U.S. sports marketing executives. In all, it is alleged that more than \$150 million in bribes and kickbacks were paid or agreed to be paid to obtain media and marketing rights to international soccer tournaments.

"The defendants fostered a culture of corruption and greed that created an uneven playing field for the biggest sport in the world," noted FBI Director James B. Comey, "Undisclosed and illegal payments, kickbacks, and bribes became a way of doing business at FIFA," he said.

FIFA—the Fédération Internationale de Football Association—is the organization responsible for the regulation and promotion of soccer worldwide. It also oversees officials of other soccer governing bodies that operate under

the FIFA umbrella. The organization is composed of 209 member associations. including six continental confederations that assist it in governing soccer in different regions of the world. The U.S. Soccer Federation is one of 41 member associations of the confederation known as CONCACAE, which has been headquartered in the U.S. throughout the period charged in the indictment.

A key way FIFA makes money is by selling media and marketing rights associated with flagship tournaments such as the World Cup. Rights are typically sold through multi-year contracts. Sports marketing companies, in turn, sell the rights downstream to TV and radio broadcast networks, major corporate sponsors, and other sub-licensees who want to broadcast the matches or promote FIFA ctd. pg. 7

Dakota Weaver, 20, Ragan Road Philadelphia, was charged with Man/Sell/Del/ of SCH. VI.

their brands. According to FIFA, 70 percent of its \$5.7 billion in total revenues between 2011 and 2014 was attributable to the sale of TV and marketing rights to the 2014 World Cup.

The indictment alleges that between 1991 and

present, the defendants and their co-conspirators corrupted the enterprise by engaging in various criminal activities. Two generations of soccer officials abused their positions of trust for personal gain, frequently through alliances with sports marketing executives who shut out competitors and kept highly lucrative contracts for themselves through the systematic payment of bribes and kickbacks.

The investigation was carried out by the FBI's New York Field Office specifically the Eurasian Joint Organized Crime Squad—in partnership with the Internal Revenue Service's Criminal Investigation Division and a variety of international partners.

The wide-ranging corruption at FIFA, said Lynch, "has profoundly harmed a multitude of victims, from the youth

leagues and developing countries that should benefit from the revenue generated by the commercial rights these organizations hold, to the fans at home and throughout the world whose support for the game makes those rights valuable. Today's action,"
