Jacqueline Stanfill indicted for fraud and money laundering charges

Jacqueline J. Stanfill, 58, of Knoxville, Tenn., was arrested today in Knoxville by agents of the Federal Bureau of Investigation (FBI) and the Internal Revenue Service (IRS). Trial was set for September 30, 2015, before the Honorable Leon Jordan, Senior U.S. District Court Judge.

In July 2015, a federal grand jury returned a six-count indictment (see Stanfill pg. 5)

International Parental Kidnapping Case

Partnerships, Publicity Key to 9-Year-Old's Rescue

When 9-year-old Billy Hanson didn't return to Pennsylvania after spending the summer with his father in Seattle, the boy's mother called her local police department, setting in motion an international kidnapping investigation that led FBI agents halfway around the world to a tiny island in the South Pacific.

What would eventually bring the case to a successful conclusion was the extraordinary collaboration between local, federal, and international law enforcement and other agencies. But on that September day in 2014 when Billy was not on the flight he was supposed to be on, his mother "was obviously very concerned," said Special

Agent Carolyn Woodbury, who led the investigation from the FBI's Seattle Division.

Johanna Hanson had agreed to let her son spend that July and August living with his father, Jeff Hanson, aboard a 30-foot sailboat named the Draco. But after Billy arrived in Washington, she began receiving text messages from her estranged husband suggesting that Billy would not be returning in the fall—a clear violation of their court-approved custody agreement.

Johanna called the Hazelton Pennsylvania Police Department, who, in turn, contacted the Port of Seattle Police Department. In August, a welfare check was conducted, which showed that Billy and his father were on the boat in Seattle, and all seemed to be well. A week later, however, the airplane ticket Billy's grandfather had purchased for his return to the East Coast was never used—and the Draco was nowhere to be found.

The FBI-led Seattle Safe Streets Task Force, which includes the Seattle Police Department and other law enforcement agencies, was called for assistance. Task force members who went to the marina and elsewhere to conduct interviews learned that 46-year-old Jeff Hanson had given away some

of his personal belongings, that he had previously sailed the Draco around the world, and—most significantly—that he had a six-day head start on investigators. In other words, he was likely on the open sea and could be headed anywhere. Investigators also learned another troubling fact, Woodbury said: "We were told that Billy didn't know how to swim."

On September 12, 2014, a federal warrant was issued for Jeff Hanson, and Woodbury

and task force members worked quickly to "get the word out" about the kidnapping. FBI offices up and down the West Coast were alerted, along with the National Center for Missing & Exploited Children. The Coast Guard and U.S. Navy were notified, and hourly announcements about the kidnapping were made on maritime radio channels. In addition, the FBI's investigative publicity team distributed posters online

and on social media networks showing pictures of Billy, his father, and the Draco.

"Our investigation suggested that Jeff Hanson would likely sail either to Mexico, South America, or the South Pacific," Woodbury said. The FBI's legal attaché offices—known as legats—were contacted, and in Australia, Legat Canberra disseminated fliers and other information to the Pacific

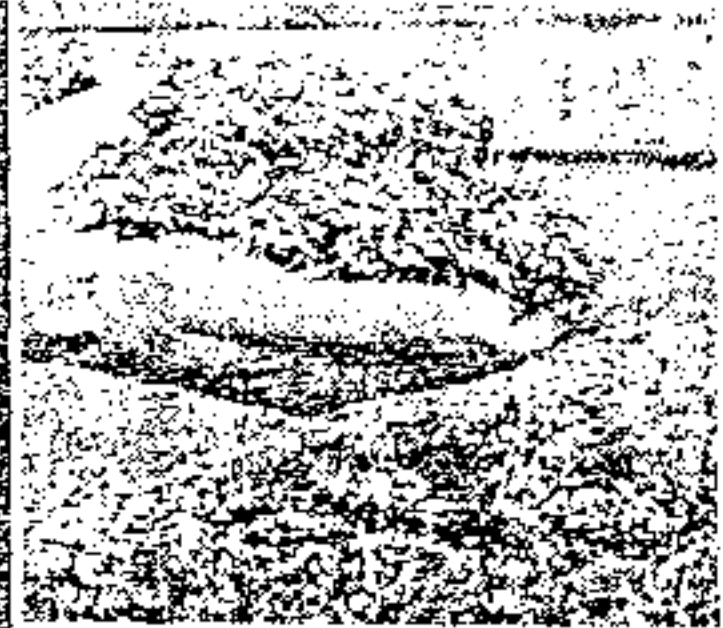

Winning Tips on Playing in a Poker Tournament (Online or Live)

How to Develop Your Poker Tournament Strategies

The only way to acquire a winning poker tournament strategy is to create a plan, stick to it, and practice it in places that don't cost you much money. To become an excellent player, and maybe make the final table (live or online), you must have a solid game and play within your capabilities. A tournament is no different from any other poker environment, but like any competition your ability to concentrate and willingness to remain on plan will be tested.

If you want to develop these playing skills and strategies then playing online, in small money tournaments that still allow you to make some-

thing while you invest in honing your skills and play, is a good way to go.

Online Multi-Table Tournaments:

If you want to get a lot of action and therefore more opportunities to practice your game, then Multi-Table play is a good option.

Multi-Table tournaments can be very useful in building your skills and grasp of the game. Most online sites have a low entry fee, some for about \$1.25 with the winning prize around \$17. This is a great environment for practicing your poker tournament strategy without a huge bankroll.

Sit and Go Tournaments:

What is the major divergence in this type of game and the multi-table game? This style of tournament is more like a Final Table, whereas in a Multi-Table environment if a player goes bust their position can be replaced by another player. So just like a final table someone from another table, with a much larger stack, will not be moving to your table. In every other way your moves should be the same as your poker strategy dictates, which should take into account your stack, your position, and players, and of

against Stanfill alleging wire fraud, mail fraud and money laundering. According to the indictment, which is on file with the U.S. District Court Clerk, she allegedly defrauded individuals by inducing them to provide her with funds for investment with Charles Schwab and Co. Instead of investing the funds with Schwab, she converted the money to

her own personal use. Stanfill was the owner and operator of Stanfill Wealth Management in Knoxville.

The investigation, which led to the indictment of Stanfill, was conducted by the FBI and IRS. Assistant U.S. Attorney Frank Dale represents the United States.

Members of the public are reminded that these are only charges and that every person is

presumed innocent until his or her guilt has been proven beyond a reasonable doubt.

course your cards. Tight play in early position and loose later is the best play, so avoid what many do, which is to play very loose early when little is on the line, and then play tighter when you could be in the money.

If you are the Short-Stack: Play a tight game and

look for an opportunity to come. When you get a good quality hand then get behind it completely. If you have a middle stack you should also play a conservative game, but when you get the premium cards play you have been waiting for then don't be timid.

If you have the large stack:

In this case you should be aggressive in your betting against short or medium stacks. Neither wants to take you on, and this is a good time to steal blinds

and antes.

Some thoughts on making it to the Final Table:

If you are only a few players away from the final table play tighter since the payouts are much bigger if you make it to the Final Table.

Knowing this, of course will have the big stacks trying to shove you around. You can use this to your benefit when up against other short or medium stacks, who fear getting eliminated. If you end up heads up for the tournament then don't forget that pot odds favor good starter cards, and the chance of drawing a hand rare.

Are Limit Tournaments different from No-Limit?

If a player usually plays in no-limit games they are used to the aggressive play, but have to modify their tactics some. With a limit it is harder to bluff and steal pots, since their entire stack is not at risk. If you have a good hand then be aggressive and play it with conviction.

General Thoughts:

Stay with your strategy and build your bankroll by playing quality cards. Be patient and don't try to force play. When you get a high quality hand you should push it. When you have a really good hand and the pot odds are in your favor don't overplay it and eliminate everyone too early. Many amateur players poker tournament strategies include playing very loose early in a tournament, so instead of following them, use it to against them. Instead of trying to steal the pots, call raises, and re-raise more often. Hopefully they will exit early and allow you to build your stack quietly. Later your opponents will tighten up their play and then you should adjust again and do the opposite.

Remember, the more you practice your strategy, the luckier you will become!

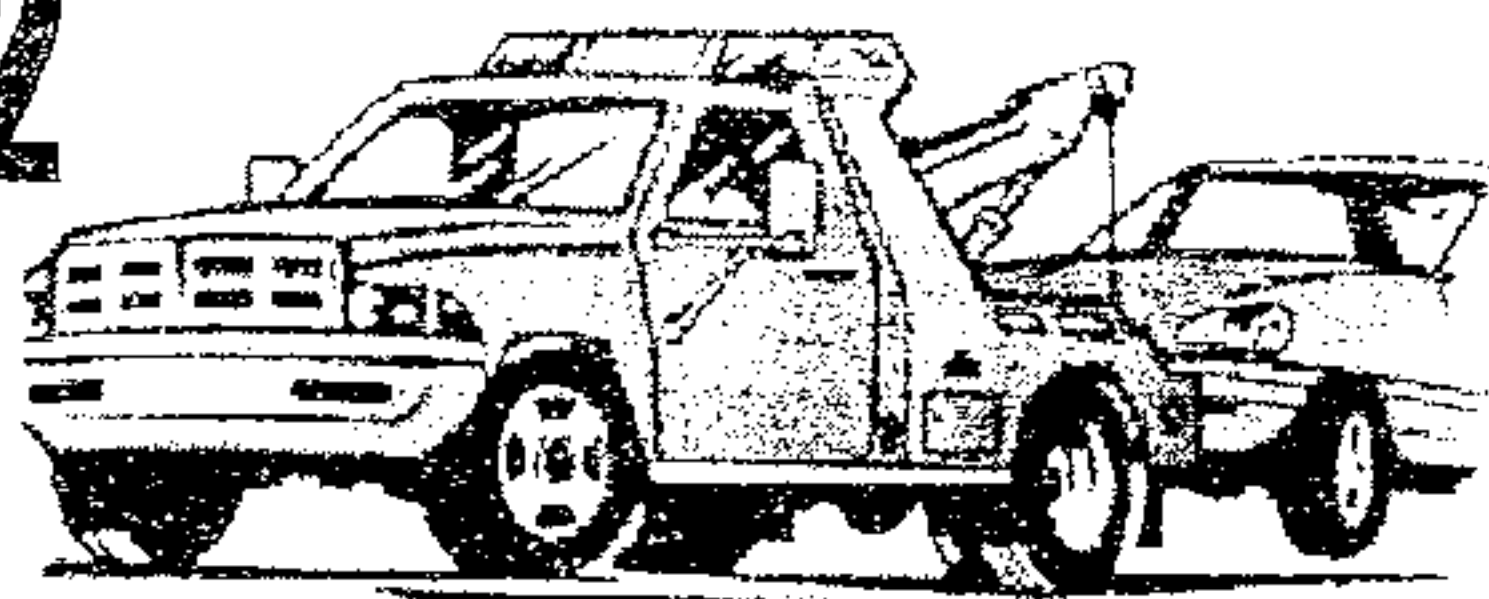

Loudon County Narcotics Unit assisted

by the Loudon County Sheriff's Office CID, and K-9 units conduct a search Warrant at the residence of Ivan Melian on Riverview Road. When Officers made entry into the front door of the residence Ivan attempted to flee out the back door. When Ivan exited the back door he

was met by Investigator Shane Ezell. Inv. Ezell did observe a baggie of crack cocaine in the right hand of Ivan. Ivan then turned and ran back inside the residence, and into a small bathroom just inside the door. Ezell followed Ivan into the bathroom and found Ivan bent

over the toilet attempting to flush the baggie of crack cocaine.

After Ivan was secure the bathroom and immediate area was searched. The baggie Ezell saw was not found. A small baggie containing 1/2 gram of crack cocaine was found outside the back door on the ground next to the porch. Approx. \$2000.00 in US cur-

rency was found inside the residence.

Comingled in with the \$2000, was recorded buy money that was used in prior controlled purchases crack from Ivan.

 Transnational Crime Coordination Centre, an organization of police, customs and immigrations, and other agencies whose goal is to gather and share intelligence to stop transnational crime in the South Pacific. Meanwhile, news reports about Billy's kidnapping were being broadcast everywhere.

On October 29, 2014, Legat Canberra reported that Billy and his father had been seen on the remote island nation of Niue, located about 1,500 miles northeast of New Zealand. The island has fewer than 1,200 residents, but a woman recognized Billy and his father from news reports and contacted the local chief of police.

Jeff Hanson was detained on immigration charges, and FBI agents

from Seattle began the long trip to Niue, which is said to be one of the least visited places on the planet. There are only two flights on and off the island per week.

"The irony for Jeff Hanson," said Woodbury, "was that he was immediately recognized in one of the most remote places in the world. For law enforcement," she added, "it illustrates that collaboration and asking for the public's help were the absolute keys to solving this case." Woodbury had particular praise for the international assistance provided by the Niue Police Department, the New Zealand Police, and New Zealand Customs Service.

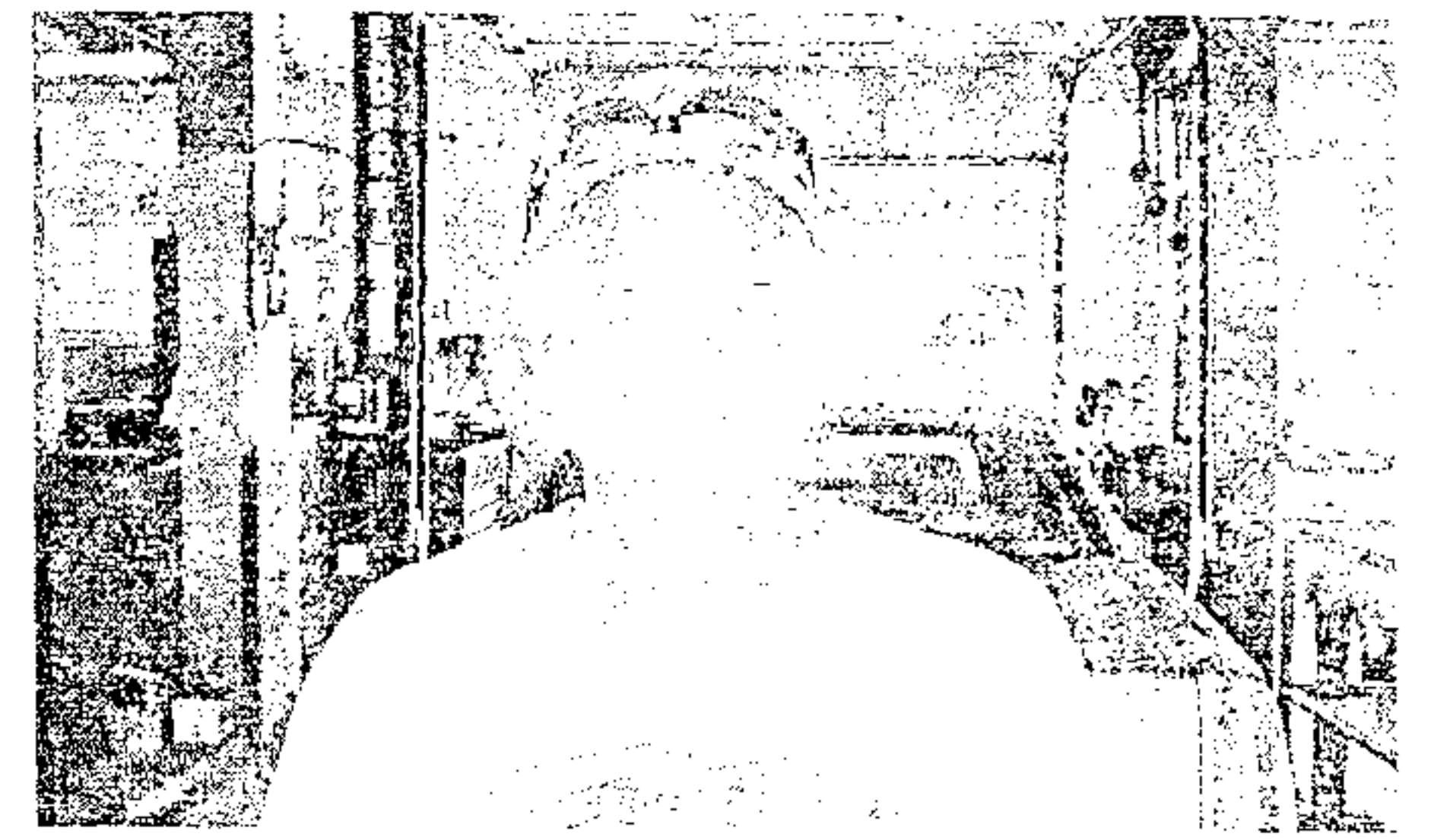
After his harrowing odyssey, Billy was reunited with his mother. "This was no carefree

adventure for him," Woodbury explained. "It was a traumatic experience." Investigators learned that shortly after the Draco left Seattle, the dinghy that carried most of the food and water for the trip was lost at sea. By the time Billy and his father reached Niue after 60 days aboard the Draco, the 9-year-old had lost 30 pounds.

On November 11, Jeff Hanson appeared in federal court in Seattle to face international kidnapping charges. He pled guilty in March 2015 and was sentenced last week to time served, which was about seven months in prison. As for the Draco, which was Hanson's residence, it remains in Niue in dry dock—some 5,500 miles from Seattle—accumulating dock fees.

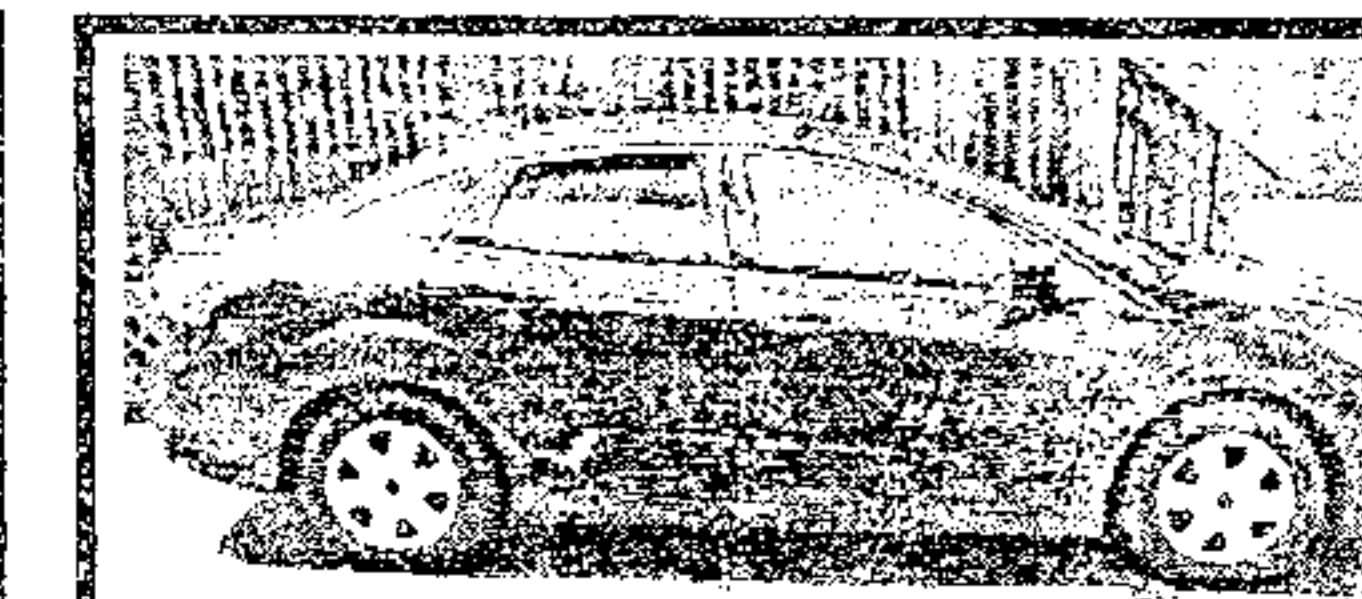
2006 Ford Expedition, 3rd row seat, 155k miles



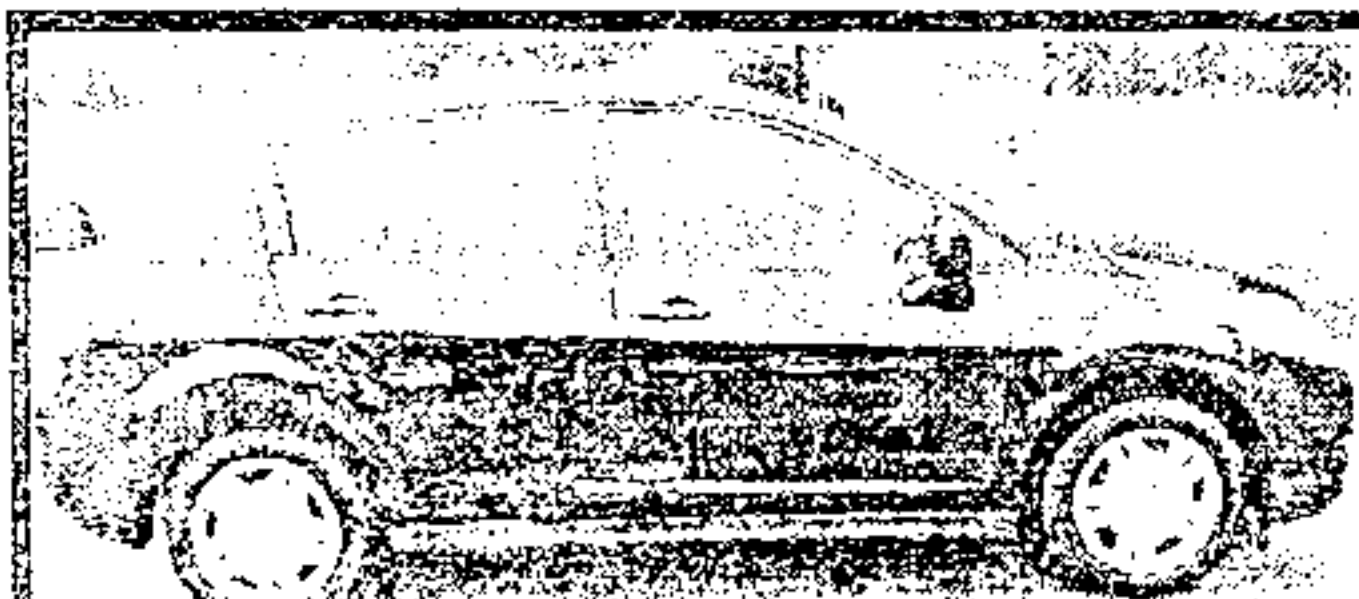

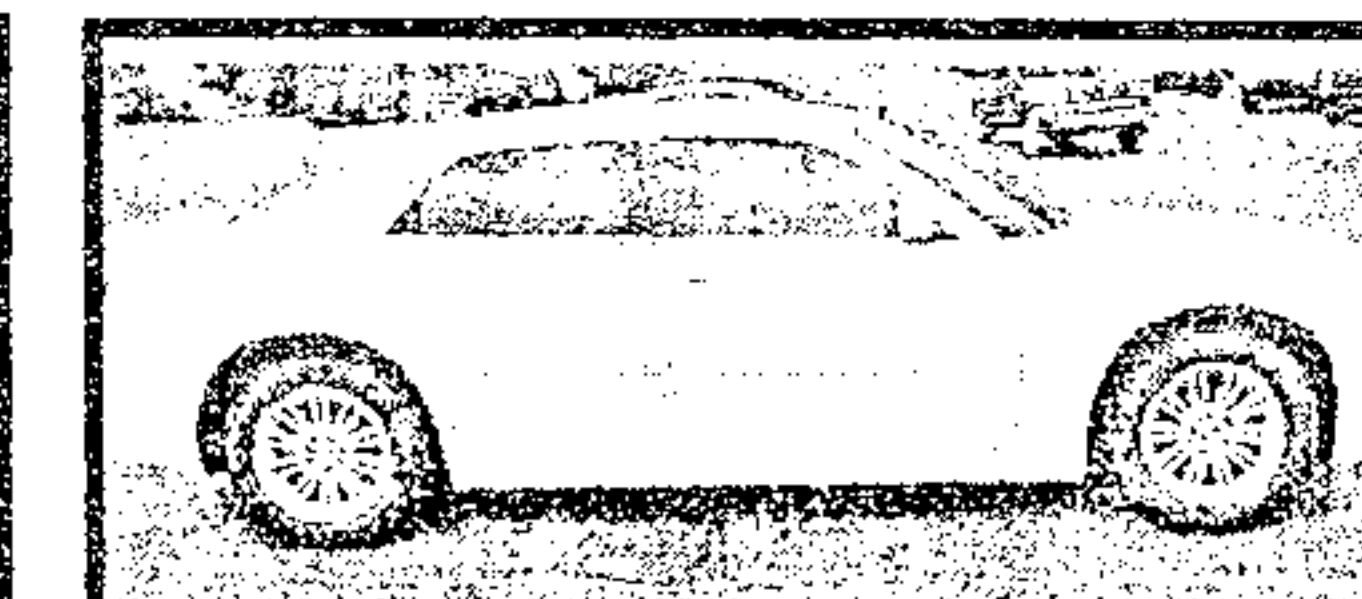
