The information contained in the Loudon County Grand Jury Report is an exact copy of the report received from the Criminal Court Clerk's Office. Any errors, omissions, or typographical errors is not the responsibility of the The Daily Edition.

A true bill means there was enough evidence to allow for a trial by jury. A no bill means there was not enough evidence for a case. A resubmittal is a case that has been presented again to the Grand Jury. A continued on bound over means the case will be presented at a later date. A scheduled to plea by information means the defendant intends to plead to the charges they have been given.

There are also sealed indictment which are not contained on the report. Those indictments are not made public until the suspect has been taken into custody and charged with the indictment.
