### ADDENDUM to the Loudon County Grand Jury Report of April 13, 2015

The Grand Jury heard a summary report from the District Attorney General regarding an investigation predicated by the District Attorney General into allegations of misconduct in the Loudon County Clerk's Office. The allegations were made by a former Clerk's Office employee who had filed a wrongful termination lawsuit against Clerk Darlene Russell. The Tennessee Comptroller's Office, the Tennessee Department of Revenue and the Tennessee Bureau of Investigation all performed separate, but coordinated, investigations into the allegations. All three organizations found no evidence of misconduct and no violations of law.

The Grand Jury accepted the report and determined that no further action was necessary.

The Grand Jury also heard a summary report from the District Attorney General regarding an investigation predicated by the District Attorney General into allegations of misconduct in the Greenback Volunteer Fire Department. The allegations were made anonymously to the Comptroller's Office and were forwarded to the District Attorney General who looked into the matter and determined that there were no violations of criminal law. The District Attorney General had previously provided his office's findings on this matter to the Loudon County Mayor, select members of the Loudon County Commission and the Loudon County Grand Jury Foreman. The findings found that the GVFD had satisfactorily addressed with the assistance of their legal counsel the issues that were raised relative to gasoline expenditures, accounting issues and other matters pertaining to how the GVFD was operating under a tax exempt and not for profit status.

The Grand Jury accepted the report and determined that no further action was necessary.
