driver switched the lights to bright. The officer then backed into the entrance to Loudon Municipal Park to turn around. The vehicle then started accelerating up Roberson Springs Road toward Card-

ing Machine Road driving by two teenage boys who were looking for their dog. The officer then engaged his lights and siren and the vehicle turned his lights off and passed another vehicle on Roberson Springs and ran the stop sign. The vehicle continued down Carding Machine with its lights, just before Hwy 72 the driver turned his headlights on and ran the stop sign on Carding Machine Road onto Hwy 72. The vehicle was traveling down the turn lane and again turned his lights off in front of Food City.

Other officers then joined the chase and the vehicle traveled through the intersection of Hwy 72 and Hwy 11 and passed a car in a curve on a double yellow line. The vehicle continued on Hwy 72 running the red light with a vehicle in the intersection. Officer continued with the vehicle driving in the middle of the road and in the oncoming lane. Just after leaving the city limits the officer was able to read the license plate.

The vehicle continued driving in the middle of the road and in the oncoming traffic lane into Monroe County. As officer approached Hwy 411 again the driver turned his lights off, and just before the intersection of Hwy 72 and Hwy 411 he

turned his lights back on. The driver ran the red light at the intersection of Hwy 72 and Hwy 411 without regard for anyone or himself. There was a vehicle approaching the intersection but was able to stop. The vehicle proceeded straight through the intersection into Woodhaven subdivision, which is a dead end. When officers came to the dead end the vehicle drove off the roadway into the woods approximately 60 yards and the driver jumped out of the vehicle and ran. Officer then heard someone running to their left and then spotted the subject and he tried to hide behind some brush. As officers approached the subject he tossed something from his right hand. 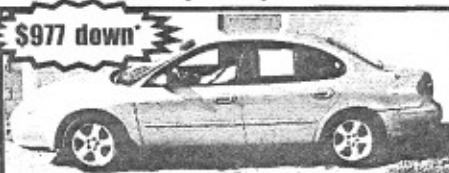

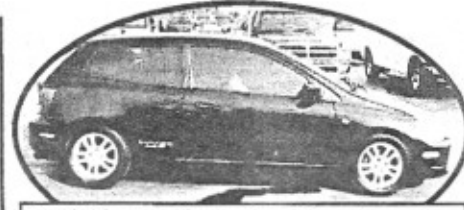
