ro, EMA, THP and a bomb sniffing dog from the Knox. Co. Sheriffs' Dept. were dispatched to the Maremont plant in Loudon in response to a bomb threat that was received at the plant at approx. 10:30 am. The rescuers prohibited traffic

from entering the area along Maremont Dr. while the facility was being searched. According to the police report, Jackie Finger received a call from an unidentified male who reportedly stated "You can take this seriously or not, but in 30 minutes there will be a bomb go off." The

report also states that Mr. Finger immediately notified Maremont plant management and E-911 at which point the emergency workers responded to the scene. The report further states that the emergency responders and the dog brought in from Knox. Co. searched

the plant to no avail.

This incident comes on the heels of an accident that took place the previous day involving a union member that was struck by a security vehicle from the Maremont plant.

The driver of the

vehicle, John Diggs, was arrested at the scene. Mr. Diggs works for a private security service that has been brought into the Maremont plant to provide security during the ongoing labor dispute.

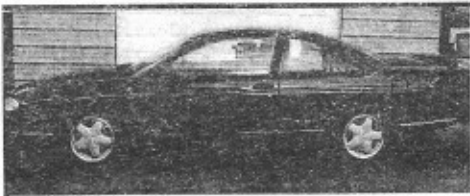

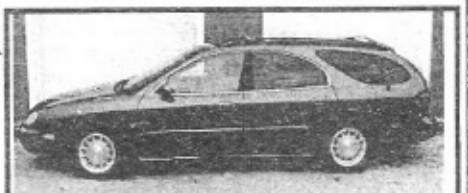

## Record Crowd Expected for Amphibian and Reptile Conservation Meeting

Over 200 scientists and conservationists will converge on Chattanooga, Tennessee for the annual meeting of Southeastern Partners in Amphibian and Reptile Conservation (SE PARC). The meeting will take place at the Tennessee Aquarium February 22-25 and is completely sold out. This will be largest meeting in the history of SE PARC or any of its counterparts in other regions. Attendees will include representatives from universities, government agencies, non-profit organizations,

private industry, and the general public.

Founded nearly a decade ago, PARC is a national coalition with five regional working groups encompassing the entire United States. Dedicated to a collaborative, solution-oriented approach to conservation, PARC describes itself as "an inclusive partnership dedicated to the conservation of the herpetofauna--reptiles and amphibians--and their habitats." The diversity of the membership makes PARC the most comprehensive conser-

vation effort ever undertaken for amphibians and reptiles. Reptiles (alligators, crocodiles, lizards, turtles, the tuatara, and snakes) and amphibians (frogs, toads, salamanders, and caecilians) have suffered from a broad range of human activities, due in part to the perception that these animals are either dangerous or of little environmental or economic value. Conservationists know now that they are important parts of our natural and cultural heritage.

At this year's meeting, SE PARC members will hear talks

from nationally-renowned senior herpetologists such as Whit Gibbons and Paul Moler, as well as young college researchers presenting their ideas for the first time. The talks will focus primarily on three issues: non-native invasive species such as fire ants, new trends in eco-friendly road construction and real estate development, and federally-funded State Wildlife Action Plans. Attendees will then be asked to begin developing the next generation of tools and products related to these issues. Finally, the group will begin identifying issues

for future meetings. Among the topics under consideration for 2008 are forest management, the value of prescribed fire, aquatic habitat quality, and emerging diseases afflicting herpetofauna.

Representatives from Maremont and Local IAM 2545 were scheduled for talks on the labor dispute at 2:00 pm Thursday, the same day of the above mentioned incident. According to union officials those talks were unproductive and no further talks are scheduled. There have been numerous police reports filed with the Loudon Police Dept. for vandalism during the strike, but

no arrests have been made at this time from those incidents. Both sides (Local IAM 2545 and Maremont) maintain that the other is engaging in "acts of intimidation", but the union maintains that no strikers have been involved in any illegal activity and point out that the only arrests that have been made have been against the company's security staff. Maremont has repeatedly refused to make any statements

to reporters from this news agency over the incidents.

The Daily Edition has also learned the security company (APT) hired by Maremont is licensed in Tennessee until May 31, 2008, however Mr. John Diggs is NOT licensed as a security guard, according to the Tennessee Department of Commerce and Insurance. This agency is responsible for maintaining the status of security providers across the state.

The victim of Mr.

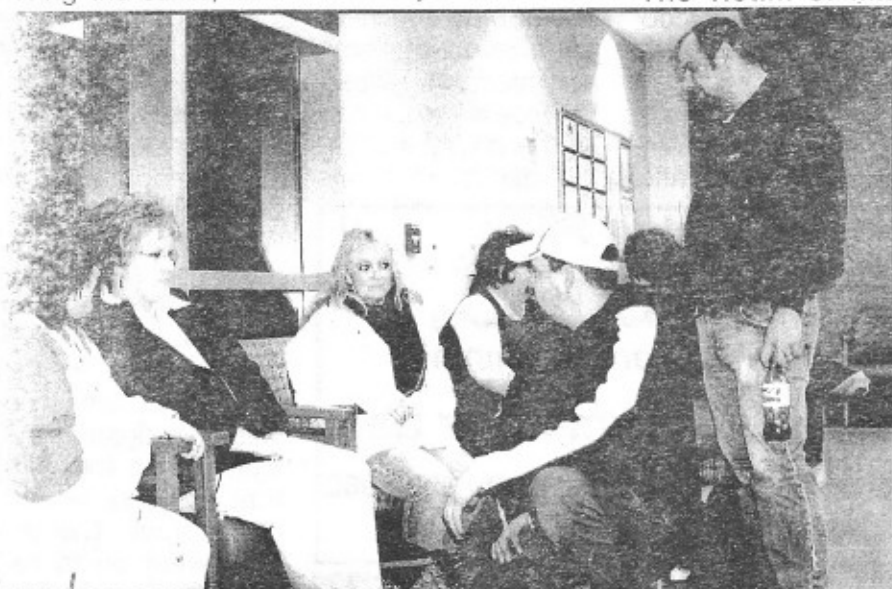
