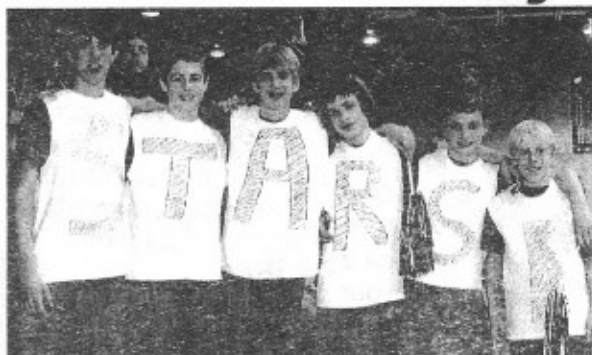

#1 Tori Jenkins and #20 Dawn Radford had been used effectively in the first half defending the Chargers best guard, #34 Mackenzie Campbell, and were able to limit her offensive output. Said coach Jessica Hayworth (C.H.) after the game, "...those two girls (Jenkins, Radford) made it difficult on her (Campbell), and caused some problems with our offense".

In the second half, with chants from the North Nation rockin' the venue, #25 Catherine Hunley bombed in a three to cut the lead down to 4. Unfortunately that was as close as the Lady Stars would get the rest of the way. Colonial Heights opened up a 13 point lead by the end of the 3rd period and led by as many as 15. The Lady Stars However would not go away quietly and kept cutting into the Chargers lead by playing good defensive and making some outstanding hustle plays. The North Nation didn't go away either. With their team down is when they (NMS) picked it up, which in my opinion demonstrated awesome character on their part.

In the end the Lady Stars just came up a little bit short this year. Having to foul late in the game allowed the

Lady Chargers some easy points from the charity stripe and the Lady Stars went down swinging by a score of 46-30.

## CASE

Judge Sharon G. Lee, will preside over the three-judge panel, which also includes Court of Appeals Judges Charles D. Susano Jr. and D. Michael Swiney. The 250 students and their teachers from Sequoyah High School, Tellico Plains High School and Sweetwater High School will hear oral arguments beginning at 10 a.m. at Sequoyah High School in Madisonville.

"The CASE Project, which is an acronym for Court of Appeals Affecting Student Education, gives young Tennesseans an opportunity to see first-hand how the court system operates at the appellate

level," Lee said. "It is designed to educate them about the judicial branch of government in a manner that will interest them because it involves actual cases and real life legal issues."

As part of the CASE Project, local lawyers will go to the schools the morning of oral argument to brief the students about the appellate process and the cases the Court will be hearing. The lawyers will also be at Sequoyah High School following oral argument to talk to students and answer questions. When the cases are decided by the court, in three to six weeks, copies of

the written opinions will be furnished to the students, and law clerks who work for the appellate judges will visit the high schools to answer questions and explain the court's decisions.

Issues in the cases include a claim by a woman seeking to recover uninsured mo-

torist benefits from her insurance company, which refuses to pay because she has already received a worker's compensation award for her injuries; a claim that a medical center failed to diagnose a man's hearing loss for nearly a decade; and a dispute over the divi-

sion of property in a divorce case.

In addition to attending the court session, students and teachers will join the court, local judges, legislators, and attorneys for lunch.

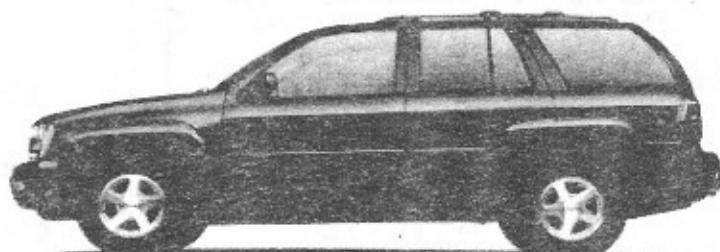
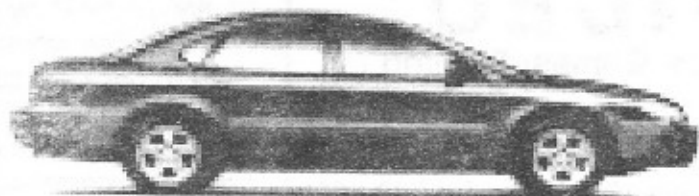
