

#### Stabbed

and Jeffery Lynn of Maryville who advised they had met Mr. Lynn's ex-wife April Sloan at the market and a dispute erupted when he refused to sign an insurance card for the child.

Sloan's current husband, Vernon, reportedly also was present and is accused of butting against the other man's chest before a physical altercation broke out between the two.

Mrs. Lynn reported she tried to get Mr. Sloan off her husband's back and April Sloan then began stabbing her with a green, silver and black pen.

The officer wrote, "The assailant stabbed the complainant three times. Stabbed her once on the top, left side of her head, stabbed her in near her left eye. and also stabbed her in left side near her rib cage. All three stab wounds were complete puncture wounds."

Lynn was treated at Blount Memorial Hospital for the stab wounds.

Additional records indicate Vernon Sloan filed a police report in connection with the assault as well.

Deputy Steve Helm, LCSD, noted Mr. Sloan said his wife's ex-husband had assaulted him during the custody exchange. Sloan did

have a small bump and red mark behind his left ear and a small scratch on his right shoulder and lower neck area.

April Sloan also filed a report in which she alleged her exhusband's wife assaulted her. The officer noted she did have small red marks and scratches on her face and neck.

#### Honored

as they watched a brother-in-arms make the ultimate sacrifice.

Deputy Jason Scott had just started his day three years ago March 12, when the call came in that would destroy two families and change Loudon County forever. A dispute between a mother and her teenaged son prompted the domestic violence call that would soon lead to Scott's death and a two day standoff that ended with the een's suicide.

After Scott was morally wounded, officers who had converged at the scene franticalty tried to find a way to get to their fallen comrade amidst a hail at bullets and flying

shrapnel. Unable to tell if the young officer had survived the bullets that had slammed into him as he exited his patrol car, lawmen desperately tried to reach Scott and were successful when several bullet proof vests were draped on a patrol unit, giving them enough protection to retrieve the young man. Unfortunately, the bullets had found their mark and the father-to-be was gone.

The ordeal, however, was far from finished. Officers still had a job to do.

As the morning stretched into hours, then days, lawmen from surrounding agencies huddled behind wood piles and in other nooks and crannies as the distraught

teen rained down a hail of bullets from the windows of his home, resulting in the wounding of several officers.

Officials desperately sought ways to negotiate with the teen, however, once the silence settled, and the smoke and the dust dissipated, police were left with the harsh reality of the teen's suicide.

The scene was every law enforcement officer's nightmare come true, but they didn't flinch, nor did they shirk their duties and on Monday were honored for their courage.

Billy Hall, LCSD, Greg Gass, Patrick Lawson, and Les Mullins, all from KCSO were all awarded a Purple Heart, which is awarded when wounds are received.

The Medal of Valor, which is awarded for extreme bravery beyond the call of duty, was awarded to Loudon County Sheriff's officers Chad Estes, Tony Arden, Billy Hall, Érnie Brown, James Massengill, Emory Matthews, Adam Yoklev. and Bobby Hamilton; LCPD officers Jack Fine, Gillis Morgan, and Eddie Range; and LPD's Sam Harrison, Bobby Lankford and Darian Goodman. Knox County officers who received the award included Dr. Russ Frazier, Sam Hardy, Patrick Lawson, Gabe Mullinax, Todd Sleet, and Roger Sexton. A Medal of Valor also was awarded to THP's Mike Melhorn and the Knox

County Aviation Unit received special recognition for it's role in the standoff.

The ceremony was held by the Knox County Sheriff's Office and Loudon County had a separate remembrance service at the Loudon County Justice Center earlier in the morning. Scott's widow Jonie and now three-year-old daughter, Jayden attended.

Jayden, born 11 days after Scott's death, is a living legacy of the young officer, and is a testament to the truth that even in the despair of loss, new life brings hope and the will to carry

### Letter to the Editor

Principal responds to bomb threat

Parents.

I know there are many rumors about what took place yesterday, and I feel it is important for you to have a firm understanding of what happened and how we handled it. I will limit some of the explanations of our safety procedures because that secured knowledge would jeopardize future responses.

At approximately 1:15 p.m., I received notification from my School Resource Officer that graffiti had

been recorded on the wall, in one of our 5th/ 6th grade bathrooms. We try very hard to keep all writings off the wall and have it removed as soon as it is reported. However, this particular graffiti made reference to an individual having a gun and bomb in our school, and he was going to start by killing the principal. A quick analysis of the evidence led us to immediately evacuate the facility. We did this in the from of a fire drill, so that we





did not create widespread panic and chaos. Once all students were removed and accounted for, they were taken to the soccer field and the campus was locked down and surrounded by police officers to protect our students and faculty, due to their close proximity, Eaton Elementary School also locked down in order to maintain a comfortable and secure environment. All backpacks nd personal items were left in the classrooms. Specialized dogs ere brought in from Knox County to search our building for any device or weapon that could be injurious to our school community This was a very time consuming process, which resulted in an extended school day that became an inconvenience for every household. While the search was being conducted, specialized police officers conducted an investigation to determine the source. The building was clean, and the evidence has led us to believe that this was nothing more than an inappropriate prank. We will spend the necessary time with investigators to identify the

source and prosecute that source to the full extent of the law.

I want to assure you that al of our decisions were based on the health and safety of your children and will never apologize for any minor inconvenience that may result in that effort. I really appreciate the words of support that many of you shared with us during this stressful event and assure you that your children are in a safe school! As in most crisis situations. you reflect on things you could have done better, but overall, I am very proud of our faculty and staff for the way they handled these procedures. If you have concerns that you would like to discuss, please schedule an appointment, so we can answer questions you may have.
