District Attorney General announces Loudon County Grand Jury Action for April Meeting

District Attorney General Russell Johnson and staff appeared in Loudon County Criminal Court Monday for arraignments of fifty-four individuals indicted by the Grand Jury on cases presented to them by the District Attorney last Monday and Tuesday. The majority of the cases indicted included DUI and rug related offenses. There were several robbery indictments as well as assault and child abuse

cases.

During the two day presentation of cases Johnson submitted to the Grand Jury the recent LCUB Investigative Audit results. He did so with the assistance of Fraud Auditor Phillip Job and State's Attorney Bill Bright, who Johnson called in as a special prosecutor on the issue of the LCUB/Dixie-Lee merger. Bright explained, as Johnson had opined in an earlier press

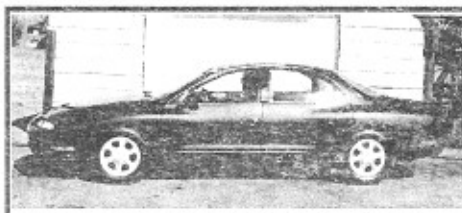

nial check was presented to Sheriff Tim Guider and LCECD Director Jennifer Estes at the Police Department office in Loudon.

"I am delighted that Loudon County has received these funds to construct a new emergency call center," said Duncan. "Coordination and quick response times are critical when dealing with emergency situations and this new E-911 Center will help insure that the safety of our citizens is the first priority."

Federal funding of \$1.5 comes in the form of a low-interest Rural Development community facilities loan. The Loudon County contribution of an additional \$140,000 brings the total investment to \$1,640,000. The federal investment is part of USDA Rural development's First Responder Initiative to help rural communities make needed improvements in the coordination of first responder services following the events of September 11, 2001.

The funds will be used to construct a new 3,000 sq. ft. secure facility of reinforced masonry and brick

on three acres leased from the Loudon Utilities Board in Loudon. The LCECD is currently located in an older modular home in a high traffic area adjacent to the courthouse in Lenoir City which does not provide adequate space for the staff and equipment necessary to meet the need for services. Additionally, the new facilities will provide a more secure environment free from unnecessary distractions. LCECD serves all of Loudon County, which has a total of just over 39,000.

Estes also announced that the road leading to the new facility will be named John Parris Drive in honor of the LCECD's first chairman and long-time advocate for improved first responder coordination, the late John Parris. The new building's street number will be 500, Parris's radio call num-

ber. Parris's wife, Wanda "Tootie" Parris was in attendance.

"The health and safety of people in rural communities can depend on a timely response to emergency calls whether it

be in times of natural disasters like tornados or some man-made crisis," said Tackett. "Mr. Parris had a mission and Congressman Duncan, Mayor Arp, Sheriff Guider and the other Loudon County leaders here with us today are doing a great thing by fulfilling his mission to deliver the best possible first-responder services to the people of Loudon County."

Rural Development's community facilities program provides rural communities with financial resources needed to construct or improve essential services. Education, health care, assisted living and civic facilities, along with local government building for police and fire protection are examples of projects typically funded through this program. Community Facilities funding targets

rural areas with a population less than 20,000.

USDA Rural development is committed to the future of rural communities in Tennessee by providing financial and technical assistance through housing, community and business development programs. In Fiscal Year 2006 Rural development assisted more than 467,575 Tennessee families and businesses with more than \$288 million in financial assistance through loans and grants.

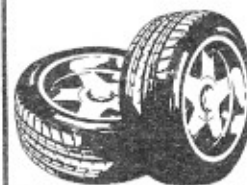
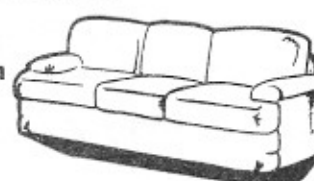

release, that since the activity occurred in late 2000-early-2001 bringing about the merger, any prosecution for official misconduct was barred by a two year statute of limitations for such charges.

Johnson's reason for presenting the audit was to "allow a jury of twelve grand jurors and their foreman to read the audit findings and listen to

the testimony of the auditor and attorney who were involved in the actual process; then for them to give me their feelings about the situation so I would have an idea in what direction to proceed, if any." Johnson added, "the Grand Jury is a good forum to vet the types of issues raised in the audit since in order to prosecute any criminal case my office has to convince twelve similar individuals beyond a reasonable doubt that a crime has been committed and the person being charged committed the crime."

The same was done with the "Litter Grant Monitor Review" that Johnson presented to the Grand Jury at the request of Mayor Doyle Arp. Johnson did not prepare a proposed indictment for the Grand Jury to consider. Instead he wanted to get the opinion of the Grand Jury on those issues as well. "With twelve or thirteen people you are going to have that many shades of gray as far as ideas and opinions go. Before

I prosecute any case we need at least twelve opinions of dark, dark gray - if not black." As a result of the presentation, Johnson has "predicated" the matter to TBI for further investigation.

One other action that Johnson asked the Grand Jury to recommend to Criminal Court Judge E. Eugene Eblen was that the Grand Jury members stay the same for one year so that at all three meetings (April, August and December) there will be some continuity of membership when issues like the audits arise. "It would save time in the empaneling of the members as well as the re-education or re-acquainting process the Clerk, foreman and myself go through each time a new Grand Jury is selected," Johnson stated. "It would be perfect for revisiting issues like these two audits because we do not have to reinvent the wheel each time. I think that Criminal Court Clerk Lisa Niles is in favor of the idea as well and the fore-

man made it part of his report."

In further business when Johnson took over as District Attorney September 1st approximately 300 cases had accumulated on the "Continued on Bound Over" docket, meaning cases that had either been bound over or waived from General Sessions Court, but never presented by

the previous DA to the Grand Jury for indictment. Since his first presentation of cases to the Loudon County Grand Jury in December Johnson and his staff have focused attention on disposing of these cases by obtaining convictions through plea agreements, indicting a larger number of the cases or dismissing

ones where defendants or victim/witnesses have died, prosecuting officers are no longer in law enforcement or evidence did not exist to obtain a conviction.

Johnson stated that "a number of the cases were as old as 2002 and 2003 and just sitting there where they

were backlogging the judicial system for our office, the Judge and the Clerk. We have reduced the number from almost 300 to about 100 and hope to have those disposed of by or during the August Grand Jury when we can get them ready for presentment. This will go a long way towards moving

the judicial system in Loudon County forward in a timely manner." Also, Johnson personally thanked Clerk Lisa Niles and her staff, especially Debbie Hart, for their help in preparing for and concluding the Grand Jury process.

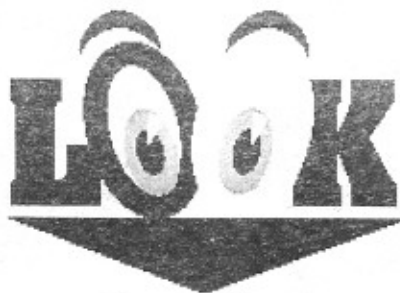

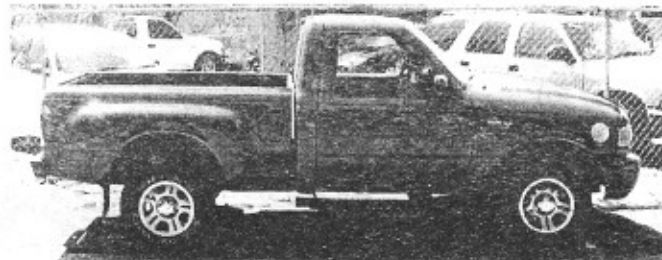
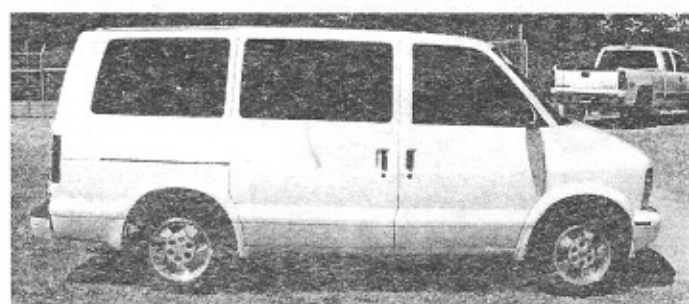
