Deputy Chad Petty, LCSD made the arrest at the Knox County Detention Facility.

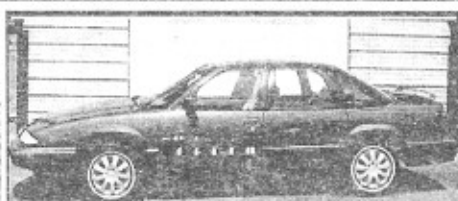
