

E85 contains 85 percent ethanol, a renewable fuel made from corn or other crops, so it burns cleaner. Ethanol, or ethyl alcohol, helps reduce air pollution, is biodegradable and does not pollute groundwater.

The E85 pump is at the Rilot convenience store located at 205 Walker Springs Rd. at the Walker Springs Road Exit 379, just off the fueling location designated by the see a Tennessee Casaa Island Biofuel Langer.

All major auto manufacturers selling cars in the U.S. approve fuels enriched with up to 10 percent ethanol. Many manufacturers even recommend ethanol for use because of its clean-burning benefits.

"Ethanol is actually good for your car," said Alan Wright, vice president of supply and distribution for Pilot. "Millions of miles and years of testing prove that ethanol-enriched fuel enhances performance of today's engines by burning cooler and cleaner."

Wright said that Pilot plans to sell E85 at a lower price than other fuel the company sells. He added that E85 can only be used in Flexible Fuel Vehicles (FFV's), of which there are more than 6 million on the road today. have been making E85 cars since 1992. Doing so earns them special credits toward government fuel-efficiency standards.

Pure ethanol contains 35 percent oxygen and is known as an "oxygenate" when added to fuel. Oxygenates are added to motor vehicle fuels to make them burn more cleanly, thereby reducing toxic tailpipe pollution, particularly carbon monoxide. Oxygenates also extend the fuel supply.
