



The Loudon County Sheriff's Department Narcotics Unit assisted by the patrol division, served a search warrant at the home of Justin Palmer Blevins located on Queener Road. - Skirts and skorts must extend below the fingertip level when arms are down.
 - 2. NO SHORTS.
- All pants must be worn at waist level.
 No sagging or low riding.
- 4. Any undershirts or tank tops must be worn with another "cover-up" shirt.

Shoulders, backs, chests and midriffs must be covered.

- 5. No see-through type or suggestive clothing is to be worn. Undergarments must not be visible.
- All shirts, including athletic jerseys,
 with the exception of sweaters, sweatshirts or vests must be tucked in pants or skirts.
- 7. Shoes or sneakers must be worn at all times. No flip-flops or house shoes (slippers)

are permitted.

- 8. No head-coverings such as bandannas, "do-rags," scarves, sweatbands, hair nets, hats or caps are to be worn or visible in the courtroom. Hoods on lightweight garments or sweatshirts may no be pulled over the head. Sunglasses shall be removed and stored out of sight.
- 9. No clothing which advertises drugs, alcohol, or tobacco, or displays inappropriate/offensive language (sex, profanity, racial or ethnic slurs, gang-related attire, etc.) may be worn. Tattoos which display drugs, sex, alcohol, or tobacco products must not be visible at any time.

10. Clothing which has been intentionally torn in inappropriate
