

now as it was then. The only difference I could see was that I seemed to have spent most of my time on asphalt, so I think the people who say the fair is the same size, that it's just been moved, are right. All the big, heavy attractions requiring grounding rods, etc... are all on asphalt now, so maybe the fair has been shifted to protect the grounds and is just as big. Like I said, it's been 16 years.

At \$20 and \$22 (weekend rate) the wrist bands are the way to go. We did not need one ticket (\$1 each) for any attraction we visited. We rode the Cyclops, Cliff Hanger, Ring of Fire, Mega Drop, the Himalayan, Zipper, Hammer, Tilt-A-Whirl, the Seattle Wheel, Ferris Wheel, Sizzler, Gravitron (which felt like a Jiffy Pop popcorn pan at 2:45 in the afternoon), the Pirate Ship, Black Widow, the swing and several others that I can't remember the names of.

We went through the Zombie ("haunted house"), Mardi Gras (funhouse), and the King's Tower, which was a really cool moving funhouse. We visited the petting zoo, the birthing center, and the farm animal tent. I also got to see my first tractor & truck pull. And we got to do all of that and more with just the arm band. Most of these attractions required 3 to 5 tickets, except for the freebies like the exhibits, which included the birthing center, the livestock, the 4-H & FFA exhibits, etc...

The food and drinks were a little on the ex-

pensive side. Bottled water - \$2, soft drinks-\$2.75 to \$6, cotton candy-\$3 or \$7 jumbo. popcorn- \$2, funnel cakes- \$5 & up, burgers, dogs, etc. average of \$5, smoked turkey legs- \$6 to \$8, Gatorade-\$3. There were offerings of giant corn dogs, chicken on a stick, kabobs, Chinese food, Philippine food and a place that grilled steak, sausage, chicken, pork and more. In checking prices on passing the two figures I saw the most for the meal-type fare was \$6 and \$8 dollars. We ended up having only popcorn and drinks because we were determined to ride all the rides (we almost did) and our stomachs rejected the thought of food. By the time were done spinning and twirling in the beating sun and baking asphalt it was time for more drinks and to head towards the arena for the tractor/truck pull. Once there for 2 1/2 hours, we headed back to the fairgrounds and by then everything food wise was starting to smell like heartburn. It also seemed like everyone decided to come to fair while we were gone. Granted, there were a lot of people about before the 7:00 p.m. show, but afterwards there were hundreds; the crowd was almost elbow to elbow. Pre-show, there were no lines. post show, forget it. We passed on a few rides we didn't get to ride earlier simply because the lines were just way too long.

More drinks in hand (ice water for me- \$1 with initial purchase of \$5 cup with 1/2 price refills) we saw the world's smallest horse-\$1, the snake woman-\$1 and the world's smallest woman-\$1. We rerode our favorite rides (if the lines weren't too long)

There was all kinds of things to buy; you could have your digital photo in one minute, or put on tee shirts, caps, posters, key chains, license plates, etc... You could get jewelry, your caricature drawn, feather boas, plastics swords, bats, toys, and all manner of trinkets that glittered and sparkled.

We also played a game or two throughout the day and they seemed to be outrageously expensive. Most of the games we saw offered 3 to 4 price levels. I played one where you had to put a metal ring around a turning metal coil mounted on a wizard whose hat would light up if you touched the metal ring to the metal coil. You got 1 try for \$3, 3 tries for \$5 and something like 5 tries for \$8. And those guys are good at what they do, so very good... In the space of two minutes flat I bought 3 tries, was given a deal on more tries for

just a few more dollars

because I had already bought the first offer, so for x-many more dollars I got more tries, and then it was, "Here let me show you..." So, of course, after showing me how easy it was and giving me the tip about the mustache, I got a deal on even more tries and before I knew it 3/4 of my \$20 bill was gone. Two minutes flat. That is why I don't play games at the fair. The only "game" I'm good at is the guessing game. For \$3 the guy guesses your age, weight or birth month within so many years, pounds, or months. always have them guess my weight. I always win. Now I have a stuffed raccoon that

loves me. My son played the basketball games a time or two. 1 ball-\$2, or 3 balls for \$5. He also played the strongman game, 1 swing- \$2, or 3 swings- \$5 and he bought 8 balls- \$5 for the dunking booth with the insulting clown in That guy was funny he'd heckle you until you wanted to give him your money just to try to dunk him. And then when you did dunk him he'd laugh at you and remind you it was over 90 degrees out.

In passing other

game prices seemed to be about the same: \$2s, \$3s, \$5s & \$8s. At one of the dart game booths you got 1 dart for \$3 and 3 for \$5. We didn't play but we did talk to the man running it and learned that to win the large stuffed tiger you had to hit 104 balloons in a row. Do the math on that one! They also had a rope ladder game, ring toss, several shooting galleries, and many others.

We didn't have little ones with us, so we didn't really check out the kiddie side of the fair, but from what I did see there seemed to be a lot of things for tykes to do. There appeared to be numerous rides including a small roller coaster, and carousels, and several games which included a "fish till you win" game. There was a whole kids section so your youngsters should have a good time too.

We had walked in the gates at 2:16 p.m. and walked out for the last time at 11:52 p.m. Even though we didn't get to do everything we wanted to do, it was a full day packed with fun, thrills and adventure. And I had all day Sunday to re-

cuperate.


