On Tuesday, September 25th, students at North Middle School were evacuated when a leak in an air-conditioning unit, being worked on by maintenance personnel, ruptured releasing Freon into several fifth grade classrooms.

The Freon gas, used as a coolant, was thick enough to cause what school officials described as a "visible fog" in the classroom and the adjacent hallway, which prompted officials to evacuate the facility.

Students were removed from the classrooms and initially taken outside on the school grounds until school administrators and emergency personnel had an opportunity to assess the situation and any potential danger that the rupture posed to the students and the structure.

The students were evacuated to Central United Methodist Church after church administrators offered the use of their facilities to the students. Students were given pizza and water and a cool place out of the sun until parents were able to arrive and pick them up.

Approximately 90-100 students, in four classrooms that were in close proximity to the leak, were transported via school bus to Ft. Sanders Loudon and Park West Medical Centers to be examined by medical personnel as a precautionary measure.

LCSD Sheriff Tim

Guider stated, "No injuries or illnesses have been reported at this time. We, (officials), just wanted to make sure that the children were alright."

In a cooperative effort between school administrators, Loudon County Emergency Management Agency, Rural Metro EMS, Loudon County Sheriff's Office, Lenoir City Fire Department and the Loudon County Fire and Rescue, the facility was ventilated and cleaned before Wednesday's classes were scheduled to begin.

The maintenance Dept. for the Loudon Co. School system made repairs to the damaged gas line and repaired the airconditioning unit that services the classroom.
