Lenoir City head coach White said before the game, "We're gonna' have to depend on our depth and how physical we play in order to be successful." Unfortunately for the Panthers, the Redskins had

other ideas in mind for the game. Loudon took control of the physical end of things with excellent blocking the entire evening and outquicked the Panthers for most of the ballgame.

Loudon entered half-time with a 14-0 lead, but Lenoir City gave the Loudon Nation a bit of a scare just before the half as they mounted an impressive drive off of a redskin turnover on the L.C. 48. Using the hurry up offense, the Panthers drove the ball with their passing attack to the Loudon 4 yd. line with 3.9 seconds on the clock, and looked as if they were going to go in for the touch, when the Redskin defense came up big with a drive and half-ending sack to preserve their two
