The tax myth is just misinformation. Loudon County and Lenoir City already receive their share of the state alcoholic beverage tax. This tax is collected by the state from liquor wholesalers and the proceeds are then distributed to each county and city based on population and land area. The addition of liquor stores in Lenoir City or Loudon County will not increase our share of the state tax by one penny.

The only additional tax collections that would be realized by local government would be the two cent sales tax that would be collected on each sale of a bottle of liquor. This would hardly cover the cost associated with city services that a liquor store would require not the least of which is police protection.

## Grand Jury report, August 17, 2008, 75 cases:

Out of seventy five cases sent to the grand jury: thirty two were DUI and drug related and twelve were for driving on a revoked license (Loudon County Sheriff Department says revoked licenses are given to DUI "offenders" who have lost their license). That is a total of forty four DUI and drug related cases or fifty eight percent. This number would increase with more opportunities to buy liquor.

#### Arrest records:

From June 8th to September 4th there were 719 arrests recorded in Loudon County. Of that 719, 239 were alcohol and drug related and 73 were for driving on a revoked license. This is a total of 312 or forty four percent arrests that were drug and alcohol related. <sup>1</sup>

The availability of alcohol within a community can influence drinking rates and related problems. <sup>2</sup>

front of the residence. The 8 year old fell off the car and landed in the street behind Ms. Gilreath's vehicle as she left the residence and her two sons unattended to approximately 5 minutes.

Shortly thereafter the husband arrived at home and Ms. Gilreath, by witness account, struck the man multiple times in the arms and chest. Ms. Gilreath appeared to be under the influence of an intoxicant and had an odor of an alcoholic beverage on her person.

After an investigation and obtaining witness accounts Ms. Gilreath was placed into custody.

#### Fire

"In the living room, the couch was on fire... I could hear the windows blowing out, and the air conditioner blowing out..."

Kelly made it out of her 60X20 mobile home located at 600 Town Creek Circle, Lenoir City, and somehow kept the presence of mind to move her and husband, Jeff's, vehicles away from the burning structure even though Jeff's truck had to be rolled with a locked steering wheel. Jeff had left about twenty minutes earlier to help another family member with his car.

According to the official report, Loudon County Fire & Rescue got the alarm call at 10:25:01 AM

and arrived on the scene at 10:32:45 AM. The home had already burned to the ground.

The origin of the fire has officially been undetermined. The fire is reported to have begun in the bedroom around the mattress, according to Captain Kevin Abercrombie of the Loudon County Fire and Rescue Squad, and that it absolutely and positively did not begin from a cigarette.

The family suffered a severe loss in the blaze and a donation account has been set up at ORNL for the family for anyone wishing to make a donation.

According to Silvey and other family members, had Kelly

stayed in the shower just thirty more seconds she would have been trapped in the bathroom with no chance of escape. She suffered second degree burns on her right arm when she tied to put out the fire, but is doing well and is back to work. She and Jeff are staying at a local motel until they area able to get a place to live.

An article in another publication was incorrect and we at The Daily Edition, a newspaper of general circulation in Loudon County, are more than happy to correct their error. We are just sorry the family had to suffer this tragic loss and they are in our thoughts and prayers.
