Report

Sgt. Billy Hall, LCSD Narcotics Division (ND) observed a gold vehicle on 175 in Loudon County that appeared to be traveling above the speed limit. The officer checked with radar and the vehicle was going 73mph in a 65mph zone and he stopped it. The driver was identified as Christopher Lovern. A check of his license showed them to be suspended for failure to satisfy a citation. While Deputy Bryan Blakney was writing a warning citation Sgt. Hall deployed K9 Draga around the vehicle and she alerted to the presence of

narcotics in the vehicle. A search was conducted and Lovern produced a small amount of marijuana from his person and the passenger of the vehicle advised there was marijuana in the vehicle in a bottle. A search of the trunk produced a large pill bottle in a black purse with marijuana. Several other pill bottles were located as well. Also located in the purse was a glass pipe. The miscellaneous pills were identified as Xanax,

Valium, Hydrocodone, Roxicodone. Found in another bag was more marijuana.



of Transportation unveiled a new revamped TDOT SmartWay Web site featuring Google Maps.

The new SmartWay Web site will retain all of the options previously available such as road construction details. traffic flow, road conditions, etc. The new site will expand SmartWay images to include Map, Satellite, and Terrain views. The new system also allows the user to zoom in and out on any area of the state and provides small pop up views of traffic cameras when a user hovers over a traffic camera icon on the map. Traffic camera images also now refresh every 60 seconds instead of every one to five minutes and in Knoxville camera images now refresh every one to two seconds due to a partnership TDOT has established with Trafficland, Other cities will have similar capabilities over the next few months.

TDOT SmartWay is Tennessee's intelligent transportation system which uses advanced information technologies to improve the safety and operation of highways and other transportation modes, such as public transit.

The tax myth is just misinformation. Loudon County and Lenoir City already receive their share of the state alcoholic beverage tax. This tax is collected by the state from liquor wholesalers and the proceeds are then distributed to each county and city based on population and land area. The addition of liquor stores in Lenoir City or Loudon County will not increase our share of the state tax by one penny.

The only additional tax collections that would be realized by local government would be the two cent sales tax that would be collected on each sale of a bottle of liquor. This would hardly cover the cost associated with city services that a liquor store would require not the least of which is police protection.

Grand Jury report, August 17, 2008, 75 cases:

Out of seventy five cases sent to the grand jury: thirty two were DUI and drug related and twelve were for driving on a revoked license (Loudon County Sheriff Department says revoked licenses are given to DUI "offenders" who have lost their license). That is a total of forty four DUI and drug related cases or fifty eight percent. This number would increase with more opportunities to buy liquor.

Arrest records:

From June 8th to September 4th there were 719 arrests recorded in Loudon County. Of that 719, 239 were alcohol and drug related and 73 were for driving on a revoked license. This is a total of 312 or forty four percent arrests that were drug and alcohol related. ¹

The availability of alcohol within a community can influence drinking rates and related problems. ²
