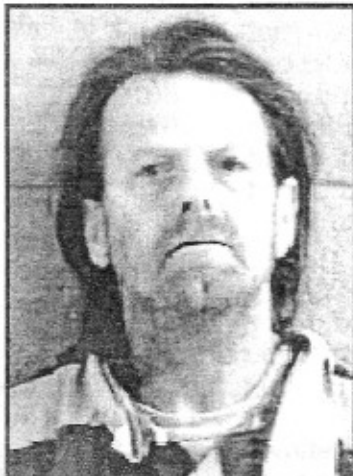

rifle in his possession. Matthew Russell fired the weapon one time towards the residence, which is owned by Johnny Coffman.

The bullet struck the side of the mobile home and lodged in the wall of a front bedroom where detectives recovered it. No one was injured in the incident.

Matthew Russell later told detectives he fired the round and led detectives to a residence on Stinnett Road where the gun had been hidden beside of the residence. The weapon was recovered, along with three live rounds of 30/30 ammunition. A cartridge casing was recovered from the roadway at the scene that was consistent with the ammunition that was found in the gun.

In another warrant, also filed by Lt. Vittatoe, on the same evening Virgil Russell did go to the Coffman residence on Turman Drive and during the

incident Virgil Russell had a broken axe handle in his possession. Virgil stated that Coffman had been to his residence earlier the same day and threatened he and his family. Virgil stated he had went to Coffman's to confront him about the threats and gave a statement about carrying the axe handle with him. A confrontation ensued where gunshots were ultimately exchanged and one person (Matthew Russell) was charged with shooting at the residence.

The other people with the Russell's were not charged in the incident.

Virgil Allen Russell, 48, of Smallen Road, Loudon, and Matthew Brandon Russell, 24, of Steekee St., Loudon, were charged with aggravated assault. Deputy Rob Lane, LCSD made the arrests at the Loudon County Jail.

Lt. Investigator Jeff Vittatoe, LCSD CID filed the charges.

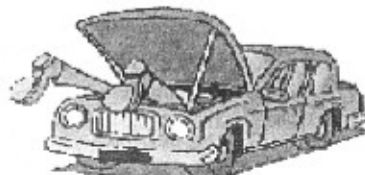

not produce a license and no paperwork for the vehicle. A check showed Osornio to have no license. Deputy Chris Jenkins, LCSD made the arrest.

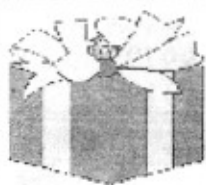

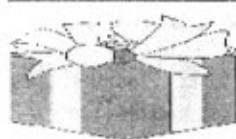

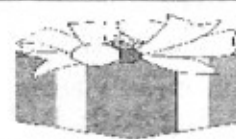
