The areas available for the hunts are listed on the instruction sheets. Hunters have up to 12 choices, but will be drawn for only one. Applicants may not use the same hunt code more than once. No person may apply more than once.

A \$20 Quota Turkey Permit Fee is required for each applicant (except holders of a current Adult Sportsman License, Lifetime Sportsman License, or seniors with a Type 167 permit). When applying at a license agent, hunters must remain at the location while the application

is processed. Hunters will receive a receipt with a confirmation number when the application is complete.
