

Williamson advised he believed the dog owner had just moved in next door and he did not know them.

Williamson had active bleeding where the bite broke the skin and went to the ER for treatment.

The officer noted he went next door and made contact with Greg Hill who said he was just working on a fence for the person who is renting the home.

The lawman wrote, "There were several dogs there, but none that matched, but from past knowledge of Mr. Hill I know he has a black and white Pit Bull that has bitten several people, but I was unable to locate it at the this time.

"Call was placed to Animal Control."

On Tuesday night just before 10:30 p.m. Deputy Brad Rayfield was dispatched to the Hines Valley Road home of Steve Clark who said he witnessed two Pit Bulls attack his cat, Rascal, on his front porch. Clark said the canine pair cornered the cat on his porch and severely injured it.

The dogs were described as both Pit Bulls, one with short brown hair and the other with black and white hair and a white face.

The officer reported he observed the cat's injuries and was not sure at the time of his report if the feline would need to be put down because it was severely injured about the head and could not walk.

The dogs owner was identified as Greg Hill of Hines Valley Road.

Deputy Rayfield noted on his report, "I have dealt with the same two dogs when Greg Hill lived in the house right behind the hospital on Town Creek Road. I, myself, have described both dogs from previous calls, one where I had to spray the black and white Pit Bull to keep from being bitten.

"Several people.

mostly from the Hampton Inn in Lenoir City, have been bitten by the black and white Pit Bull."

The officer further noted he contacted an Animal Control worker who advised she had just been at the location on Monday on two dogs running loose and Hill told her he didn't have the black and white dog anymore.

No other information was available at press time.





Easter

posed by the 8th-century English scholar St. Bede, believe the name Easter is thought to come from the Scandinavian "Ostra" and the Teutonic "Ostern" or "Eastre," both Goddesses of mythology signifying spring and fertility whose festival was celebrated on the day of the vernal equinox.

Traditions associated with the festival survive in the Easter rabbit, a symbol of fertility, and in colored easter eggs, originally painted with bright colors to represent the sunlight of spring, and used in Easteregg rolling contests or given as gifts.

The Christian celebration of Easter embodies a number of converging traditions with emphasis on the relation of Easter to the Jewish festival of Passover, or Pesach, from which is derived Pasch, another name used by Europeans for Easter. Passover is an important feast in the Jewish calendar which is celebrated for 8 days and commemorates the flight and freedom of the Israelites from slavery in Egypt.

The early Christians, many of whom were of Jewish origin, were brought up in the Hebrew tradition and regarded Easter as a new feature of the Passover festival. a commemoration of the advent of the Messiah as foretold by the prophets.

Easter is observed by the churches of the West on the first Sunday following the full moon that occurs on or following the spring equinox (March 21). So Easter became a "movable" feast which can occur as early as March 22 or as late as April 25.

Christian churches in the East which were closer to the birthplace of the new religion and in which old traditions were strong, observe Easter according to the date of the Passover festival.

Easter is at the end of the Lenten season, which covers a forty-six-day period that begins on Ash Wednesday and ends with Easter. The

Lenten season itself comprises forty days, as the six Sundays in Lent are not actually a part of Lent. Sundays are considered a commemoration of Easter Sunday and have always been excluded from the Lenten fast. The Lenten season is a period of penitence in preparation for the

highest festival of the church year, Easter.

Holy Week, the last week of Lent, begins with the observance of Palm Sunday, Palm Sunday takes its name from Jesus' triumphal entry into Jerusalem where the crowds laid palms at his feet. Holy Thursday commemorates the Last Supper,

which was held the evening before the Crucifixion. Friday in Holy Week is the anniversary of the Crufixion, the day that Christ was crucified and died on the cross.

Holy week and the Lenten season end with Easter Sunday. the day of resurrection of Jesus Christ.
