Kids First

Lenoir City, - Kids First, the Child Advocacy Center of the Ninth Judicial District of Tennessee officially dedicated its new 8,000 square-foot home on Highway 70 in Lenoir City, on land donated by Ted and Frances Wampler.

Children from Philadelphia Elementary School in Philadelphia ioined Ted Wampler, USDA official Jerry Armonett, Kids First Board Chair Millie Bruner and Executive Director Chris Evans-Longmire in cutting a 1,200-link, 400-foot paper chain. Cutting the links in the chain symbolized "breaking he chain" of child abuse, with 1,200 representing the number of severe child abuse cases handled by Kids First since its founding.

Set up in 2002 to handle severe cases of both sexual and physical child abuse in Loudon, Meigs, Morgan and Roane public agency has operated in rental quarters - most recently at the Parish Family Life Center of St. Thomas the Apostle Catholic Church. The agency began using the "Kids First" name last year, but also still is known as the Child Advocacy Center, or CAC.

The new building sits atop a hill overlooking a pastoral setting where horses graze on land that was part of the Wampler family farm. A Wampler's Farm Sausage plant is nearby, and Ted Wampler spoke at the

dedication.

Volunteers raised about half of the \$819,000 needed to build the new facility, and covered the cost of furniture, office furnishings and other equipment. That effort included fundraising dinners featuring Lady Vols basketball Coach Pat Summitt, UT men's basketball coach Bruce Pearl and UT football coach Phillip Fulmer. anonymous bene-

\$100,000 challenge grant, which volunteers more than matched. A crew of volunteers from the Home Depot Store in Lenoir City planted bushes and flowers and spread mulch provided by the company.

However, a lowcost, long-term mortgage was needed in order to start construction, and through the efforts of U.S. Rep. John Duncan, the Rural Development Administration of the U.S. Department of Agriculture was able to provide a loan with "excellent terms" said Ms. Evans-Longmire. Duncan and USDA Area Director for Rural Development Jerry Ammonett also spoke at the ceremonies.

Bill Williams, television anchorman emeritus and long time friend of the Kids First/CAC, emceed the dedication doings. Williams reminded the audience that the CAC runs primarily on private donations, and

now will have a mortgage to pay off.

"If you'll pardon the pun on Ted Wampler's primary product, just because we have the land and the new building doesn't mean we're in "Hog Heaven." Williams said. "There's still much work to do, and money to be raised, to keep this place running and growing, to continue to help the children."

Only the 5,000square foot main floor of the new building is finished, leaving 3,000 square feet upstairs unfinished and ready for future expansion. It was designed by George Ewart Architecture, of Knoxville, and built by Creative Structures of Knox-

ville.

It has offices for Executive Director Evans and her six staff members, a forensic interview room, observation room, conference rooms, play rooms, and space for law enforcement,


child protective services people and prosecutors who are an integral part of the agency's work in the four-county area.

Kids First/CAC serves victims of severe physical and/or sexual abuse ranging from 3 to 17 years of age. The majority of the children are sexually abused by someone they know, love and trust. The average age of a client is 8 years and tends to be female.

A critical benefit of the Center is that the experts are under one roof so that the child will not have to re-live the traumatic abuse experience agency by agency. The investigating law enforcement officers, department of children's services caseworkers and the District Attornev's representatives come directly to the agency. so that they are a part of the service delivery in real time. If a forensic medical examination is necessary, the agency tries to schedule it for the same That medical service is provided by volunteer doctors and nurses.

As a child victim is being interviewed, the non-offending caregivers also receive services. The children and their non-offending caregivers are the priority and deserve the best treatment possible.

CAC services include support groups and education classes to non-offending caregivers, pregnant teens and adult survivors of child abuse. They also deliver a school-based curricu-

Three residents of Tennessee have been sickened by a dietary supplement that is currently being voluntarily recalled by Total Body Essential Nutrition of Atlanta. the sole distributor of the products. The U.S. Food and Drug Administration and the State Department of Health are urging Tennesseans not to purchase or consume the products "Total Body Formula" and "Total Body Mega Formula" in the flavors of Tropical Orange and Peach Nectar, or "Total Body Mega Formula" in the Orange/Tangerine flavor. These products are manufactured by TexAmerican Food Blending, Inc., of Hot Springs, Arkansas.

FDA laboratories are analyzing samples of the products to verify that the reactions are due to increased levels of selenium. which is known to cause symptoms including significant hair loss, muscle cramps, diarrhea, joint pain, fatigue, and occasionally more severe neurologic symptoms such as loss of feeling in arms and legs. Selenium, a trace mineral, is needed only in small amounts for good health.

Tennessee residents made sick by the products reside in the eastern part of the state and reported serious reactions within three to 10 days after ingestion. In all cases, the reactions included significant hair loss. muscle cramps, diarrhea, joint pain and fatique.

In addition to discontinuing use of the products immediately, people should discard

the products by placing them in a trash receptacle outside of the home. Consumers who have been taking the products and have experienced adverse reactions should consult their health care provider regarding treatment for certain signs of illness, such as diarrhea or neurologic symptoms. Symptoms go away slowly on their own after discontinuing use of the product without specific treatment, and testing is generally not necessary.

In addition to Tennessee, the products have been distributed in Alabama, California, Florida, Georgia, Kentucky, Louisiana, Michigan, Missouri, New Jersey, North Carolina, Ohio, Pennsylvania, Texas and Virginia.

The total of the theft was \$67.10. The other person was a juvenile. Officer Jason Butler and Officer Jeremy Dishner. LCPD made the arrests.






