



held at the University of Maryland June 15-19. The national history awareness program this year took the theme "Conflict and Compromise in History" and weighed entries which also included exhibits, performances, papers and websites.

The Episcopal School has participated in National History Day for three years, and each year the school has sent a team to the national competition in Mary-

Kate first became interested in the Selma march following a family trip to the Civil Rights Museum in Memphis. In addition to extensive research of primary and secondary materials on the Civil Rights movement, Kate and her teammates interviewed Avon Rollins. Executive Director of the Beck Cultural Exchange Center, Mr. Rollins was arrested more than 30 times for his participation in Civil Rights demonstrations, and he participated in the Selma to Montgomery march in 1965.

The team also interviewed Margie Stewart, a participant in the first Selma to Montgomery march, and incorporated music that originated at the Highland Center, where Rosa Parks and other Civil Rights activists were trained. In addition to producing a compelling documentary on the Civil Rights movement, the Episcopal School team produced an extensive annotated bibliography and process paper as part of the competition.

The winning team members were among 30 Episcopal School eighth graders who participated in the district competition of National History Day at the University of Tennessee on March Dr. Patricia Brake is Episcopal School sponsor of National History Day.

Aimed at re-invigorating the study of history for teachers and students alike, National History Day involves some 2 million students, teachers, parents, and volunteers from across the country each year. NHD was highlighted as an "exemplary program" in the 1997 President's Committee on Arts and Humanities. It is endorsed by such organizations as the American Historical Association and the American Association for State and Local History. he found Carter trying to extinguish his 2006 Mood Craft boat with a garden hose. Loudon County Fire and Rescue and the Philadelphia Fire Department responded and extinguished the blaze.

Carter told the lawman they had their windows open and were awakened by a sickly sweet smell around 3:29 a.m. They looked out and saw a glow and Mrs. Carter went down the driveway where she found the boat on fire.

The boat and all of it's contents, including about \$2000 worth of rods and reels and \$2000 worth of lures, were a total loss.
