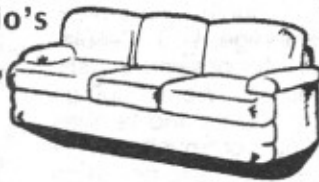

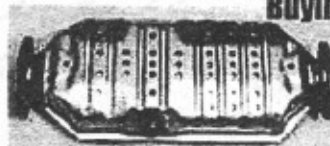

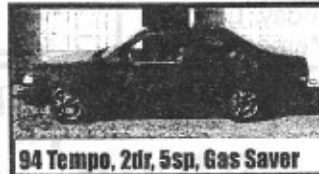

The deputy also found another push rod in the glove box.

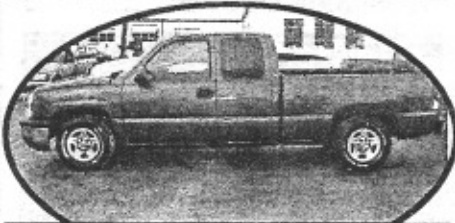
