#### WATER SYSTEM WIDE FLUSHING PROGRAM

LCUB and the City Fire Department will be conducting our semi-annual water distribution system wide flushing program per Tennessee Department of Environment & Conservation Water Quality Control Requirements. The Flushing Program will occur for the City of Lenoir City on Monday, April 7, 2008, from 2:00 p.m. until 10:00 p.m. and Tuesday, April 8, 2008, from 8:00 a.m. until 3:00 p.m. The program goals are to identify problems in the water system and ultimately have them corrected.

When fire hydrants are flushed, iron deposits in the water lines are stirred up. This may cause a brown discoloration to the water in the area which is being flushed. This condition is only temporary and will normally correct itself in a number of hours. During this period of flushing, we recommend that you flow your cold water prior to use to determine if there is any discoloration. While the water is still safe for consumption, we recommend not washing any white clothes without first testing the water for discoloration. If your water is discolored, it will clear on it's own under normal usage over a period of time. It is also best to limit the use of hot water until it is clear, as this will keep the iron deposits from settling in hot water heaters. You may also notice a drop in water pressure during these times; however, the water pressure should return to normal within a short period of time.

Possible suspects were identified to police.





#### Davis

In an agreement worked out with Davis and her attorney T. Scott Jones she was sentenced by Loudon County Criminal Court Judge E. Eugene Eblen to a three-year sentence to be served on supervised probation whereby she will have to perform forty hours of community service, pay a Fraud & Economic Crime contribution of \$1,000 and pay court costs. As a further condition of her quilty plea agreement she will continue with the sequence of therapy that she is currently undergoing on an outpatient basis. Her probation officer will monitor her therapy progress as an aspect of her probation meetings.

If she fails to complete any aspect of the sentence, the District Attorney General can file a motion to revoke her probation and request the Court to make her serve a portion or all of her three year sentence in jail or prison. District Attorney General Johnson noted "our Judge routinely orders probation only in these types of cases, especially where it involves a smaller amount of money, restitution was voluntarily made before the plea, and the defendant admits his or her guilt."

General Johnson explained that Kre-

isher, upon learning of the unauthorized transactions totaling about \$2,700 from her First National Bank account, reported the matter to the Loudon County Sheriff's Department on January 24th. When a review of the transactions revealed that Callie Davis. who is the wife of LCSO Assistant Chief Deputy Jimmy Davis, was the alleged suspect, Loudon County Sheriff Tim Guider immediately contacted the District Attorney General who predicated the investigation of the apparent identity theft to the Tennessee Bureau of Investigation, TBI Special Agent Jason Lega conducted the investigation that was concluded and turned (see Davis cont. pg. 11)

over to General Johnson on Monday.

The various items that were paid by Callie Davis over the telephone using Kreisher's bank account routing number were monthly bills e.g. cell phone and utilities. Agent Legg. however, determined that Jimmy Davis had no knowledge of his wife's illegal activities since she was the one who handled the payment of the monthly bills. Therefore, no criminal charges were brought against Jimmy Davis.

In fact, Mr. Davis, upon learning what his wife had done, immediately took action to make sure that Ms. Kreisher was refunded the money. Therefore, there was no order for restitution in Callie Davis' guilty plea agreement. Also, Mr. Davis sought treatment for his wife to try and address the apparent problems that led her to engage in this unlawful conduct. conduct for which she was previously convicted in 2007.

Callie Davis was convicted in Loudon County Criminal Court in 2007 for using the social security number of her ex-husband to obtain a cell phone in 2006 before she was married to Jimmy Davis. The original charge of identity theft in that case was reduced to misdemeanor theft with the agreement at the suggestion of her ex-husband. Callie Davis was ordered to

pay a fine and court costs in that case, but since there was no actual financial loss to her ex-husband, there was no restitution ordered. The three-year sentence, assuming Davis is successful in the requirements of her plea, will not expire until April of 2010. The felony conviction will also remain a conviction on her record.

General Johnson related that he contacted Sheriff Guider and Davis' attorney, T. Scott Jones, immediately upon receipt of the TBI investigation. Davis' attorney indicated that Davis was willing to plead guilty to the felony identity theft so that she and her husband could move forward with their lives as soon as possible. "Ms. Davis has been very apologetic and is sorry for her actions" stated

"I felt that it was necessary to secure a felony conviction on this case, especially in light of Mrs. Davis' prior conviction for a similar action. She also had eleven worthless check charges (that were dismissed by prior DAG Scott McCluen's office in 2004)", Johnson said. "Because of the past history it was obvious to me that Mrs. Davis has issues that need to be addressed and I am glad that her husband is guiding her in getting the help that she needs."

Johnson also explained that the case

presented several problems from a prosecution standpoint. "We had several transactions for relatively small dollar amounts. Therefore, we could have had lesser charges (misdemeanors) that would typically have been handled by warrants in General Sessions Court on fines and court costs." The most problematic aspect for Johnson was that the victim, Christie Kreisher, did not want her friend prosecuted. "Ms. Kreisher called my office several times requesting that I not even charge Mrs. Davis. She even sent me a written waiver of prosecution by way of a letter requesting that I not prosecute her friend. In fact, Kreisher had previously paid bills on behalf of Callie Davis. Therefore, I was especially concerned given this set of circumstances that the Grand Jury might not indict Mrs. Davis because of Ms. Kreisher's request that I would have been ethically obligated to present to the Grand Jury. Therefore, I decided to go with the 'information' directly to Criminal Court in order to get the conviction that I felt was most appropriate."

"I fully disclosed Ms. Kreisher's position and 'written waiver' to Mrs. Davis through her attorney," Johnson said. "They chose to accept the felony plea agreement in order to avoid the process of the Grand Jury, the

possibility of an indictment, arraignment and eventual jury trial in Criminal Court."

Johnson also added that the ease with which the personal information was obtained and used in this case exhibits why you should always protect the security of this information. including checkbooks and debit cards, even from friends and family members. "A large number of the identity theft cases that we see involve people that the victims know as friends, family members or relatives. Therefore. the victims are often unwilling to prosecute these cases because of their relationship to the defendants."

General Johnson was asked what will happen to Jimmy Davis at the LCSO?

Johnson stated. "That will be up to Sheriff Guider, but since there was no culpability on Jimmy Davis' part, the District Attorney General did not bring criminal charges and is not requiring or recommending any administrative action against Jimmy Davis. The District Attorney General does issue a cautionary warning to law enforcement officers and public officials, as well as the public in general, that in a household where one spouse or family member is solely responsible for paying the monthly bills that

this too could happen in your family, and obviously sometimes does."

According to a prepared statement from Sheriff Tom Guider regarding the Callie Davis Case:

"When is case was brought to our attention, I immediately notified the District Attorney General and requested the T.B.I. do the investigation so that there would be no questions as to any conflict.

The investigation clearly revealed that Assistant Chief Deputy Jimmy Davis had no knowledge of his wife's actions. When he did have this knowledge he was obviously extremely embarrassed and immediately made restitution to those involved and sough counseling for his wife.

Given the facts of the case and the position that Assistant Chief Davis holds, I advised him that when judgement was rendered, there would be some consequences to discuss.

Jimmy Davis has worked his way up the ranks doing an outstanding job. Unfortunately, effective Monday, April 7, 20-08, Jimmy Davis will resume the rank of Sergeant. This decision is not meant to punish Jimmy, but to maintain stability in management and confidence among the troops and the citizens we serve.
