

lections totaled \$555.081.206, an increase of \$6,605,652 or 1.2 percent from May 2007 collec-

Collections from the retail trade group decreased 0.7 percent. Items with significant changes include:

Apparel & accessory stores: up 19.5 percent

Miscellaneous retail stores: up 4.4 percent

Eating & drinking places: up 2.4 per-

Motor vehicle dealers and service stations: down 4.6 percent (with a 9.1 percent decline in the new, used motor vehicle sub-category

Food stores: down 4.2 percent

Building materials: down 3.4 percent

Collections from the service group increased 3.3 percent from May 2007. Only the business services category exhibited significant change (up 8.7 percent).

Collections from the non-retail, non-services group rose 4.9 percent led by gains in transportation (up 142 percent), manufacturing (up 12.9 percent) and electric, gas & sanitary services (up 11.5 percent). Partially offsetting these gains was communications (down 9.5 percent).

Consumer use collections were \$510,413, a decrease of \$209.387 (29.1 percent) from May 2007.

Franchise and excise tax collections were \$47,730,918, an increase of \$6.693.619 or 16.3 percent when compared to May 2007. Separately, franchise tax collections were \$21,596,816, an increase of \$288,761 or 1.4 percent from last May. The excise tax collection was \$26,134,103, an increase of \$6,404,858 or 32.5 percent from May 2007.

Tobacco tax collections were \$28,778,956, an increase of \$19,558,645 or 212.1 percent over the collection of May 2007.

Motor vehicle fuel tax collections were \$19,479,593, an increase of \$5,889,715 or 43.3 percent from May 2007.

Inheritance and estate tax collections were \$6,199,910, a decrease of \$5,339,424 or 46.3 percent from May 2007.

Gasoline tax collections were \$50,284,949, a decrease of \$1,303,560 or 2.5 percent compared to May 2007.

Privilege tax collections were \$46,255,000, a decrease of \$1,227,081 or 2.6 percent compared to May 2007.

June 2, 2008. We get one every single month.

What more can you possibly hope to gain from us? We are paying you, why are you doing this to us?
