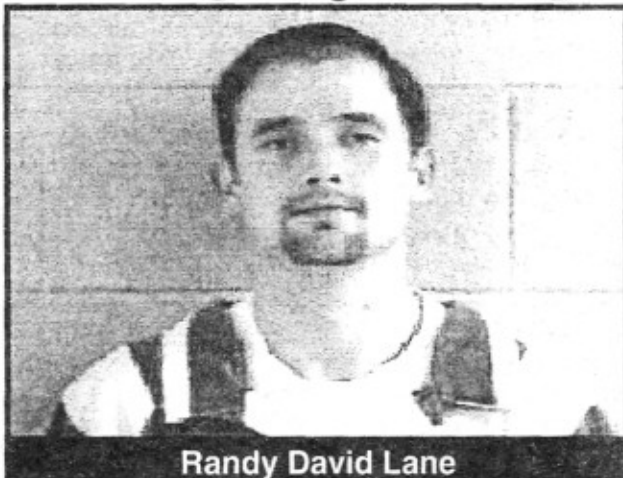
Upton charges man in 2007 burglary string

A Knoxville man has been charged by Detective Sgt. Patrick Upton, LCSD Criminal Investigation Division (CID) after an investigation into several burglaries that occurred in 2007. According to the warrants, on November 9, 2007 Randy David Lane did enter a residence on Cardwell Chapel Road in Lenoir City without the consent of the owner. Once inside, Mr. Lane did take a 20-gauge shotgun, .22

cal bolt-action rifle, a Marlin .22 cal rifle, passports, Xbox, silver dollars and \$30,000 in savings bonds. The investigation showed that Mr. Lane did have the stolen guns and savings bonds in his possession. Mr. Lane also gave a statement to the fact he did commit the above burglary and theft. The victim also identified 3 guns and the savings bonds that were recovered from Mr. Lane.

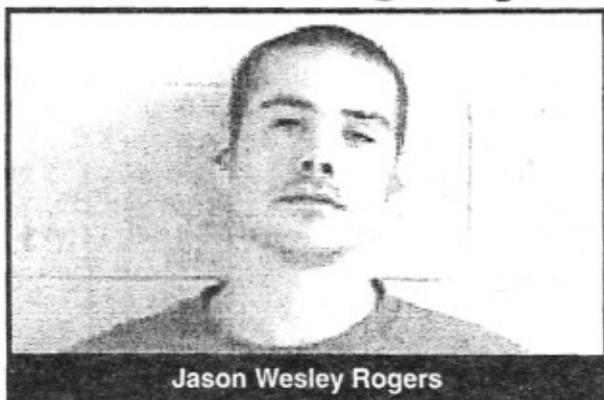
Phil man charged with burglary

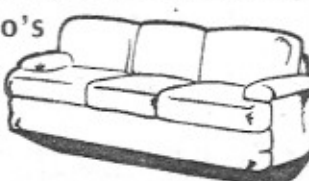

ber 19, 2007 Randy D. Lane did enter a residence located on Tshudatsi Circle in Loudon without the owner's knowledge or consent. After entry to the residence was made by forcing a door open, items were taken from the residence by Mr. Lane. The items included DVDs, 37" TV, a portable DVD player, two fishing poles and a tackle box. Investigation showed Mr. Lane did have the DVDs, tackle box and fishing poles in his possession. The victim identified the tackle box, fishing poles and movies that belonged to him. Mr. Lane gave a statement to the fact he did commit the burglary and theft.

In yet another warrant, on or about November 9, 2007 Randy Lane did enter a home on Old Kingston Road in Loudon without the owners consent. Mr. Lane took several items including birth certificates, 46" TV, 2001 Suzuki 4-wheeler and several keys. The estimated value of the items taken is \$10,000. Mr. Lane was found with some items taken in the burglary. Also on November 21, 2007 Detective Upton interviewed Mr. Lane and he did admit to the burglary and taken the items.

In another warrant, on October 19, 2007

Randy D. Lane did enter a residence located on Get Good Hollow Road in Loudon without the owner's knowledge or consent. After entry to the residence was made by forcing open a rear door, items were taken from the residence. Those items included a Samsung 32" TV, Sharp 20" TV, and two remote controls. The cost of the items was valued at \$2500. Mr. Lane gave a written statement to the fact he did commit the burglary and theft and stated the 32" TV was broken during the burglary and it was thrown from the vehicle and he left the scene on Get Good Hollow Road. Deputy Charles Butler LCSD while on Get Good Hollow Road with the work crew located the TV on the side of the road. The serial number showed it was the TV taken from the victim's residence.

Randy David Lane, 30, was charged with 4 counts of aggravated burglary, three counts of theft over \$1000 and one count of theft over \$10,000. Deputy Ryan Grubb, LCSD made the arrest.

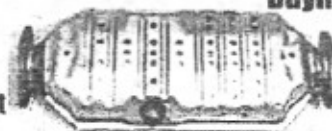

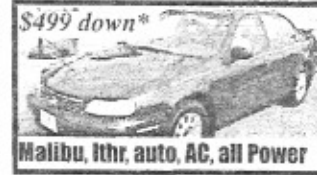

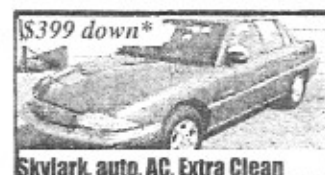
