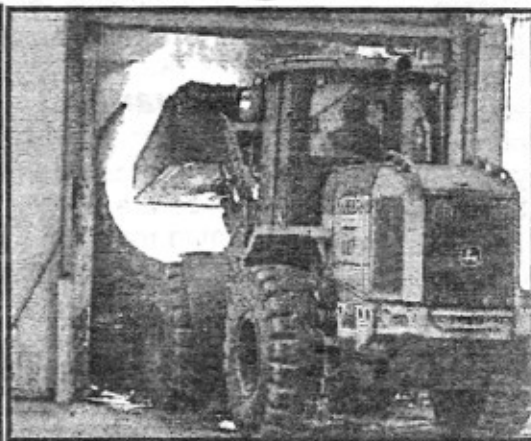
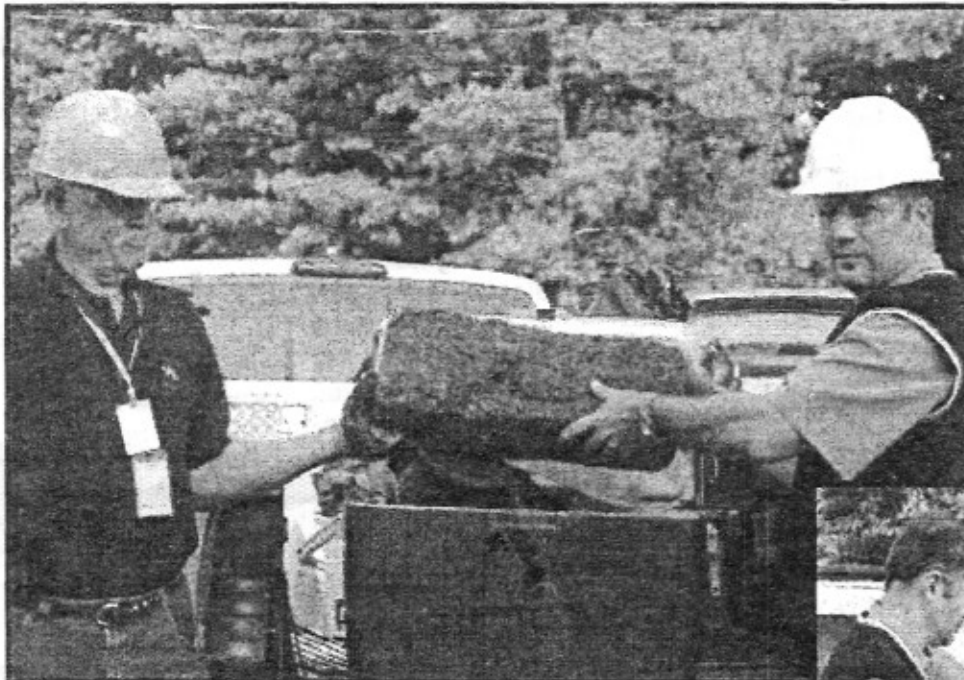

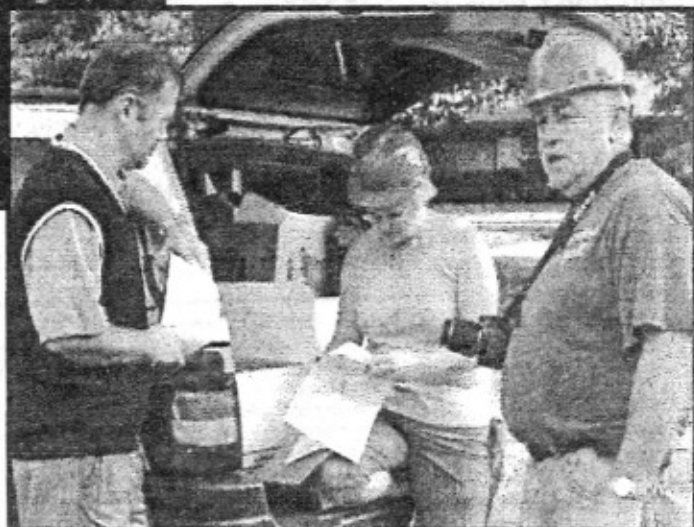
## LCPD & LPD team up in drug bust

## Burn

District Attorney General Russell Johnson and 9th District Drug Task Force Director Steve Cook, along with agents of the DTF, recently met with Susan Harrison of the Loudon County Sheriff's Office to inventory and destroy illegal drugs consisting of marijuana, cocaine, crack cocaine and pills, as well as weapons and other evidence seized by the DTF.

Harrison acts as the evidence custodian for the LCSO and, according to General Johnson, is the most qualified certified evidence custodian in the 9th District, "so we call on her to assist our office anytime we have to destroy drugs or evidence pursuant to a judicial destruction order". Johnson also noted "Susan [Harrison] has been helpful in training seminars that we put on for other agencies to make sure

they have an appropriate evidence handling procedures."

The drugs and evidence were destroyed by incineration at IMCO Recycling in Loudon. Johnson and Cook thanked Stan Sampson and his crew at IMCO for their assistance. "We often use IMCO for this sort of thing and they are always willing to help," said Deputy Director Cook.

Johnson noted the level of cooperation between the DTF and

its member agencies in Loudon County – the Sheriff's Office, Loudon Police and Lenoir City Police. "Just last week one of the Loudon officers made a stop that produced information that was passed through the Sheriff's Office to one of our DTF agents. The information from that stop led to the destruction of over 200 pot plants in Roane County. It was also good to see the Loudon and Lenoir City officers working together with the DTF to make a recent large drug bust in Lenoir City that led to the detention for deportation of eleven illegal aliens and the arrest of three more individuals for illegal drugs. I appreciate Sheriff Guider, Chief Webb, and Chief White having their officers and investigators work

together with Steve Cook and our other DTF agents for the common good on these issues," stated Johnson.
