According to records, the Loudon Police Department received an emergency call from the 911 center in reference to Michael Green harassing individuals at a Creekwood Circle, Loudon residence.

The 911 center advised Green was sitting in a large red 1979 Chevy four-wheel-drive pick up, and he was armed with a gun.

Upon the arrival of police, Officer Samuel Harrison, LPD observed the pick up leaving the area and initiated a traffic stop on Roberson Springs Road just off of Carding Machine Road.

The driver was identified as Michael E. Green. Green had an odor of an alcoholic beverage about his person and breath, blood shot eyes, very slurred speech and he was very unsteady on his feet.

Green also performed poorly on sobriety tasks administered by Officer Harrison.

After placing Green under arrest he verbally consented to a blood test to determine the alcohol and/or drug content of his blood.

While in custody Green allegedly began exhibiting extreme mood swings, which included becoming verbally combative.

While en route to Fort Loudoun Medical Center to conduct the blood test, Green suddenly became lethargic and unconscious. When the officer was unable to get any response from Green he stopped along Cedar Street and had Fire and EMS dispatched to the location.

Green who was possibly suffering from an overdose was transported by EMS to the ER where he remained unconscious for several hours.

Due to the circumstances that existed, the blood test was conducted in order to determine the alcoholic and/or drug content of Green's blood and the results are pending from the TBI.

After arriving at the jail, Deputy Bowen asked Mr. Burnette to complete the field sobriety task because it was unsafe to perform them on the interstate. He reportedly agreed to them and performed poorly.

After Burnette was read a copy of implied consent he refused. A check of his license through NCIC showed that Burnette has a prior conviction of DUI on July 31st 2003.
