
# Convicted drunk driver nabbed after wreck, blows .17%

After being transported to the jail, Ms. Sedman was read the implied consent law and agreed to submit to a BAC test, which produced the result of .14%.

A passenger in the vehicle, Jonathan D. Fisher, 21, of Highland Avenue, Loudon was charged with violation of probation and simple possession of schedule VI.

According to affidavits, on August 1, 2007, Mr. Fisher was convicted of DUI 1st and driving with out a license. The court suspended his sentence and placed him on probation for 11-29.

Since then, Mr. Fisher has failed to report to probation officer (last visit 6/26/2008), failed to pay court costs and fines (owes \$1028, has made no payments), failed to report to his probation officer (last visit was 6/26/2008 and last probation payment was 3/4/2008) and failed to comply with court ordered probation.
