#### Henry

A local woman was jailed in connection with the burglary of a River Chase residence earlier this month in which a juvenile and an adult were arrested. The adult reportedly was taken into custody after K-9 Diego tracked him across the lake.

Telly Michelle Henry, 34, Sierra Drive, Sweetwater was charged with aggravated burglary.

According to the affidavit, on October 12, 2009, at approximately 9:45pm,

Ms. Telly Michelle Henry was checked by Loudon County Sheriff's deputies in the area of Lakeland Drive and Thurmer Circle in Lenoir City. At the same time the Loudon County Sheriff's Office was investigating a aggravated burglary that had just occurred in the area.

Also during the same time period, two suspects were apprehended by the use of LCSO's K9 unit for the aggravated burglary of a residence on River Chase Road in the nearby area.

During the investigation, both suspects identified Ms. Telly M. Henry as the same person that assisted in the aggravated burglary by driving them to the location for the purpose of committing a felony.

Based on the statements of both suspects, Ms. Henry was to stay in the area and one of the suspects was to notify her by cellular telephone to make arrangements to pick them up once the felony was complete.

Cosner, LCSO, is in charge of the case and filed the charges. Deputy Rondel M. Branum, LCSO, arrested Ms. Henry at a location on Markwood Road Saturday.

The other suspects were identified as George Locklear and a juvenile who were charged with aggravated burglary.

Sheriff Tim Guider also advised the Loudon County Criminal Investigations Unit was currently investigating Mr. Locklear for several burglaries in the Loudon County area. He advised the CID unit interviewed Mr. Locklear further and was able to solve at least six (6) other burglaries in the area.

Some items were recovered and other charges may be forthcoming against Henry.

The juvenile will face a Juvenile Court hearing.

#### COPS

Loudon County Sheriff Tim W. Guider today announced the expansion of the Citizen's Observer Patrol, also known as the COPs Program. Over the last year Sheriff Guider has teamed up with citizens from the Tellico Village community and implemented a COPs pilot program. The newest communities to join forces with the Sheriff will be the Greenback and Glendale Communities including the City of Greenback.

The COPs program is designed to allow citizens to assist law enforcement by being an extra set of "eyes and ears", and immediately report suspicious activity, potential hazards and even crimes in progress to the Sheriff's Office. COPs volunteers also do home checks for residents who are on vacation.

The concept derived its roots from the Community Policing Concept and was first implemented in San Jose, CA. Law enforcement agencies who have implemented the program have seen a reduction of complaints affecting quality of life as well as a reduction of criminal activity within communities. There has also been standing of, and a cooperative relationship between, the public and law enforcement within communities involved with the COPs programs. Citizen volunteers who wish to participate in the COPs program go through a background check, and upon successful completion and acceptance into the program, receive training on how to identify activities that would require law enforcement intervention, such as criminal activity, suspicious activity, or public nuisance hazards. The Loudon County Sheriff's Office supplies the COPs volunteers with a uniform that will not confuse the public into believing

them to be sworn law enforcement officers.

The Sheriff's Office also provides a vehicle for the use of the communities designated as a COPs volunteer vehicle that is marked as not to confuse the public into thinking the vehicle is a law enforcement vehicle, but is so defined that it will clearly be visible as a Citizens On Patrol vehicle.

Sheriff Guider stated "Due to the overwhelming success of the COPs program in the Tellico Village Community, we are expanding the COPs program to other communities within Loudon County." Sheriff Guider also

plans to continue the expansion of the COPs program to communities on the upper and lower ends of Loudon County. "This program has proven to be a successful and powerful tool forged between the citizens and the Sheriff's office that is helping ensure Loudon County remains a safe place to live," added the Sheriff.

Executive Director Bo Irvin said, "Our goal is to protect the safety of the public, especially

children, throughout the Halloween season. In past years, this effort has been highly effective. By reminding offenders of the restrictions upon them, and the consequences of non-compliance. we make the harvest season safer for Tennessee families."

The letters advise sex offenders that:

\* Neither they, nor anyone in their home, can answer the door to

trick or treaters on Halloween:

\* They cannot pass out candv:

\* Their homes cannot be decorated for Halloween, either inside or outside:

\*They cannot host Halloween parties at their homes:

\* They cannot go to haunted houses, com mazes, hay rides or any other seasonal activity:

\* They cannot be at any

They cannot give any Halloween treats to children:

\* They cannot wear costumes and

\* They cannot take any child trick or treating.

Probation/Parole Officers have discussed the restrictions with sex offenders under their supervision, and the offenders signed statements acknowledging that they understand and will comply with the conditions. Officers are making visits, both announced and unannounced, to verify that offenders are abiding by the terms of their curfews and the other directives.

The Board of Probation and Parole ( www. tn.gov/bopp/) is an independent sevenmember board whose members are appointed by the Governor. The Board is charged with the responsibility of deciding which eligible felony offenders will be granted parole and released from incarceration to community-based supervision. Along with the supervision of those granted parole, the Board is also responsible for supervising felony offenders who are placed on probation by criminal courts.
