
Man kicks woman unconscious, charged

Jesse Ray Huffine, 22, Norwood Street, Lenoir City, was charged with aggravated domestic violence assault.

was met by a woman. She advised her son Jesse Huffine and his girlfriend were fighting. Mr. Huffine was sitting on the couch and the deputy found the airlfriend lying on the bathroom floor near the hallway where he had seen Mr. Huffine walking back and forth.

The lawman reported he asked the woman if she was ok. She started crying and advised her head was really hurting.

tionally decreased this week over last week. This is the second week of national decreases in ILI after four consecutive weeks of sharp increases. (All regions but one showed declines in ILI. Region I (CT, ME, MA, NH, RI and VT) continues to show sharp increases in ILI activity. While ILI declined overall nationally, visits to doctors for influenza-like illness remain higher than what is seen during the peak of many regular flu seasons.

* Total influenza hospitalization rates for laboratory-confirmed flu continue to climb and remain higher than expected for this time of year. Hospitalization rates continue to be highest in younger populations with the highest hospitalization rate reported in children 0-4 years old.

The proportion of deaths attributed to pneumonia and influenza (P&I) based on the 122 Cities Report continues to increase and has been higher than what is expected for six weeks now. In addition, 35 flu-related pediatric deaths were reported this week: 26 of these deaths were associated with laboratory confirmed 2009 H1N1; eight were in-

fluenza A viruses, but were not subtyped: and one was an influenza B virus. Since April 2009, CDC has received reports of 156 laboratory-confirmed pediatric 2009 H1N1 deaths, one influenza B death, and another 23 pediatric deaths that were laboratory confirmed as influenza, but the flu virus subtype was not determined.

* Forty-six states are reporting wide-spread influenza activity at this time; a decline of two states over last week. They are: Alabama, Alaska, Arizona, Arkansas, California, Colorado, Connecticut, Dela-

The permits available are on a first come, first serve basis. Permits can be purchased at any TWRA license agent or through the internet at the TWRA Web site at www.tnwild-life.org. The receipt will serve as the permit and no permits will be mailed. No phone sales will be accepted.

A permit fee will not be charged to Annual Sportsman (Type 004) or Lifetime Sportsman (Types 402 thru 405) license holders or Senior Citizen Hunters (Type 166) with an Annual Senior Citizen Permit (Type 167). For all other license holders, the cost is \$20 per permit, plus agent fee.

First come, first serve permits are sold one at a time per transaction. Customers can purchase permits for others as long as they have all their pertinent information. The same one permit per hunt choice applies.
