was charged with felony fleeing, driving on revoked 2nd offense and habitual offender.

According to reports, on Saturday Deputy Michael Watkins, LCSO noticed a white Infinity traveling on Highway 321 near Antioch Church Road at a speed of 83 mph in a 65 mph zone. While attempting to stop the vehicle, it accelerated to speeds over 100 mph, with no regard for public safety.

The vehicle traveled into Blount County and turned onto Walker Road in Friendsville before wrecking into a fence line and several posts.

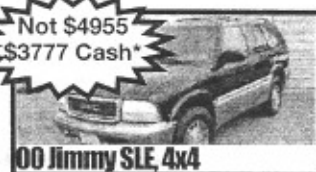

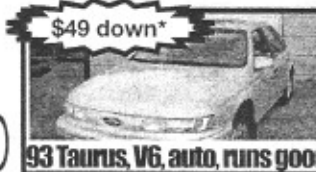

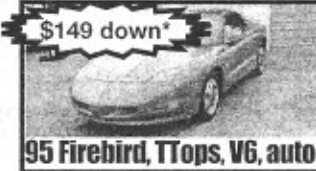
