Doses

NASHVILLE - The Tennessee Department of Health has determined that health providers in the state received 11.210 doses of H1N1 flu vaccine now impacted by a voluntary, non-safety related recall. Sanofi Pasteur. Inc., is recalling four lots of H1N1 vaccine in 0.25 ml pre-filled syringes designed for use in children ages 6 to 35 months. These lots passed all tests for potency and purity when they were distributed, but routine follow-up tests after distribution found that levels of antigen, the

active ingredient, were slightly lower than the level specified on the label. The recall is not related to any safety or effectiveness concerns.

Tennessee received only 1.4 percent of the Sanofi vaccine impacted by the recall, and these doses represent only 0.6 percent of all H1N1 flu vaccine distributed in Tennessee.

"Tennessee health providers who registered to offer H1N1 vaccine have been informed about the recall, and know they are to set aside any doses they received from the recalled lots," said Health Commissioner Susan R. Cooper, MSN, RN. "There are other vaccine products available for use for young children, so we don't anticipate a significant impact on supply of vaccine for that age group."

The lot numbers of vaccine included in the recall are: UT023DA. UT028DA, UT028CB and UT030CA. Some 800.000 doses of H1N1 vaccine are included in these lots. The Department of Health is working with the Centers for Disease Control and Prevention to inform providers who received affected lots on instructions from

Sanofi Pasteur for returning unused doses to the company.

No action is required by parents with children between the ages of 6 to 35 months who may have received H1N1 flu vaccine in the form of a pre-filled syringe from Sanofi Pasteur. The doses are considered safe and effective: revaccination is not recommended. Parents with questions may contact their child's health provider, or call the Tennessee Flu Information line toll-free at 1-877-252-3432.

Amanda Sue Stevens, 30, Maple Court, Gatlinburg was charged with vandalism over \$500.

The report states on Tuesday, at about 2:10 AM, Officer J. Anderson, LCPD observed Amanda Stevens causing a disturbance at Bimbo's on Highway 321. The officer asked Ms. Stevens for her information and ran her through records, which showed she had three outstanding warrants from Loudon City.

Officer Anderson placed her under arrest for the warrants. When he placed her in the passenger side rear of his patrol car and closed the door, Ms. Stevens proceeded to kick the passenger side rear window and bent the entire window frame out of the door.

The value of the damage is over \$500. The in-car camera showed Ms. Stevens kick the window out.

A short time later, at about 4:00 PM, Deputy R. Grav. LCSO. served Stevens warrants charging her with possession of schedule II, possession of schedule IV and possession of a legend drug.

According to those affidavits, on March 23rd, 2009, at approximately 8:16 PM. Loudon Police Department received a call of suspicious subjects in a white Ford at the Mr. Gas on Highway 11 in the city of Loudon.

LPD observed the vehicle in the parking lot with a white female standing outside the open driver's side door. She was identified as Amanda Stevens.

While talking with Ms. Stevens, Officer Farmer requested permission to search her vehicle and she agreed.

Inside Ms. Stevens purse the officer located an Aleve bottle, which contained several different types of pills.

When asked about the pills, Ms. Stevens stated she had a prescription for them. One of the pills was identified as half a totem pole of xanax, one was identified as a 30 mg roxicet and one was identified as buspirone.

The pills were taken from Ms. Stevens as evidence and she was

issued a property receipt. According to the affidavit, at the time of her arrest on Tuesday Ms. Stevens had failed to produce a valid prescription for the pills.





hunters resumes Saturday. Dec. 19 and will continue through Jan. 10, 2010. Historically. the doe harvest numbers see an increase during this upcoming segment of gun sea-


"The second gun season is traditionally the time to harvest does," said Daryl Rataiczak, TWRA's Deer Coordinator. Most Unit A and B counties save their antlerless hunts towards the end of the season so we should see a significant rise in the number of does harvested statewide. "If you have your quota permits or your county is scheduled eluded you earlier in the season."

Since archery season opened in late September, more than 124,300 deer have been harvested. During the first gum season segment (Nov. 21-Dec. 6) 55,135 deer were reported. Henry County is the overall top county for harvest with 3,764 deer reported since late September. Hardeman County had 2,184 whitetails reported harvested during the first gun segment with neighboring Fayette County close behind

The state's 2009-10 deer hunting seasons will conclude with the second Young Sportsman Deer Hunt to be held the weekend of Jan. 16-17. Only youth, ages 6-16 may participate in the Young Sportsman Hunt.

man has pled guilty to three counts of illegal possession of wildlife resulting in arrests made by Tennessee Wildlife Resources Agency wildlife officers on Chickamauga

William "Bill" Sligh pleaded guilty to the three counts in Rhea County Criminal Court. He was ordered to pay \$970 in fines and court costs and was placed on 18 months of supervised probation. Sligh also must serve 100 hours of community service.

Acting on a tip, TWRA wildlife officers observed the violation of commercial fishing regulations including unlawful placement of nets, killing sportfish and possession of several catfish of more than 34 inches of length. Tennessee law allows the possession of one catfish of more than 34 inches in length.

Rhea County Wildlife Officer Brian Letner and Meigs County Wildlife Officer Chris Combs initially began the investigation. They were later assisted by wildlife officers Burton Capps, Jeff Bishop, and Phillip Earhart.

Chocolate Peanut Butter Bonbon Prep Time: 25 minutes

Ingredients:

- 1 cup peanut butter
- * 1 cup chopped pecans
- * 1 cup powdered sugar
- * 1 cup chopped dates (NOT the prepackaged chopped type)
 - * 1 Tbsp. butter, softened
 - * 2 cups semisweet chocolate chips
 - * 1/2 cup milk chocolate chips
 - * 1/2 cup milk chocolate chips

Preparation:

In large bowl, combine peanut butter, pecans, powdered sugar, dates, and butter and mix well; form into 1" balls.

Melt semisweet chips and 1/2 cup milk chocolate chips together in a glass measuring cup in microwave on medium power about 2 minutes, stirring once, until melted and smooth. Stir in remaining 1/2 cup milk chocolate chips and stir constantly until smooth (this tempers the chocolate, setting up crystals so it will harden). Dip each ball into melted chocolate mixture and set on parchment paper. Let stand until chocolate is firm, then store tightly
