

Yelverton was checked and ran through NCIC which revealed he is unlicensed and had two outstanding warrants, one for failure to appear for violation of probation, and the other one for driving without a license.

While still on the scene at City Park Drive, Officer Anthony Chitwood, TWRA arrived and charged Mr. Yelverton with

evading arrest and illegal possession of wildlife.

According to those affidavits, which were filed by Officer Chitwood; on the evening of October 8th, 2009, the officer encountered Mr. Yelverton at a residence on Jackson Bend Road while investigating the theft of a deer that had been taken from a hunter in the area. When Mr. Yelverton realized who Officer Chitwood was, he fled on foot around the back of the house.

Yelverton fled into the woods adjacent to Jackson Bend Road and escaped. A LCSO K9 Unit was deployed, which tracked Yelverton back to the residence on Jackson Bend Road where he had just been picked up by another vehicle.

Upon investigation the TWRA officers discovered the deer that had been stolen in the garage of the residence. Yelverton's vehicle was then towed and impounded by Moneymakers on that date in October.

explosive charges, and successfully exposed a stable layer of rock that is less susceptible to future slides. Plans are to continue working from the west side of the slope to the east with drilling and trim blasting operations and will begin haul-

ing away slide debris this week. The larger debris will be broken into a manageable size using a hoe-ram, loaded on to dump trucks and removed from the site.







"This undertaking is a true partnership between state and the local governments," said Commissioner Reagan Farr. "While increasing revenue

Beginning with Classification 1 taxpayers, due Feb. 28. 2010, all business tax returns will now be filed with the Tennessee Department of Revenue. Businesses will continue to obtain business licenses from the county clerks and/or municipal officials.

Until recently, CoverKids had provided coverage to children in similar situations, but suspended new enrollment in November 2009 due to budget limitations.

"With enrollment for new members in CoverKids closed, uninsured children with chronic conditions have fewer options for coverage," said David Hilley, director of AccessTN. "The AccessTN board voted to expand the program to include children to ensure viable options remain for families with sick children."

With a current enrollment of more than 3,800 members. each of whom pays a monthly premium for coverage, AccessTN provides comprehensive health insurance to individuals younger than 19, while still managing within its set budaet.

Premiums for children will be based on the lowest premium level charged to AccessTN enrollees and will range from \$284 to \$410 per month. Premium assistance is an option for some families earning less than \$75,000. This aid can cover up to 60 percent of the monthly premium, depending on family income, and is subject to available

funding. "Prior to the CoverKids enrollment suspension, families with uninsurable children could buy into that program by paying monthly premiums because they exceeded the income limits to qualify for free cov-erage," Hilley added. "Now that enrollment for CoverKids has closed, this keeps a buy-in option open for those families who still need coverage for their children."

To qualify for AccessTN, an individual

must be a Tennessee resident, U.S. citizen or qualified legal alien and be considered uninsurable due to pre-existing health conditions. In addition, applicants must be uninsured for at least three months. though special exclusions apply for those finishing COBRA or TennCare policies, or for those whose employer has cancelled group coverage. For more information about AccessTN eligibility, or to apply, visit www. CoverTN.gov or call 1-866-COVERTN.

AccessTN is a program of Cover Tennessee. Governor Phil Bredesen's initiative to address the health care needs of Tennessee's uninsured. Cover Tennessee offers three other programs, including CoverTN, a limited benefit health plan for the working uninsured. CoverKids provides free comprehensive health insurance for qualifying children 18years-old and younger. CoverRx provides Tennesseans who lack pharmacy benefits with access to affordable prescriptions.

New enrollment in CoverKids suspended Dec. 1, 2009. The last day to pre-qualify for CoverTN was Nov. 30. Any businesses or individuals who prequalified for coverage have until Dec. 31, 2009, to enroll with BlueCross BlueShield of Tennessee. Both programs are temporarily closing enrollment as a result of limits in the state budaet.

A McGhee Square woman was jailed twice after she allegedly assaulted her boyfriend, once for the assault, the second time because she reportedly called her boyfriend even though she had a no contact order against her.

Martha June Mills, 23, McGhee Square, Lenoir City was charged with assault by domestic violence and criminal contempt.

According to the affidavit, on November 22nd, 2009, the complainant stated he and Ms. Mills were walking towards his mother's house on Brittni Lane in Lenoir City when he stopped to talk to his brother. Martha kept walking towards his mother's house and

when he got there Ms. Mills was on the phone talking to a man, asking him to come and pick her up to go buy pills.

The complainant advised he told Mills to get off the phone while at his mom's house and if she wanted to be with the man, to go be with him.

Mills reportedly hung up the phone, threw it, then reached up and smacked and kicked the complainant a couple of times. He got the phone and called 911 while she continued to smack and hit him.

The complainant reportedly further stated when Ms. Mills realized he called 911, she ran out the door. LCPD made reports at that time.

Two days later, Mills was charged with criminal contempt.

According to that report, on November 25th, 2009, between the hours of 11:20 and 11:40 PM, Ms. Mills called her fiance on his cell phone and texted

him. Deputy Chad Estes, LCSO reported he heard the phone call.

Martha Mills had a Exparte Order of Protection against her and when she made bond for the assault by domestic violence on November 24th, 2009, she had a conditional release to not contact the victim.
