## Narcotics nabs meth lab in process of cooking

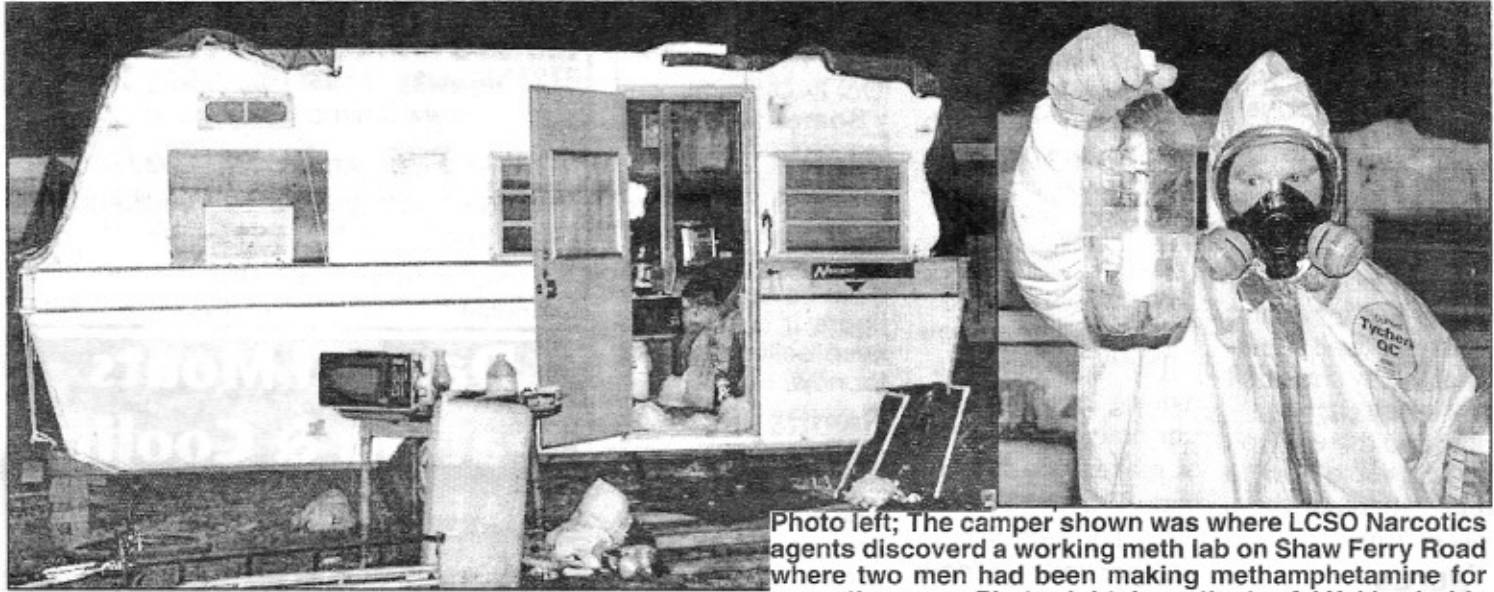

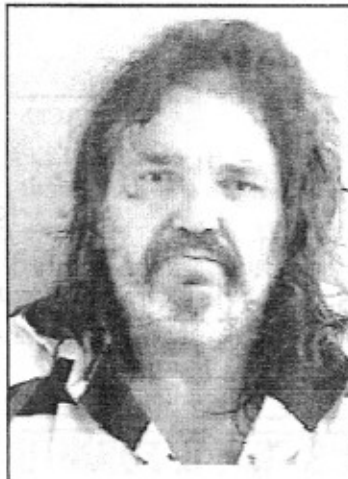

## Illegal dumping reported

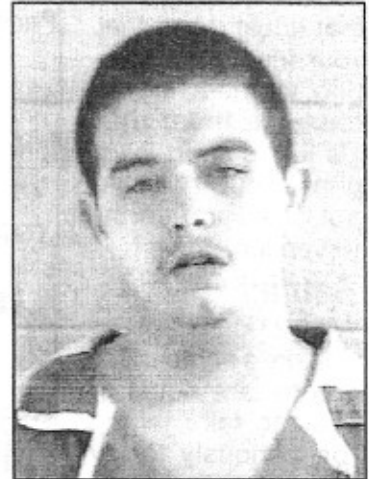
A local man called authorities to report someone dumping on his property illegally and said the incident had occurred multiple times.

## Lab

The Loudon County Sheriff's Office (LCSO) Narcotics Division (ND) went to a camping trailer located at 8261 Shaw Ferry Road, Lenoir City to serve outstanding warrants on John Krippendorf and Zachary Harvey. On scene at the camper officers including Sgt. Billy Hall, Investigator AJ Yokley and Deputy Shane Ezell located Krippendorf and Harvey and arrested both on the outstanding warrants. Sgt. Hall asked Krippendorf for consent to search his camper for a methamphetamine lab.

After explaining how the officer came to know about the meth lab to Krippendorf he consented to a search of the camper and advised there was an active meth lab inside. Members of the LCSO Meth Response Team suited up in protective clothing and searched the camper. Found in the camper were several items and chemicals used to manufacture methamphetamine. Items found consisted of several plastic jugs with bi-layer and tri-layer flammable liquids, several glass bottle with iodine crystals and red phosphorous, 2 glass jars that contained pill washes, coffee filters stained with iodine, coffee filters with pill binder wrapped inside, and several other items

used to manufacture meth.

Zachary Harvey admitted to purchasing Pseudo ephedrine that was being used to produce meth at the location. While interviewing Krippendorf he stated he and Harvey were in the process of manufacturing meth when officers arrived. Krippendorf also stated he and Harvey both manufactured meth at the camper and that Harvey obtained most of the items used in the process due to Krippendorf not having any identification and being wanted out of Texas. Prior to arrival Sgt. Hall checked the Tennessee methamphetamine database and discovered Harvey had purchased more than 9 grams of pseudo ephedrine in and around Loudon County.

John David Krippendorf, 45, of Shaw Ferry Road, Lenoir City was charged with initiating a process intended to result in the manufacture of methamphetamine and outstanding warrants out of Texas.

Zachary Richard Harvey, 21, of Shaw Ferry Road, Lenoir City was charged with initiating a process intended to result in the manufacture of methamphetamine and failure to appear out of General Sessions Court.

Sgt. Billy Hall, LCSO ND made the arrests.

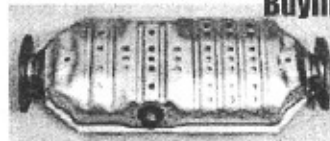
