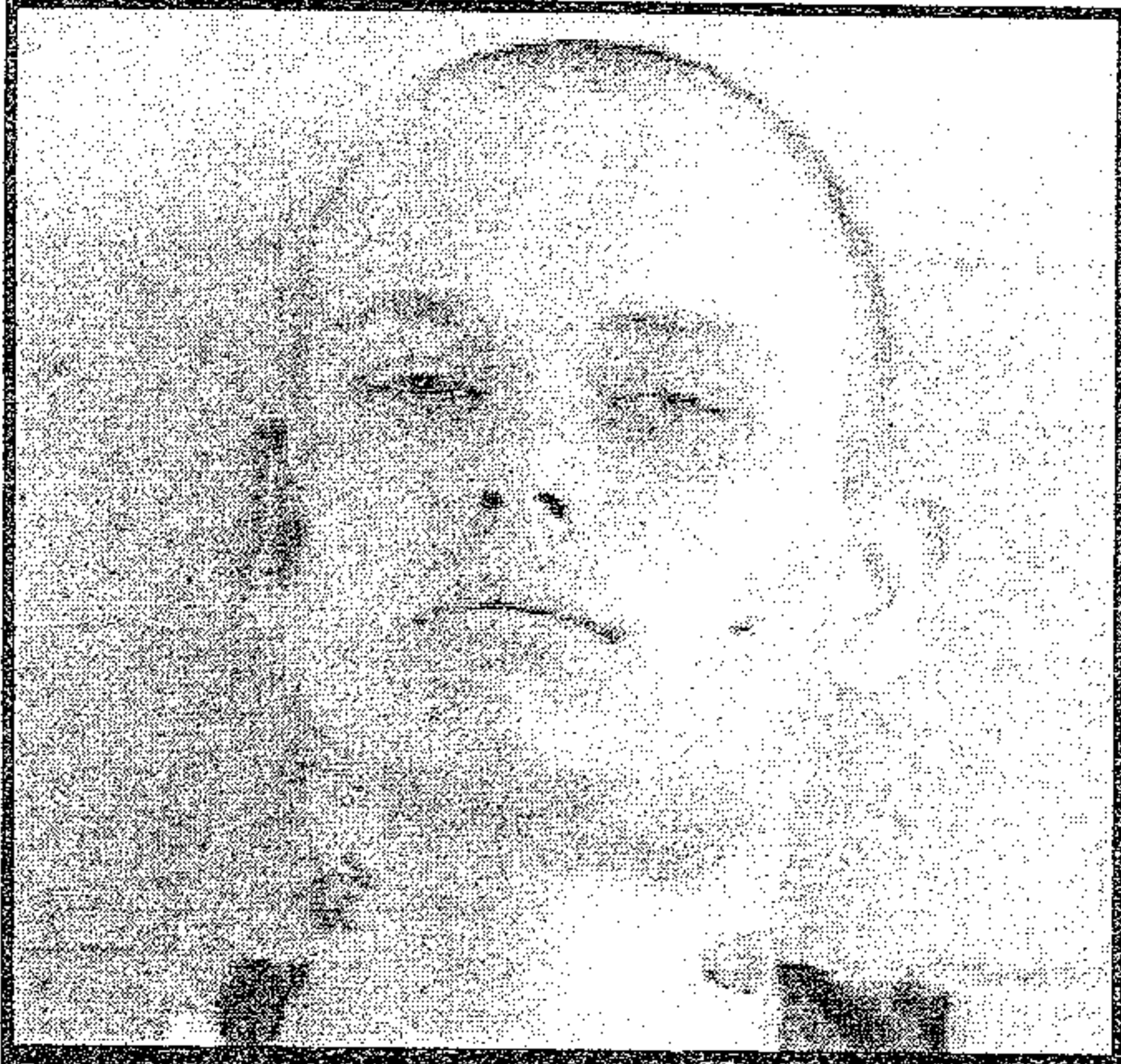

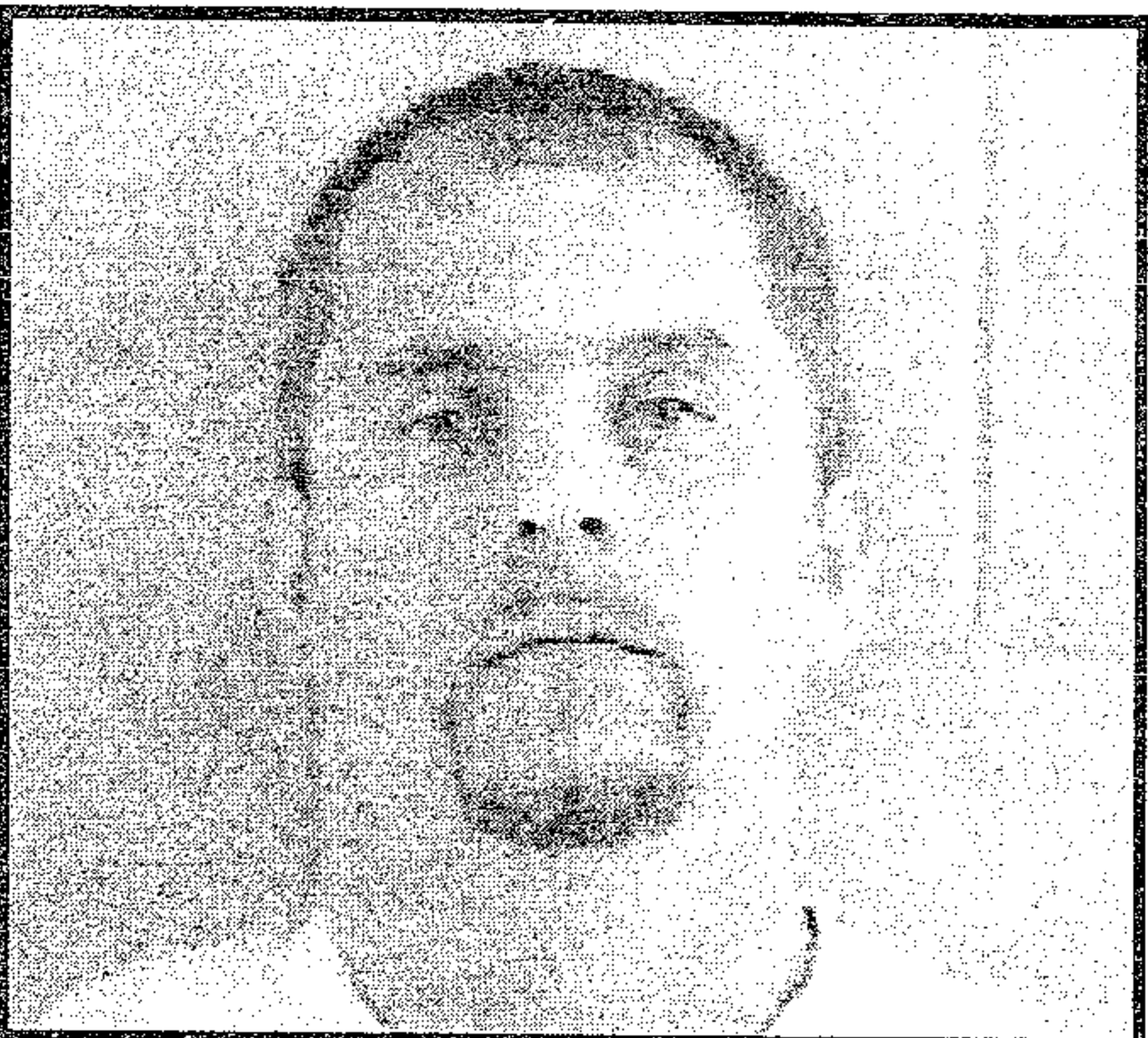

nel Drive, Loudon was charged with four counts of theft under \$500.

According to affidavits filed by Detective Jonathan Sartin, LCPD; on or about February 21st, 2010, James R. Covington went to Murphy USA Gas, 905 Highway 321 in Lenoir City and was driving a white Ford utility type truck.

While there, Covington pumped \$40 worth of gas into the vehicle, then drove off without paying for it. This was done without permission or knowledge of the owner or manager.

On or about February 22nd, 2010, Covington again went to Murphy USA on Highway 321 where he pumped \$27 worth of gas into the same white Ford truck and

drove off without paying for it.

On or about February 27th, 2010, James R. Covington went to Murphy USA in a white Ford truck and pumped \$40 worth of gas and drove off without paying for it.

On or about March 1st, 2010, Mr. Covington again went to Murphy USA on Highway 321 in the white Ford truck and

pumped \$57 worth of gas and drove off without paying for it.

The total amount of gas stolen was estimated at \$164.

Detective Sartin made the arrest Monday.

Unemployment

unchanged from the January rate of 10.7 percent. The United States unemployment rate for the month of February was 9.7 per-

cent.

County non-seasonally adjusted unemployment rates for February 2010, released today, show that the rate decreased in 78 counties,

increased in 10 counties and remained the same in seven counties.

Lincoln County registered the state's lowest county unemployment rate at 8.0 percent, down from 8.3 percent in January. Marshall County had the state's highest unemployment rate at 19.1 percent, down from 20.2 in

January, followed by Henderson County at 19.0 percent, down from 19.8 percent in January.

Knox County had the state's lowest major metropolitan rate of 8.4 percent, down from 8.5 percent in January. Davidson County was 9.3 percent, down from 9.5 in January. Hamil-

ton County was at 9.7 percent, down from 9.9 in January, and Shelby County was 10.8 percent, down from 11.3 in January.

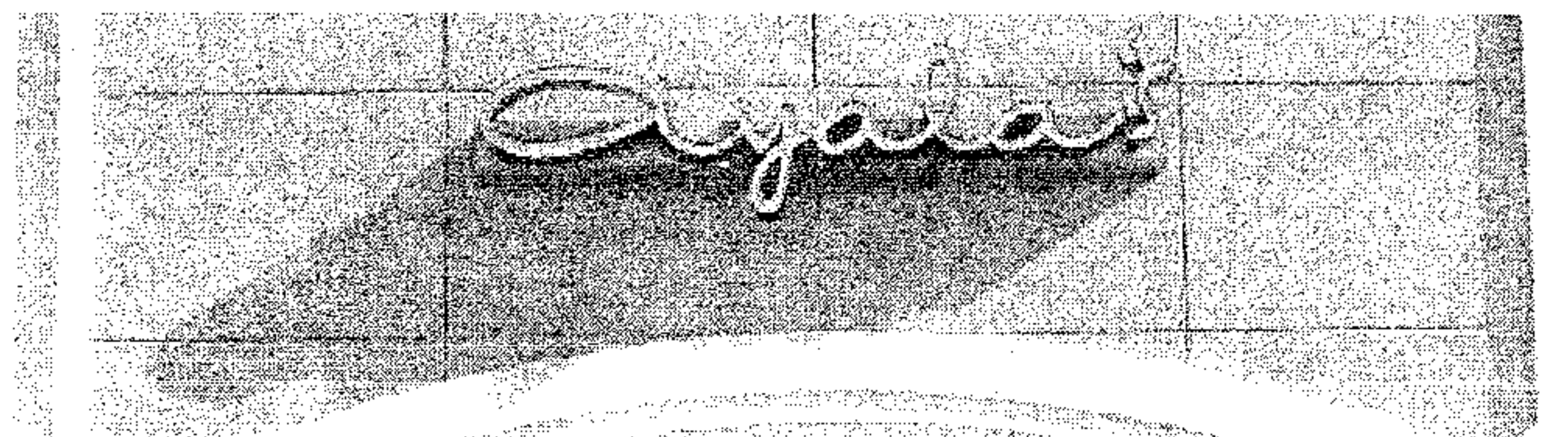

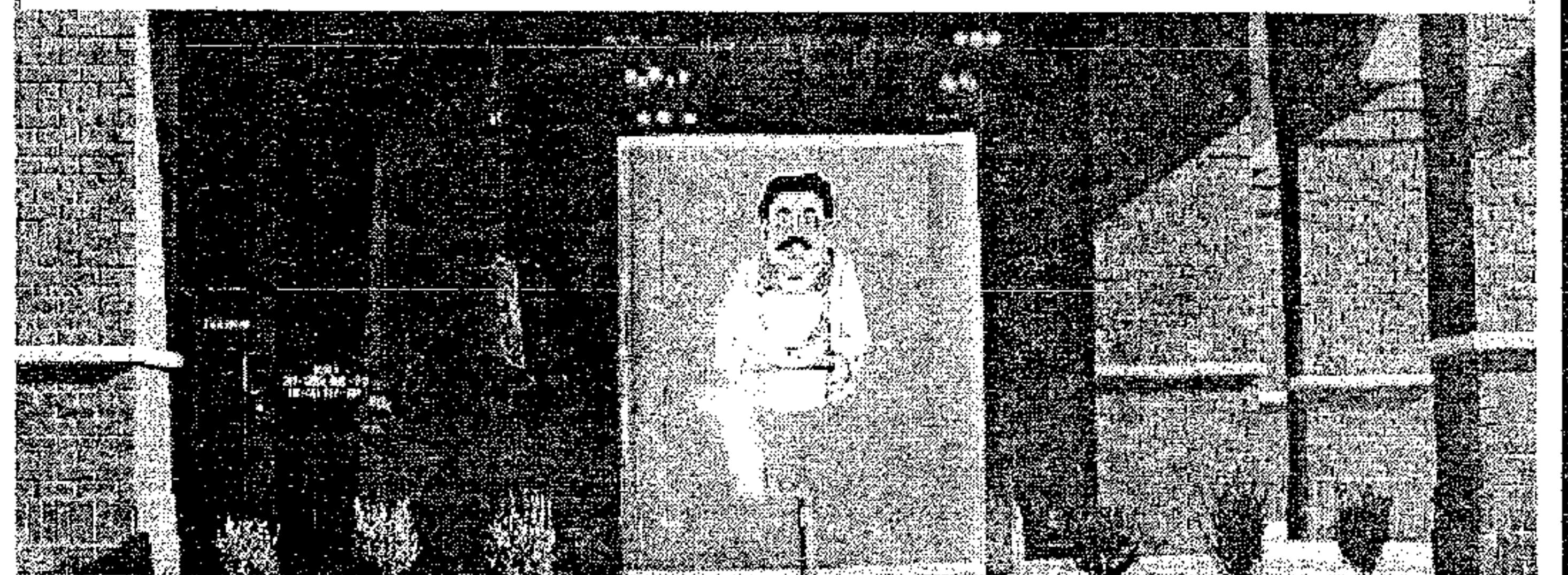

Goley, 37, Simpson Road East, Lenoir City was charged with violation of sex offender registry.

According to an affidavit filed by Deputy Marty Stanley, LCSO: on Friday, March 26th, 2010, Deputy Stanley was working as school resource officer for a school in Lenoir City and as school children were being released, Deputy Stanley noticed William N. Goley was a passenger in a ve-

hicle sitting on school grounds waiting to pick up a child.

The deputy reported he is familiar with Mr. Goley from prior calls to his residence and knew him to be a convicted sex offender.

The officer contacted Goley's sex offender registry supervisor and advised her that Mr. Goley has no children attending the school and was not on the pick up sheet of the student who got into

their mother's vehicle with Mr. Goley. The supervisor advised it was a violation of his sex offender registry rules, which Mr. Goley signed on March 22nd.

Deputy Craig Brewer, LCSO made the arrest Monday at the Justice Center.

Wells

revealed the presence of numerous pills for resale.

William Doug Wells, 35, Dee Ridge Drive, Rutledge was charged with posses-

sion of schedule II for resale.

According to records, Wednesday, around 12:03 AM, Deputy Jason Goddard, LCSO observed a silver Honda Accord parked with the front passenger door standing open at Simmons BP in Philadelphia. There were two male occupants in the vehicle and they appeared to be asleep.

The deputy approached the vehicle and made contact with the driver, William D. Wells. Wells advised they were coming back from Daytona on Spring Break and had pulled off the Interstate because he was sleepy.

The passenger was identified as William Brian Musick, 26, King Avenue, Morristown.

Deputy Goddard ran Mr. Wells' drivers license to check his license status and for warrants. Wells came back with a valid drivers license and no warrants.

The deputy ran Mr. Musick's identification only card and found he had a warrant out of Hamblen

County. The officer told Mr. wells it was OK for him to leave but asked him if he could search the vehicle before he left. Mr. Wells said it was OK for officers to search his car.

During the search Sgt. A.J. Yokely found two prescription pill bottles from First Coast Pain and Urgent Care Clinic. One bottle was a prescription for oxycodone HCL 15 mg and the other bottle was a prescription for oxycodone HCL 30 mg.

In the oxycodone 15 mg bottle were one hundred thirty 30 mg oxycodone HCL pills. In the oxycodone HCL 30 mg bottle were thirty-nine 30 mg oxycodone HCL.

Also found were fifteen oxycodone HCL 30 mg pills packaged in toilet paper. The prescription bottles were filled on March 29th, 2010. The pills were packaged separately in different bottles and in toilet paper.

With the missing 15 mg pills, and the pills packaged in different amounts, it was believed William Wells was in possession of schedule II (oxycodone) for resale.

William B. Musick was also arrested for violation of probation warrant out of Hamblen County.

2010 Statewide Spring Turkey Season Open

NASHVILLE --- If the recently held young sportsman turkey hunt provides any indication, the forecast is good for Tennessee's 2010 spring turkey season. The statewide season opened Saturday, April 3 and continues through May 16.

Tennessee's young hunters harvested 1,285 birds across the state last weekend, a record for the two-day hunt. There were 1,066 turkeys harvested last year and the previous young sportsman hunt record was 1,191 set in 2007 before a damaging late season freeze and the ensuing summer drought.

"2007 was an impactful year with the

Easter freeze and the summer drought and we saw more jakes taken the last couple of years," said Gray Anderson, TWRA Turkey Program Coordinator. "We saw our gobbler harvest at about 70 percent in the young sportsman hunt.

"Based on that, we should see the number of gobblers increase and we are hearing reports of good quantities of birds being seen statewide. Everything that we have seen is pointing toward the positive."

In last week's young sportsman hunt the county with the most birds harvested was, Dickson County with 44 birds harvested. Giles and Hawkins

counties each had 34 followed by Sumner County 33, Montgomery County 31, Henry and Maury counties 30, Hardin and Hickman counties 29, and Greene County with 28.

There were 32,081 turkeys harvested in the 2009 spring season. Greene County was the state leader with 930 birds. Montgomery had 792, Henry 783, Dickson 736, and Maury 709 to round out the top five.

All Tennessee counties are open to wild turkey hunting including Wildlife Management Areas and refuges unless specifically listed. For specifics, sportsmen should check the 2009 Tennessee Hunting and Trapping Guide which is available at any TWRA Regional Of-

fice, license agent or online at www.tnwildlife.org.

es. Gordon Dale Narmore, 29, Cedar Street, Loudon was charged Friday with felony fleeing lawful arrest, resisting lawful arrest x 2, escape and driving on revoked license.

The report states Deputy Chris Jenkins, LCSO responded to the area of Highway 321 to a possible impaired driver in a gold Chevy Cavalier. He spotted the vehicle on Highway 321 at Adesa Boulevard and identified the driver as Gordon Narmore.

Deputy Jenkins had prior knowledge of the status of

Mr.Narmore's drivers license and had it confirmed through dispatch. He attempted to traffic stop the vehicle at Highway 321 and the Shell station.

Narmore's vehicle then turned north on Interstate 75, accelerated at a high rate of speed and refused to stop.

Mr. Narmore's speed, which reached approximately 100 mph, and the heavy traffic put innocent people in danger of bodily harm or death.

Narmore finally stopped and exited his vehicle in an aggressive manner and would not comply to officer's commands. Due to the safety of

the officers with the heavy traffic on the Interstate and Mr. Narmore not complying, K9 Diego was deployed to apprehend and take Mr.

Narmore into custody. When Narmore was in custody K9 Diego was relieved of duty.

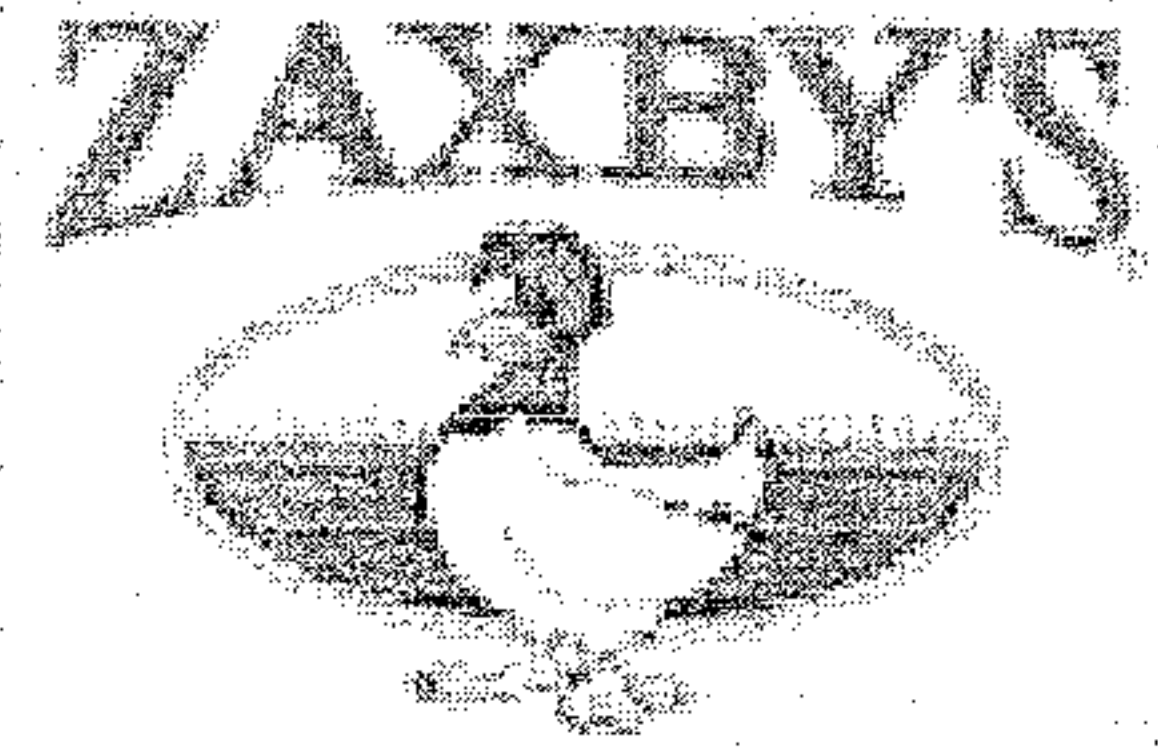

Corporal Pete McGinley, LCSO and Trooper Rusty Smith, THP were also on scene.

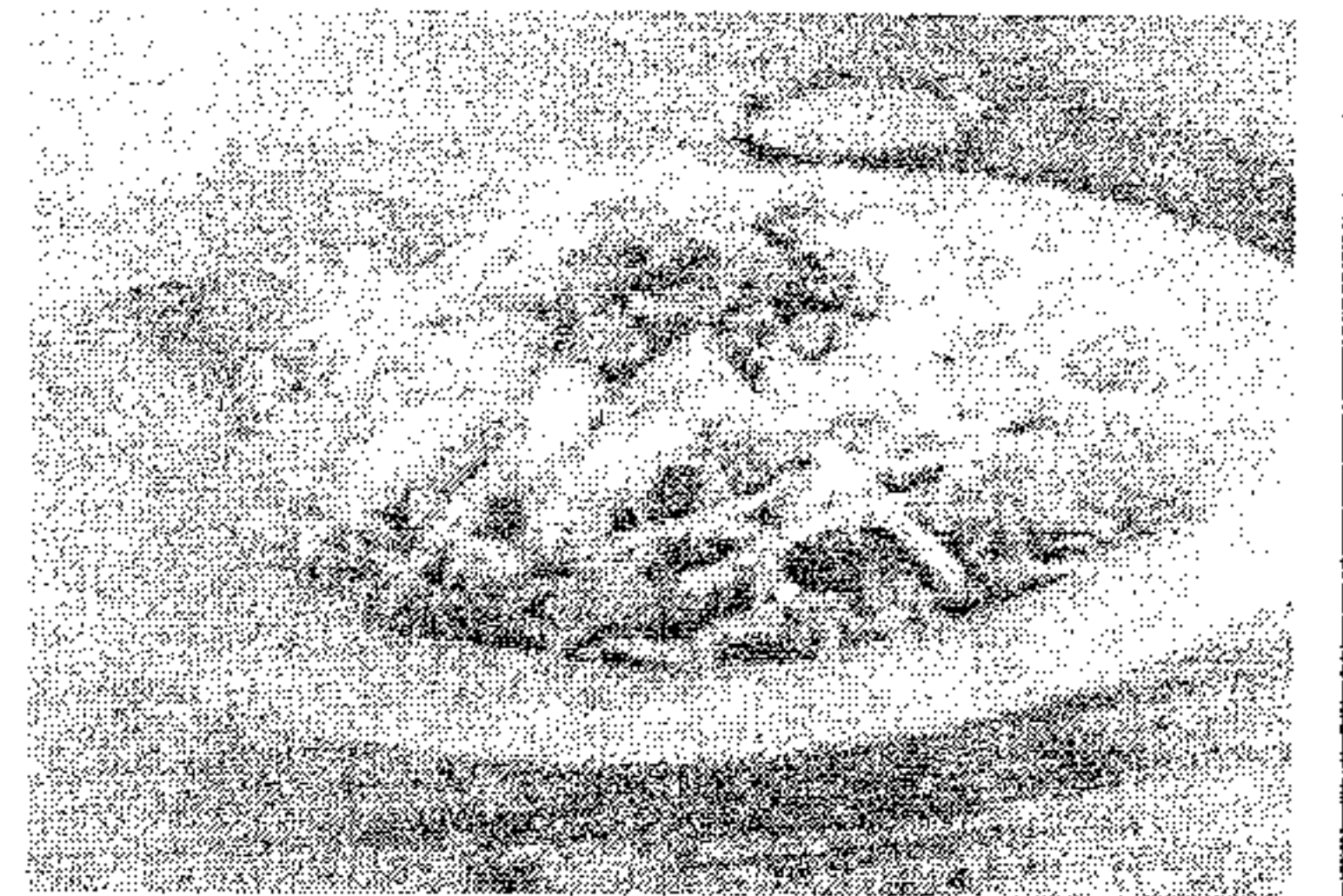
