The officer observed a number of firearms where the victim advised she had obtained the weapon. Mrs. Gilbert was also asked to write a statement pertaining to what happened before the officer arrived and she refused.

While the victim was in the kitchen Mrs.Gilbert allegedly came around the corner towards him in an aggressive manner, cursing and yelling right in front of Deputy Ezell. Mrs. Gilbert was taken into custody and transported to the Loudon County Jail.

A check through NCIC showed his license to be revoked for two prior DUI's and to be a Tennessee ID only.


Mr. Johnson was taken into custody and read the Tennessee implied consent. He reportedly refused to submit to any chemical test.




He got in behind the Cavalier to observe.
