## Loudon County Sheriff's Office charges local pair with felony theft

**Couple accused of stealing several high dollar trailers and industrial mowers**

Sheriff Tim Guider announces the arrests of Mr. Daniel Paul Langley and Mrs. Heather Renee Stinnett in connection with several high dollar trailer and industrial mower thefts in the Loudon County area.

Sheriff Guider advised that the investigation began approximately one (1) month ago when several residents were reporting trailers and items on the trailers, including zero turn mowers, being stolen. Some of these thefts were committed during the daylight hours.

The Sheriff advised that the Loudon County Criminal Investigations Division began to develop some suspects during the thefts, including Mr. Daniel Langley. The suspected truck and suspects were also caught on tape during one of the thefts.

## Charged

On June 15th in the evening hours Mr. Langley was stopped in Lenoir City in a red Ford Ranger pickup truck. Loudon County investigators then went to the scene and the truck was compared to photos taken from a surveillance tape.

The truck matched the photos including a sticker on the back window and a spare tire on the driver's front.

Investigators then interviewed Mr. Langley along with Mrs. Heather Stinnett and developed enough evidence to connect Mr. Langley to the thefts.

The Sheriff advised that investigators worked late into the night on the case recovering thousands of dollars in stolen items.

Sheriff Tim Guider advised that the case

is still ongoing and other arrests may be forthcoming. Other items are still being recovered at this time.

Detective Charles Cosner, LCSO CID advised he charged both Daniel Paul Langley, 8575 Jackson Bend Road, Lenoir City and Heather Renee Stinnett 213 Pike Street, Lenoir City with felony theft.

## Extremely slow driver busted

Burman Paul Bare Jr., 51, McConnell Street, Jefferson, North Carolina, was charged with driving under the influence of alcohol and/or drugs and violation of implied consent.

According to records, Saturday at approximately 3:20 a.m., Deputy Shane Ezell, LCSO noticed a white vehicle traveling north on Highway 11 at an extremely slow speed. The of-

ficer turned around, got behind the vehicle and paced it at speeds well below the posted 45 m.p.h. speed limit.

Deputy Ezell attempted to check the registration, but could not determine the state in which the registration was issued due to a frame around the tag. He stopped the vehicle on Highway 11 at Tennessee Waste Movers. The driver, Mr. Burman Paul Bare Jr., reportedly had a strong odor of alcohol about his person and the odor was coming from the vehicle.

When asked if he had anything to drink Bare stated he had not drank anything. He also reportedly told the deputy he could search his vehicle if he wanted to.

The officer asked him to exit the vehicle

and step to the rear. According to Deputy Ezell, when Mr. Bare exited the vehicle he appeared unsteady on his feet, stumbling for a couple of steps. He was asked to perform a series of sobriety tasks and performed poorly on all tasks given, having to be given instructions several times for each task.

After advising Mr. Bare he was under arrest he was read the Tennessee Implied Consent form, which Bare refused to determine his blood alcohol content.
